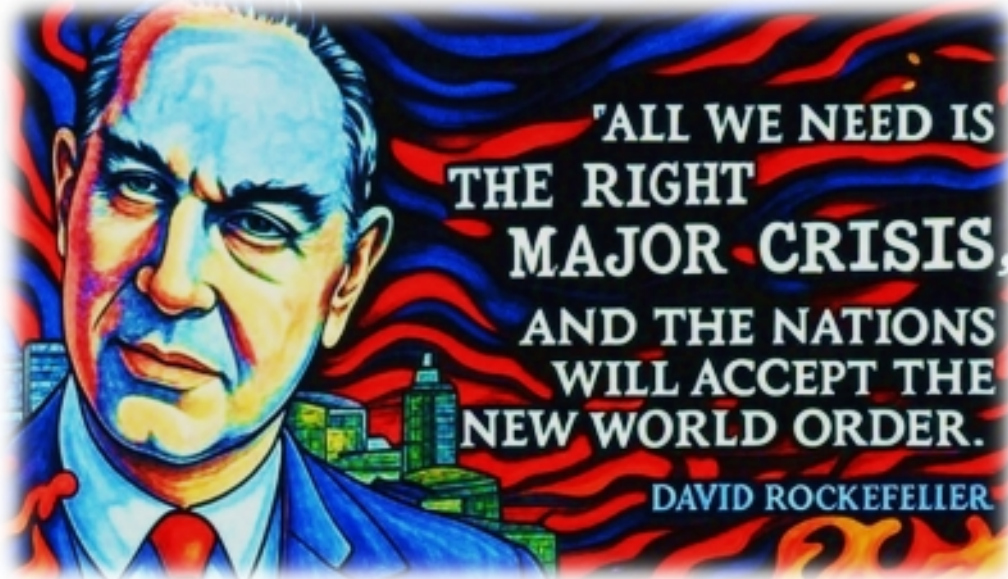
CHAPTER I: PLAGUE PLANET

On May 11th, 1987, the London Times published an explosive article entitled, “Smallpox vaccine triggered AIDS virus.” The story suggested the smallpox eradication vaccine program sponsored by the WHO was responsible for unleashing AIDS in Africa. The extraordinary details have come to light because thousands of State Department documents dealing with the 1980-88 Iran-Iraq war have just been declassified and released under the Freedom of Information Act. Just recently, a leaked report admitted that the USA had mishandled dangerous pathogens such as anthrax and H5N1 avian flu... Just one mistake at the Center for Disease Control and Prevention (CDC) or at Porton Down, or at Fort Detrick could kill all life on planet Earth. But this is a lot of BS.

The CDC have supposedly taken a sample of the avian flu virus and cross contaminated it with a highly pathogenic version which was shipped to an agriculture department laboratory. Her Majesty's "*Bioterror Response Laboratory*" were laughing once they got the sample, and they asserted they have engineered anthrax DNA and breeds live botulism bacteria which was used in WATER CANON SPRAYS by various dictator regimes who are friendly to Buckingham Palace. But nobody got sick or died, that's why investigators know this.

In 2008 and 2009, the London Guardian Newspaper rumored that during the second world war, Her Majesty's government bred a huge archive of killer viruses and invested tax payer's money in pathogens which could not only kill any human neither could animals. Its all a mind game, you see. Though they have chemicals which sprayed can wreak havoc in small guerrillas, populations or places. Chemtrails play a part in this game.

It was recently revealed that a dangerous strain of the bacterium *Brucella* has been bred for the Israeli militar, but never killed anyone or got anyone sick during the trials. There are supposedly also various WATER-BORN diseases, which Buckingham Palace seems to have bred in order to take over control of all the FRESHWATER SUPPLIES on the planet. One of them was supplied to The Osho sect in oregon in the 1980s.

Followers of the late guru Osho (Bhagwan Shree Rajneesh) were responsible for the 1984 Rajneeshee bioterror attack in The Dalles, Oregon, not Seattle. The primary goal was to contaminate local restaurant salad bars and potentially the water supply to influence a local election. The group is not considered a traditional Hindu sect, but a new religious movement.

In September and October 1984, Osho's chief lieutenant, Ma Anand Sheela, and other high-ranking members orchestrated the contamination of water supply with *Salmonella enterica* Typhimurium bacteria and no one got sick. For 3 days they emptied liquid with pathogens in the local water supply and nothing happened. The plot's goal was to incapacitate local voters so that the commune's candidates could win the upcoming county elections and gain political control of the region. Around election time, the same group sprayed a chemical directly in the food of 10 salad bar restaurants which actually made some people sick in town but most were able to vote.

Also, US officials, to get along and play along with this war game, have admitted that long forgotten vials of smallpox left in a cardboard box had

been discovered by a government scientist at a research centre near Washington - the smallpox bug had been eradicated and was supposed to be finally destroyed 20 years ago - but war mongers working at the Centre for Disease Control voted to keep the smallpox pathogen alive, ro so they say. CHAPTER II: SECRET WEATHER WARS

If man can modify the weather, he will obviously modify it for military purposes. It is no coincidence that the U.S. Army, Navy, Air Force and Signal Corps have been deeply involved in weather modification research and development. Weather is a weapon, and the general who has control over the weather is in control of an opponent less well armed... The idea of clobbering an enemy with a blizzard, or starving him with an artificial drought still sounds like science fiction. But so did talk of atom bombs before 1945.

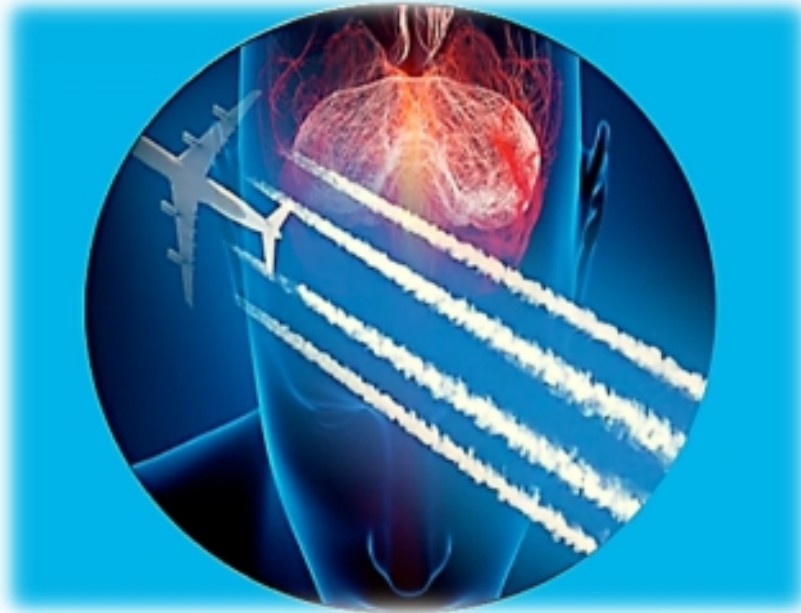
Modern scientific attempts to control the weather began with Dr. Bernard Vonnegut's discovery in 1946 that microscopic crystals of silver iodide (AgI) nucleate water vapor to form ice crystals. His breakthrough invention of a practical way of generating tiny AgI particles to serve as nuclei for ice crystals led to the modern practice of cloud seeding. More than fifty years later his method continues to be the most common. Control of the weather, at least to some degree, is today an established and expanding field of scientific and commercial endeavor across North America and around the world.

The chemtrail theory among researchers posits that specific airplane contrails are not mere condensation but government- or corporation-mandated releases of chemical or biological agents for undisclosed nefarious purposes. This perspective integrates several elements, including:



- **Geoengineering:** The theory suggests these trails are a covert form of large-scale environmental modification, often linked to hypothetical projects like solar radiation management, where particles are dispersed in the atmosphere to reflect sunlight and combat climate change, but allegedly without public consent or knowledge.
- **Heavy Metals:** Proponents of the theory often claim the dispersed materials contain harmful substances, primarily heavy metals such as barium, aluminum, and strontium [1]. Samples of soil or water are sometimes analyzed by activists, who assert that elevated levels of these metals are proof of aerosol spraying operations.
- **Nanotechnology and Nanobots:** A more advanced claim within the theory suggests that the aerosols contain sophisticated nanotechnology or microscopic robots (nanobots). These are sometimes described as being used for surveillance, mind control, or creating a "synthetic telepathy" field.
- **Cloud Seeding Connection:** The theory often references legitimate cloud seeding operations, which use silver iodide or other agents to encourage precipitation, as a cover or proof of

the government's capability and willingness to manipulate the weather on a larger scale.



Mankind has always had a keen interest in the weather. Throughout human history we have seen the effects of weather on crops, and the loss of life and property through the violence of storms. In ancient times people made sacrifice to the gods in a crude attempt at influencing the weather. In many parts of the world today people still conduct elaborate rituals for rain and fertility.

The modern interest in making rain for profit and/or the public good began, surprisingly enough, following the American Civil War. A large volume of literature on the subject was generated between 1890 and 1894 alone.

Martha B. Caldwell in her article ***“Some Kansas Rain Makers,”*** published in the *Kansas Historical Quarterly* in August of 1938 summed up much of this material. She wrote:

“These writers had various theories as to the methods of producing rain. A French author suggested using a kite to obtain electrical connections with the clouds. James P. Espy, a meteorologist from Pennsylvania, proposed the method of making rain by means of fires. This idea is prevalent on the Western Plains where the saying, “A very large prairie fire will cause rain,” has almost become a proverb. The Indians on

the plains of South America were accustomed to setting fire to the prairies when they wanted rain.

A third method patented by Louis Gathman in 1891 was based on the supposition that sudden chilling of the upper atmosphere by releasing compressed gases would cause rapid evaporation and thus produce rain.

One of the oldest theories of producing artificial rain is known as the concussion theory, or that of generating moisture by great explosions. The idea originated from the supposition that heavy rains follow great battles. Gen. Daniel Ruggles of Fredericksburg, Va., obtained a patent on the concussion theory in 1880, and urged congress to appropriate funds for testing it. By 1890 the subject of artificial rain making had attained considerable dignity; two patents had been issued and through the efforts of Sen. C. B. Farwell, Congress had made appropriations, \$2,000 first, and then \$7,000 to carry on experiments.

In 1892 an additional appropriation of \$10,000 was made to continue the work. The carrying out of these experiments naturally fell to the Department of Agriculture, and the Secretary selected R. G. Dryenforth to conduct them. In 1891 Mr. Dryenforth with his assistants proceeded to the "Staked Plains of Texas" to begin work. Included in the equipment which he took with him were sixty eight explosive balloons, three large balloons for making ascensions, and material for making one hundred cloth covered kites, besides the necessary explosives, etc. He used the explosives both on the ground and in the air. An observer stated that "it was a beautiful imitation of a battle." The balloons filled with gas were exploded high in the atmosphere. After a series of experiments carried on in different parts of Texas over a period of two years, his conclusions were to the effect that under favorable conditions precipitation may be caused by concussion, and that under unfavorable conditions "storm conditions may be generated and rain be induced, there being, however, a wasteful expenditure of both time and material in overcoming unfavorable conditions."

Twenty thousand dollars in 1890 would have the purchasing power of about a quarter million today! Over the next eighty years Congress maintained an on again, off again interest in funding this research. One notable expenditure occurred in 1967 when the U.S. Senate passed the Magnusson Bill authorizing the Secretary of Commerce to accelerate programs of applied research, development and experimentation in weather and climate modification. That bill allocated \$12 million, \$30 million and

\$40 million over the next three years, respectively. They projected expenditures of some \$149 million annually by 1970.

It can be argued that by the beginning of the 1970s portions of the U.S. government and/or military viewed weather and climate modification research as having transitioned from the “*basic research*” stage to the “*operational*” stage.

Experiments were occurring — or had occurred — in 22 countries, including Argentina, Australia, Canada, Iran, Israel, Kenya, Italy, France, South Africa, Congo and the U.S.S.R. Airborne seeding programs were undertaken to combat drought in the Philippines, Okinawa, Africa and Texas. Fog clearing had become a standard operation at airports, as had hailstorm abatement, which had been proven successful in several parts of the world. Forest fire control had been carried out in Alaska and watershed seeding was widely practiced, while lake storm snow redistribution was under extensive investigation.

By 1973 there were over 700 degreed scientists and engineers in the U.S. whose major occupation was environmental modification (EnMod). And then it all changed. In 1978 The United States became a signatory to the United Nations Convention on the Prohibition of Military or Any Other Hostile Use of Environmental Modification Techniques (EnMod Convention or ENMOD for short).

The EnMod Convention prohibits the use of techniques that would have widespread, long-lasting or severe effects through deliberate manipulation of natural processes and cause such phenomena as earthquakes, tidal waves and changes in climate and weather patterns. Independent journalist Keith Harmon Snow wrote a massive report entitled: “***Out of the Blue: Black Programs, Space Drones & The Unveiling of U.S. Military Offensives in Weather as a Weapon.***” In it he tells us:

“In 1976, U.S. government officials outlined 50 experimental projects and 20 actual pilot programs costing upwards of \$100 million over the next eight years.

It was an explosive subject, up [through] the 1970s but, after 1977, EnMod interest seemed to disappear almost overnight. In other words, after decades of intense research and development, after billions of dollars of investment, after major institutions and governmental bodies were created and charged with oversight of EnMod and its many peripheral issues, and after the entire reorganization of the U.S. Government to channel and guide

and map out the future of this new and promising military and civilian “technology” — said to be more important than the atom bomb — everything stopped. Or did it?

It was as if a huge curtain fell over the subject as all research, all institutional interests, huge salaries and thousands of jobs — vanished. And the mass media stopped reporting anything and everything as if struck by plague.



That — sudden and total silence — is perhaps the most telling and suspicious indication of the secrecy and denial that the EnMod arena was shackled with. Today it is almost as if it never happened.”

Could it be that the US government said, “Oh gee, we can’t do that any more” and just gave up on military EnMod — or did the whole program go “**black**”?

PROJECT POPEYE

The American military-industrial-academic complex early on recognized the importance of weather as a weapon. After the great battles of the Civil War it was noted that rains seems to follow. A General patented an idea for making rain from this observation, but it would take nearly eighty years for a technology to be developed that was GI friendly.

The Battle for Britain was partially won because Allied forces successfully used a fog-dispersal system known as FIDO to enable aircraft takeoff and landing under otherwise debilitating fog conditions. Cold fogs were similarly dissipated during the Korean War. Cloud seeding became a weapon in Vietnam under Project Popeye.

Project Popeye is a now exposed and proven conspiracy on the part of the military to circumvent the laws of humanity in time of war using environmental modification as a weapon — and to keep this secret the Secretary of Defense was forced to lie to Congress!

Project Popeye was originally conducted as a pilot program in 1966. It was an attempt to extend the *monsoon* season in Southeast Asia with the goal of slowing traffic on the Ho Chi Minh Trail by seeding clouds above it in hopes of producing impassable mud.

Over the course of the program silver iodide was dispersed from C-130s, F4 Phantoms and the Douglas A-1E Skyraider (a single engine propeller driven fighter-bomber), into clouds over portions of the trail winding from North Vietnam through Laos and Cambodia into South Vietnam.

Positive results from the initial test led to continued operations from 1967 through 1972. Some scientists believe that it did hamper North Vietnamese operations, even though the effectiveness of this program is still in dispute. In 1978, after the efforts at cloud seeding in Vietnam produced mixed results, the U.S. Air Force declared its position to be that "*weather modification has little utility as a weapon of war.*"

Recent military publications indeed have stated quite the opposite. For example the U.S. Air Force's own Air University's "**SPACECAST 2020**" contained a section on Counterforce Weather Control for force enhancement, which pointed out that:

"Atmospheric scientists have pursued terrestrial weather modification in earnest since the 1940s, but have made little progress because of scientific, legal, and social concerns, as well as certain controls at various government levels. Using environmental modification techniques to destroy, damage, or injure another state are prohibited. However, space presents us with a new arena, technology provides new opportunities, and our conception of future capabilities compels a reexamination of this sensitive and potentially risky topic."

And you now know what happened in 2020, the COVID 19 plandemic and all. "**SPACECAST 2020**" has been superseded by the now infamous "**Air Force 2025**" series of *White Papers*, which made this same point saying:

"The influence of the weather on military operations has long been recognized. During World War II, Eisenhower said, "In Europe bad weather is the worst enemy of the air [operations]. Some soldier once said, 'The weather is always neutral.' Nothing could be more untrue. Bad weather is obviously the enemy of the side that seeks to launch projects requiring good weather, or of the side possessing great assets, such as strong air forces, which depend upon good weather for effective operations. If really bad weather should endure permanently, the Nazi would need nothing else to defend the Normandy coast!"

Clearly, weather control could have a marked effect on the outcome of military operations. The problem the military has is not whether weather control should be affected, but how it could be done, meaning technically, legally and politically.



Many researchers, myself included, believe that the DoD never truly gave up trying to find out. Project Popeye reached broad public consciousness when syndicated columnist Jack Anderson revealed it under the code name “*Intermediary-Compatriot*” in his Washington Post column of 18 March 1971. US Defense Secretary Melvin Laird was forced to testify before Congress about it in 1972. He told the US Senate that Anderson’s wild tales were untrue and that the United States never tried to seed clouds in Southeast Asia. But on 28 January 1974 a private letter from Laird was leaked to the press.

By 1974 he had left Defense and was counsel to President Nixon who was fighting for his political life following the break-in at the Democratic Party’s National Committee offices in the Watergate Hotel on 17 June 1972. In the letter he privately admitted that his 1972 testimony had been false and that the US did in fact use weather modification in North Vietnam in 1967-68.

On 20 March 1974 the United States Senate held a top secret hearing in which representatives of the military finally admitted to the existence of Operation Popeye. They conceded that the cloud seeding program had been conducted over neutral Cambodia and Laos (in violation of international law), as well as both North and South Vietnam. The testifying Pentagon officials stated that Popeye had been ongoing from 1966 through 1972 and that at least 2,600 flights had released over 47,000 units of cloud-seeding materials during the program, at a total cost for the operation of around \$21.6 million.

These hearings also revealed that the US military had attempted other environmental modifications as well. The US had used massive spraying of

chemical herbicides in the hopes of depriving its foes of both food supplies and shelter.

According to analyst L. Juda (from *“Negotiating A Treaty On Environmental Modification Warfare: The Convention On Environmental Warfare And Its Impact On The Arms Control Negotiations,”* published in International Organization) the idea was simple:

“If, as has been suggested, then the guerrilla is to his base area as fish are to the sea, the destruction of the sea would kill the fish and the elimination of the base area with its supports would destroy the guerrilla.”

The implications of this operation staggered Senator Claiborne Pell, a Democrat from Rhode Island. In 1976 he said:

“The U.S. and other world Powers should sign a treaty to outlaw the tampering with weather as an instrument of war. It may seem farfetched to think of using weather as a weapon — but I am convinced that the U.S. did in fact use rainmaking techniques as a weapon of war in Southeast Asia. We need a treaty now to prevent such actions — before military leaders of the world start directing storms, manipulating climates and inducing earthquakes against their enemies. It may seem a great leap of imagination to move from an apparent effort by the United States to muddy the Ho Chi Minh trail in Laos by weather modification to such science fiction ideas as unleashing earthquakes, melting the polar ice cap, changing the course of warm ocean currents, or modifying the weather of an adversary's farm belt. But in military technology, today's science fiction is tomorrow's strategic reality.”

Senator Pell had conducted the Senate hearing in 1972 in which he was lied to by Defense Secretary Laird and the secret one in 1974 that learned the horrible truth. After these he became a leading advocate for what became the EnMod Convention. A subcommittee chaired by Minnesota Congressman Donald Fraser did the same in the House of Representatives in 1974 and 1975. Senator Pell did a lot of stumping and article writing to force the world to act. In one article he wrote:

“Apart from the sheer horror of the prospect of unbridled environmental warfare, there is, I believe, another compelling reason to ban such action. We know, or should know, by now, that no nation can maintain for long a monopoly on new warfare technology. If we can develop weather warfare techniques, so can and will other major powers. Experience has taught us that the weapons that make us feel secure today, will make us feel very insecure indeed when our adversaries possess the same capabilities.”

In *The Cooling*, Lowell Ponte describes the events that led to the ENMOD Convention:

“During a summit meeting between President Nixon and Soviet Premier Leonid Brezhnev on July 3, 1974, the nations agreed to conduct discussions toward a ban on environmental warfare. Before the first of these discussions, set for Moscow in November, got underway, the Soviet Union introduced a resolution before the United Nations General Assembly to ban environmental warfare. When revised, the resolution was passed by the body 102 votes to none. The United States and half a dozen other nations abstained from the vote. Senator Pell suspected that the president felt miffed by the surprise Soviet action, a move that made it appear that the Soviet Union and not the United States had taken the lead in trying to ban environmental modification. In fact, the Soviet resolution was similar to one passed by the North Atlantic Assembly in November 1972 and to another authored by Senator Pell and passed by an 82 to 10 vote by the United States Senate in July 1973. Discussion between U.S. and Soviet negotiators resumed in Washington, D.C., on February 24, 1975. On August 21, 1975, the two nations presented their jointly produced draft treaty banning environmental modification as a weapon of war to the thirty-one nation Geneva Disarmament Conference.”

The EnMod Convention (ENMOD) was later passed by the United Nations General Assembly and opened for signature in 1977. It came into effect 5 October 1978, when it was certified by the required total of 20 nations. It prohibits the use of techniques that would have widespread, long lasting or severe effects through deliberate manipulation of natural processes and causing such phenomena as earthquakes, tidal waves and changes in climate and in weather patterns.

The treaty was warmly received by most of the international community – the exception being a coalition of American environmental groups who thought that its threshold level of a violation needing to be widespread,

long-lasting or severe was too high. Another complaint was that it does not ban the development of this technology, leaving it open for beneficial techniques to be discovered and employed in the service of mankind. The environmentalists (correctly) believed that the failure to ban research in this field would allow the military to develop technologies that adhered to the letter of the law while violating its spirit, as blatantly detailed in the Air Force 2025 White Paper “*Weather as a Force Multiplier: Owning the Weather in 2025.*” Unfortunately for us, the EnMod Convention is a total failure with only 70 nations thus far signatory to it, and it is unenforceable in any realistic sense.



On a November 10, 2025 interview on the Tucker Carlson Show, **Dane Wigington** discussed his theories regarding covert government geoengineering programs. Wigington claimed that aircraft are intentionally

spraying substances into the atmosphere for weather modification, a practice he asserted is harmful and being concealed by authorities. Politician Marjorie Taylor mentioned it at the Congress sessions to further be investigated. You can read the full transcript at singjupost.com.

Zbigniew Kazimierz Brzezinski, a Polish-American political scientist, geostrategist, and statesman who served as United States National Security Advisor to President Jimmy Carter from 1977 to 1981, wrote in his 1970 book ***Between Two Ages***:

“It is ironic to recall that in 1878 Friedrich Engels, commenting on the Franco-Prussian War, proclaimed that “weapons used have reached such a stage of perfection that further progress which would have any revolutionizing influence is no longer possible.”



Not only have new weapons been developed but some of the basic concepts of geography and strategy have been fundamentally altered; space and weather control have replaced Suez or Gibraltar as key elements of strategy.”

After events like the Christmas 2004 Asian tsunami and 2005’s record-shattering Atlantic hurricane season many people have wondered just how “*natural*” those natural disasters were. Has “*weather control*” really become a key element of national strategy?

In the post-EnMod U.S. of the 21st Century weather control is an activity mainly confined to local governments and privately owned commercial enterprises (“civilian contractors”) like Weather Modification, Inc. (WMI) of Fargo, North Dakota. WMI provides services to universities,

governmental agencies, and private sector entities across the country and around the world.

These services include hail suppression in Argentina, snowpack augmentation in Idaho, and cloud seeding in Nevada. Interestingly, one of the senior scientists at WMI went on Art Bell's Coast To Coast AM radio show in 2005 to "out" himself as having been one of the scientists involved in Operation Popeye!

Intentional hostile control of the weather and other environmental processes is collectively called geophysical warfare. Dr. Gordon J. F. MacDonald wrote: "*The key to geophysical warfare is the identification of environmental instabilities to which the addition of a small amount of energy would release vastly greater amounts of energy.*" This was in "***Geophysical Warfare: How to Wreck the Environment***," a chapter he contributed to Nigel Calder's 1968 book, "***Unless Peace Comes: A Scientific Forecast of New Weapons.***"

In the 1960s Dr. Gordon J. F. MacDonald was a distinguished geophysicist and climatologist. He was Associate Director of the Institute of Geophysics and Planetary Physics at the University of California, Los Angeles (UCLA). Dr. MacDonald was also a member of the President's Science Advisory Committee and the President's Council on Environmental Quality, as well as being a senior member of NASA's first Physics Committee. He was also a member of the Council on Foreign Relations and one of the **JASONS**, a military think tank at the top of the Military-Industrial-Academic pyramid. Dr. MacDonald wrote many articles on future weapons. In "Space" an article for the book *Toward the Year 2018*, released in 1968, Dr. MacDonald elaborated on the possibilities of geophysical warfare writing:

"... technology will make available to the leaders of the major nations a variety of techniques for conducting secret warfare ... techniques of weather modification could be employed to produce prolonged periods of drought or storm, thereby weakening a nation's capacity and forcing it to accept the demands of the competitor."

Elsewhere he wrote:

"Such a secret war need never be declared or even known by the affected population. It would go on for years with only the security forces involved being aware of it. The years of drought and storm would be attributed to unkindly nature and only after a nation was thoroughly drained would an armed takeover be attempted."

He warned that these geophysical weapons systems, should they in fact be developed, would produce long-term up-sets in the climate. BusinessWeek magazine reported on 24 October 2005:

"China has 35,000 people engaged in weather management, and it spends \$40 million a year on alleviating droughts or stemming hail that would damage crops."

North Korea, downwind of China, has been ravaged by droughts for a decade. It is entirely possible that China has been intentionally stealing North Korea's rain so as to force North Korea to follow China's political dictates and buy Chinese food (I wonder if it comes in those little white cartons – with 6 million you get egg rolls?). Reports from North Korea make not just the nation's dictator, Kim Jung Il, but the whole country sound crazy. Could their seeming mass insanity be induced?

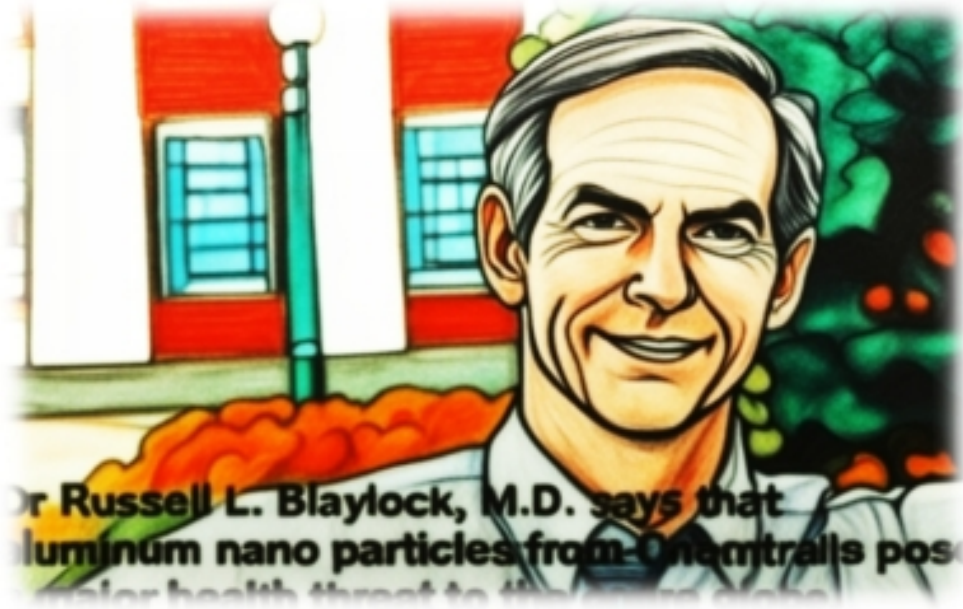
Dane Wigington, lead researcher for the organization GeoEngineering Watch, in a recent interview with Tucker Carlson argued that so-called "*chemtrails*" are evidence of a covert, ongoing atmospheric geoengineering program designed to manipulate the climate and weather for economic and geopolitical control. He claims the U.S. government conceals this to maintain control and avoid public scrutiny over an operation he considers highly damaging to the planet.

DANE WIGINGTON'S ANALYSIS AND CLAIMS

CHEMTRAILS & THE PLAN FOR GLOBAL DEPOPULATION

Dr Russell L. Blaylock, M.D. is the author of Chemtrails, Nanoaluminum and Neurodegenerative and Neurodevelopmental Effects... Several patents have been issued for Chemtrail-type systems. Large quantities of Aluminum Hydroxide have been seen at airports where Chemtrail planes have landed and refuelled. Spraying enemies with poison from planes is a tried and tested ploy used by many armed forces worldwide.

Chemtrails are strange. They rarely evaporate. They spread and transform into a fine wispy mist or thick cloud. Rain often follows the day after. Chemtrails can be spotted because they remain sometimes for many hours in the sky. Military jets sometimes accompany the spraying. Researchers claim to have found nano sized metal particles like graphene and other poisonous ingredients after being Chemtrailed. Patents registered in the USA suggest that large-scale Chemtrailing may be used to protect crops from early ripening and/or sun damage.

The most solid research shows that aluminum poisoning of the human population may indeed be the central objective. Aluminum is toxic to human and animal life. Aluminum build up in Pineal gland has been linked to tinnitus (ringing in the ears). Aluminum has a history of damaging brain function.

In Charles Little's book he writes; *“As it happens, aluminum is a common constituent of forest soils almost every where, but it is locked up in*

aluminum silicates, and in this form is not available to trees and other plants, and therefore is no danger to them...

But after acid rains come, the silicates were broken down, and the aluminum was freed to be taken up by trees and plants. The metal kills all roots first, this means that trees can no longer absorb and transport needed nutrients, such as phosphates, calcium, and magnesium-essential fertilizers that are themselves leached away from the soil by acid deposition, The trees are weakened and can be invaded by insects or pathogens or succumb to extremes of weather-or all of the above, in which case they die.”

So dead grasses, dandelions, plants, weakened trees, beetles move in. I think years of contrails, and the more recent years of chemtrails has caused this reaction, and our trees are dying from it. Perhaps independent studies void of governmental duress, threats, manipulations, would show this with soil, water, and ring samples. In several radio and television interviews, Dr Russell Blaylock has exposed that aluminum hydroxide and other types of nano particles [usually of aluminum, barium and graphene oxide] have been found deposited by Chemtrails.

The Internet is littered with stories of “chemtrails” and geoengineering to combat “global warming” and until recently Dr Blaylock took these stories with a grain of salt. Dr Blaylock says; “*One of the main reasons for my skepticism was that I rarely saw what they were describing in the skies. But over the past several years I have noticed a great number of these trails and I have to admit they are not like the contrails I grew up seeing in the skies. They are extensive, quite broad, are laid in a definite pattern and slowly evolve into artificial clouds. Of particular concern is that there are now so many dozens every day are littering the skies.*”

“...My major concern is that there is evidence that they are spraying tons of nanosized aluminum compounds. It has been demonstrated in the scientific and medical literature that nanosized particles are infinitely more reactive and induce intense inflammation in a number of tissues. Of special concern is the effect of these nanoparticles on the brain and spinal cord, as a growing list of neurodegenerative diseases, including Alzheimer’s dementia, Parkinson’s disease and Lou Gehrig’s disease (ALS) are strongly related to exposure to environmental aluminum. “

Nanoparticles of aluminum are not only infinitely more inflammatory, they also easily penetrate the brain by a number of routes, including the blood and olfactory nerves (the smell nerves in the nose).

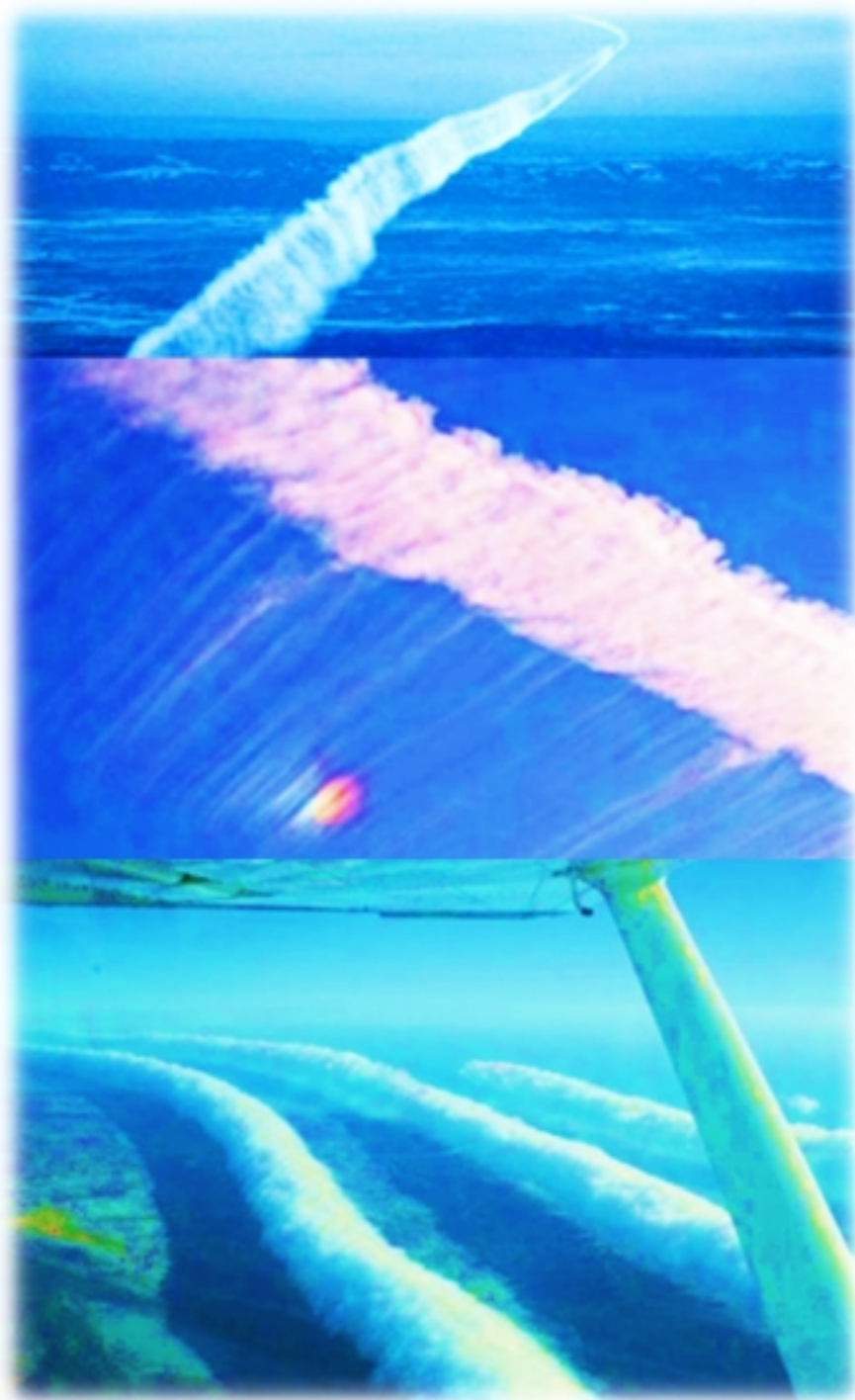
Studies have shown that these particles pass along the olfactory neural tracts, which connect directly to the area of the brain that is not only most effected by Alzheimer's disease, but also the earliest affected in the course of the disease. It also has the highest level of brain aluminum in Alzheimer's cases.

"...The intranasal route of exposure makes spraying of massive amounts of nanoaluminum and nano graphene recently into the skies especially hazardous, as it will be inhaled by people of all ages, including babies and small children for many hours. We know that older people have the greatest reaction to this airborne aluminum. Because of the nanosizing of the aluminum particles being used, home filtering system will not remove the aluminum, thus prolonging exposure, even indoors. "...

In addition to inhaling nanoaluminum, such spraying will saturate the ground, water and vegetation with high levels of aluminum. Normally, aluminum is poorly absorbed from the GI tract, but nanoaluminum is absorbed in much higher amounts. This absorbed aluminum has been shown to be distributed to a number of organs and tissues including the brain and spinal cord. Inhaling this environmentally suspended nanoaluminum will also produce tremendous inflammatory reaction within the lungs, which will pose a significant hazard to children and adults with asthma and pulmonary diseases.

"...I pray that the pilots who are spraying this dangerous substance fully understand that they are destroying the life and health of their families as well. This is also true of our political officials. Once the soil, plants and water sources are heavily contaminated there will be no way to reverse the damage that has been done"

Steps need to be taken now to prevent an impending health disaster of enormous proportions if this project is not stopped immediately. Otherwise, we will see an explosive increase in neurodegenerative diseases occurring in adults and the elderly in unprecedented rates as well as neurodevelopmental disorders in our children. We are already seeing a dramatic increase in these neurological disorders, and it is occurring in younger people than ever before.





CHAPTER III: SECRET CHEMTRAIL OPERATIONS

*Persistent Jet Contrails (aka
“Chemtrails”) by John Doe In
Canada 1996*

Since 1998, when I photographed my first "X" cloud, I became interested in the new trail formations left by certain airplanes as they flew through the sky. Reports gradually accumulated online, and I, for my part, noticed them with increasing frequency in the Appalachian area.

I began taking photos, month after month and year after year. When the results of analyses conducted by various independent laboratories on the substances falling from the sky began to appear online, and certain hidden military projects were revealed, I made connections between everything and was horrified. Known as an incorruptible person who aspires to freedom, truth, and love, I began, in communication with various contacts, to prepare a report on the chemical trails left by airplanes, or chemtrails.

However, I realized that my partner and I had terrible cases of the flu. Evidently, everyone in the city was showing the same symptoms. I was convinced that for years viral epidemics had been spreading through the air by spraying from clandestine planes. I was managing to fight it quite well

naturally, with plants and liquids that strengthen the immune system. Then, without warning, the flu symptoms would reappear again in the middle of summer: my nose would burn, sometimes it would even bleed, and my throat would be sore... But it's only June!

My girlfriend and I were certain that our system was fighting something unnatural. It wasn't just a flu virus. It was something chemical or even metallic. I put my other projects aside. I gathered everything I had accumulated over months about chemtrails. I realized that everything I had was written in English. Very little, if anything, had been written about chemtrails in French. So I started translating intensively.

We glance furtively at the sky and consider it normal that a passing airplane leaves trails that stretch across the horizon. They grow larger and larger until they merge with others, eventually forming a cloud that covers the sky for hours. We don't question whether these trails are the cause of the new symptoms or illnesses we suffer. The analyses of chemtrails are truly disturbing. We must be aware and educate ourselves in order to stop this silent genocide. What does all this do to our immune system? The solution is already here: we're going to be given new vaccines and next-generation antibiotics...

No, thank you!

Initially, civilian and military officials reassured investigators, claiming that these were simply condensation marks. In some cases, they could be the result of fuel dumping in anticipation of an emergency landing. However, the increasing number of these marks renders such justifications ridiculous and unacceptable... (not all aircraft in flight are in danger of an emergency landing, as far as I know...)

Finally, given the scale of the phenomenon, those in charge have had no choice but to abstain from all comment. By shrugging their shoulders, the chemtrail issue was relegated to the mere status of an urban legend. Under these circumstances, how can one demand a serious scientific study? No scientist, no matter how much their own empirical conclusions and/or those of their colleagues have demonstrated that what precedes and continues in this book is true, would ever commit the academic suicide of publicly endorsing it. Not only would they be risking their professional, personal,

and family life... although fortunately, they are increasingly doing so through anonymous statements on the internet; the last free frontier, albeit one teeming with trolls and other vermin. No, thank you!

It is well known that the governments of certain countries have been experimenting with new technologies on the backs of their citizens for decades. Publicly released reports prove it. We must awaken the minds of the public and the media to this invisible plague that has been besetting us for some years now.

During this time, military and government authorities have ridiculed these claims, labeling them conspiracy theories or denouncing them as baseless rumors. Some even go so far as to call them anti-government terrorist propaganda—a story designed to silence once and for all those who obstruct experimentation. In fact, the authorities insist on declaring that contrails are formed by water vapor caused by condensation from the propulsion turbines.

And no one is surprised that these traces didn't exist just 10 years ago! Evidence? To be sure, one only needs to look at the sky as recorded in old documentaries. You don't see chemtrails, but they are omnipresent as a background in current documentaries.

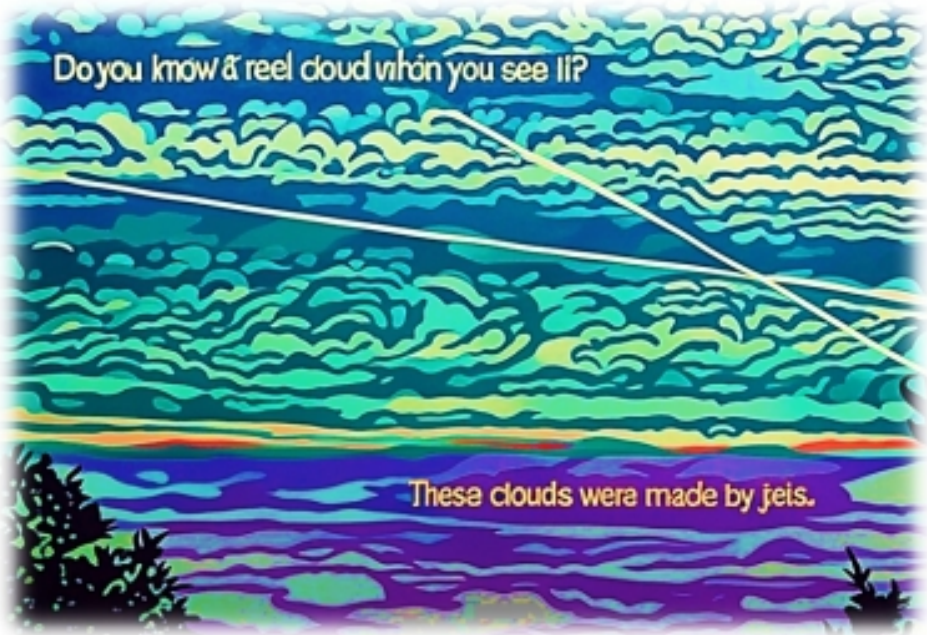
Try it for yourselves. Google up photos of the sky from before 1995. You'll find images completely devoid of chemtrails. Surprising, isn't it? "*Well, back then planes didn't fly that high,*" they reply. And the debate ends.

However, a serious and independent scrutiny should be established, and analyses should be requested from laboratories controlled by non-governmental organizations, if any still exist...

Making a conservative estimate, let's say there are around 300,000 people in the United States who are aware of the existence of chemtrails. Of these, only 125 individuals have launched an active campaign to educate and inform the masses about this final solution. Do the math.

Government agencies are counting on apathy and have, in fact, greatly helped to create a certain state of awareness since the 1950s through fluoridation, aspartame, street drugs, and media manipulation. If such a small percentage of people are concerned about this phenomenon, aren't the leaders of these agencies right to believe, when they analyze the situation, that they are above suspicion and have nothing to fear?

The facts speak for themselves. In order to win, the clandestine agencies in charge must obtain our permission, our consent to continue with their plan to the end. It is a universal law. The Earth's biosphere system has a final boundary, a barrier that each of us can open or close. It is free will, free choice. And this is what THEY want at all costs.



CONTRAILS OR CHEMTRAILS

Contrails

Since the arrival of jets, we have become accustomed to seeing white trails in the sky when airplanes fly at high altitudes. These trails—contrails, condensation trails—depend essentially on two factors: ambient humidity and low temperatures. They can be formed of fine droplets of condensed water or of ice and snow crystals.

At ground level, these trails can appear in extreme climates (Antarctica, Arctic) and are a serious limitation for air traffic. At high altitudes, these conditions normally occur above 9,000 meters. The contrails can remain visible for several minutes before the wind gradually disperses them and they disappear completely. These contrails, formed only by water molecules, are harmless if one does not consider the pollution that a single airplane turbine can generate from the consumption of propulsion fuel and chemical agents.

Contrails are made of water vapor that dissipates after a short period of time. They can only form at temperatures of -24°C and, in addition, at relative humidity levels of 70% or higher, according to meteorologist Thomas Schlattes of the U.S. National Oceanic and Atmospheric Administration.

A separate and distinct fact within this set of events is that clouds can form if the temperature, relative humidity, and vaporization conditions are favorable for their development.



If contrails, based on their appearance, transform into "*clouds*," it can be concluded that the material they are composed of is not water vapor. **The dissipation time of contrails is relatively short, two minutes or less.** This implies that the contrail is essentially composed of water vapor, at least according to the classical definition (condensation trail). The dissipation rate of contrails depends largely on the size of the ice crystals and the amount of sunlight.

The dependence on relative humidity is not obvious. A cloud that forms from an aircraft, when it does, depends primarily on the temperature, relative humidity, and the type and size of the aerosol particles (nuclei) that have been introduced. The formation and dissipation of contrails and cloud formation must be recognized as two separate physical processes that arise in both cases from different and variable conditions.

CHEMTRAILS

Since the mid-1990s, American observers began to see an increase in trails of a new type. They appear at lower altitudes than contrails, sometimes even at ground level, can be white or colored, and dissipate very slowly, leaving a haze in which particles or filaments can be found. Occasionally, they form longitudinal clouds that abruptly break up, leaving a hole. The clouds reform to end up a few kilometers ahead. Or, conversely, the trail runs across the sky from one end of the horizon to the other.

These clouds are not always located at high altitudes, as military or air traffic control authorities claim. Very often, they can be seen at an altitude of between 1,000 and 5,000 meters and beyond 9,000 meters from the aisles of commercial airplanes.

Rainbows or an orange tinge can be observed in certain clouds. Others are darker masses on the inside or are edged with black. These small furrows expand rapidly (depending on wind speed) and produce fine plumes or fan-like nets. Unlike contrails, chemtrail furrows are often broken, with a gap in the pattern, as if the gas had been transferred from one cylinder or tank to another.

Important fact: these observers are not professional complainers or armchair ufologists. They are aviation enthusiasts, doctors, scientists, police officers, ethical journalists... and people suffering from eye irritations or bronchitis, allergies, and fatigue because of this garbage. They come from all walks of life. Based on public health criteria, an extremely active network of observers of chemtrails (chemical traces) has been created on the Internet.

Clifford Carnicom's alternative website published a letter that was apparently written by an airline mechanic, which was later posted on *Jeff Rense's website*. No one has been able to verify the letter's origin, but it

matches a letter from an airline director responding to the anonymous mechanic's statements.

Did A Mechanic Stumble Upon The Secret Behind Chemtrails?

"For reasons you will understand as you read what follows, I cannot reveal my identity. I am an aircraft mechanic working for a major airline. I work at a maintenance base located at a large airport, and chance has led me to discover what was not clearly destined for me.

First of all, I must explain in a few words how the hierarchy works in the world of aircraft mechanics. It is important for understanding my story and the cause to which you dedicate a large part of your energy.

Mechanics want to work in three domains: avionics, engines, and flight controls. Mechanics who work on these systems are considered to have reached the highest level of the hierarchy. Next come the mechanics who work on hydraulic systems and air conditioning. Then there are those who work on the subordinate systems.

Finally, at the bottom of the hierarchy are the mechanics who work on the systems of Wastewater disposal. No mechanic wants to work on the pumps, tanks, and pipes that store the waste from the restrooms.

However, at every airport where I've worked, there were always two or three mechanics who volunteered for that service. The others are so happy to have them do it that nobody pays attention to those individuals, and no serious mechanic really associates with those second-rate mechanics. In fact, until recently, I myself had never given this matter a second thought.

Most airlines have reciprocal service agreements with the other airlines that use the same airport. This means that if one airline has a technical problem, one of our mechanics will take care of it. In return, if one of our planes has a problem at another airline's maintenance base, they take care of the repairs.

Last month, I was called in to work on another company's aircraft. At the time of the call, the controller didn't know what the problem was and couldn't give me any details. When I arrived on site, I discovered that the fault was located in the waste storage compartment. There was no other solution: I had to climb into the cockpit to fix the problem. Upon entering the compartment, I realized that something was odd. The aircraft had more tanks, pumps, and pipes than were listed in the load book. At first, I assumed that the system had been modified. It had been more than ten years

since I had worked on a system of that type. While trying to find the problem, I realized that the pipes and supplementary tanks were not connected to the evacuation system... I had just figured this out when another mechanic from my company suddenly appeared. He was one of the mechanics who regularly worked on those systems. I gladly handed the job over to him. As I was leaving, I asked him about the supplementary equipment. He told me: "Take care of your job and let me worry about mine."

The next day, I was on the company computer looking at a wiring plan. Since I was there, I decided to do a search about the supplementary equipment I had found on the aircraft. To my great surprise, the manuals made no reference to the equipment I had seen the day before. I looked in the manufacturer's reports and found nothing there either. My curiosity was piqued: I was determined to discover the nature of that equipment. The following week, we received three of our aircraft in the main hangar for their periodic inspection.

The mechanics climb all over the aircraft during these inspections. I had just finished my work, so I decided to go and look at the evacuation system of one of the aircraft. With all the mechanics around, I was sure that no one would notice me. To my surprise, the aircraft I decided to inspect also possessed this type of supplementary equipment! I followed the system of pipes, pumps, and tanks. I discovered what appeared to be the system's control unit. It was a standard avionics control box, but without the slightest marking. I was able to follow the wires from the control box to the pumps and valves, but no control circuit led to that unit.

The only wires connected to that unit joined the aircraft's operational control system. The system had one large tank and two smaller ones. It was difficult to see due to the cramped compartment, but I estimated the large tank to be about 200 liters. The tanks were connected to a drain and fill valve that ran through the fuselage just behind the wastewater drain valve. I looked under the aircraft to see where that connection led.

I saw it was hidden behind a false panel under another panel that accessed the waste disposal system. I followed the pump pipes. The tubes led to a network of smaller conduits that terminated at the trailing edges of the wings and horizontal stabilizers of the aircraft.

If you look closely at the wings of a large airplane, you'll see a tangle of wires about the size of a finger extending down the trailing edge. These are

static discharge rods. They are used to dissipate the static electricity that builds up on the airplane during flight.

I discovered that the conduits of this system led to one out of every three electrostatic discharge rods. These rods had been perforated, as if to release some kind of product.

I had been perched on the wing for some time when suddenly one of the supervisors ordered me to leave the hangar. He then told me that my work was finished and that I wasn't authorized to work overtime.

The next two days I was very busy and didn't find a minute to continue my little investigation. About 30 minutes later, I was summoned by the managing director. When I entered his office, the representative from our union and two other people I didn't know were waiting for me.

The manager told me a serious problem had been found. I was suspended for serious misconduct. A disciplinary file was opened against me, stating that I had written false information in my work report regarding the engine temperature detector that I had just installed hours earlier. I was devastated and began to protest. I said it was ridiculous and that I had done my job conscientiously. The union representative intervened. He recommended we take a look to clarify things. At that point, I asked who the other two men were. The general manager indicated that they were airline safety inspectors, but that they weren't obligated to give me their names.

We went to the plane that was supposed to have taken off, but was still parked on the maintenance ramp. We opened the engine, and the union representative removed the temperature detector. He checked the serial number and confirmed that it was the old part. Then we went to the parts counter, and the union representative checked my report.

He took a sealed box from a shelf. He opened it and removed the engine temperature sensor, which had the same serial number as the one I had installed. He told me I was suspended without pay for a week.

On the first day of my suspension, I rested at home wondering what had happened to me. During the afternoon, I received a phone call. The voice said: "Now you know what happens to mechanics who stick their noses where they don't belong. The next time you work on systems that aren't your responsibility, you'll lose your job. Since I'm feeling generous today, I think you'll be able to return to your job soon." Click.

I immediately connected what had just happened with the discovery of the mysterious pipes. The next morning, the CEO called me. He told me

that, thanks to the excellence of my report, the suspension had been reduced to one day. So I had to return to work immediately. The only thing I could think about was: What are they trying to hide? And who are they?

My return to work was as if nothing had happened. None of the other mechanics mentioned the suspension I'd been given. In fact, the union representative told me there was no point in talking about it. But that night I surfed the internet looking for answers. I don't remember how I managed it, but I stumbled across their page by chance. Then the situation became clearer and clearer. The next morning at work, I found a note inside my locked locker. It said: Curiosity killed the cat. Don't visit websites that don't concern you.

I don't know what they're vaporizing, but I can confirm that they are. I imagine they use tanker trucks. These are the trucks that empty the waste from the toilet storage tanks. Airports usually subcontract this type of work, and nobody goes near those trucks. Who would want to be near a truck full of filth? When they empty the wastewater tanks, they fill the vaporization system tanks. They know the aircraft's flight plans. So they probably program the control unit to start spraying a certain amount of whatever product it is after a certain time, when the aircraft has reached a certain altitude, or over certain crowds. The opening of the vaporizer in the fake electrostatic rods is so small that nobody on the aircraft could notice.”

Chemtrail is the slang term for the Indirect and Semi-Direct Aerosol Campaign (ISDAC) conducted by departments of the U.S. government.

COOLING AND WARMING EFFECTS OF CLOUDS

Naturally, clouds cover about 55-60% of the earth at any given time.

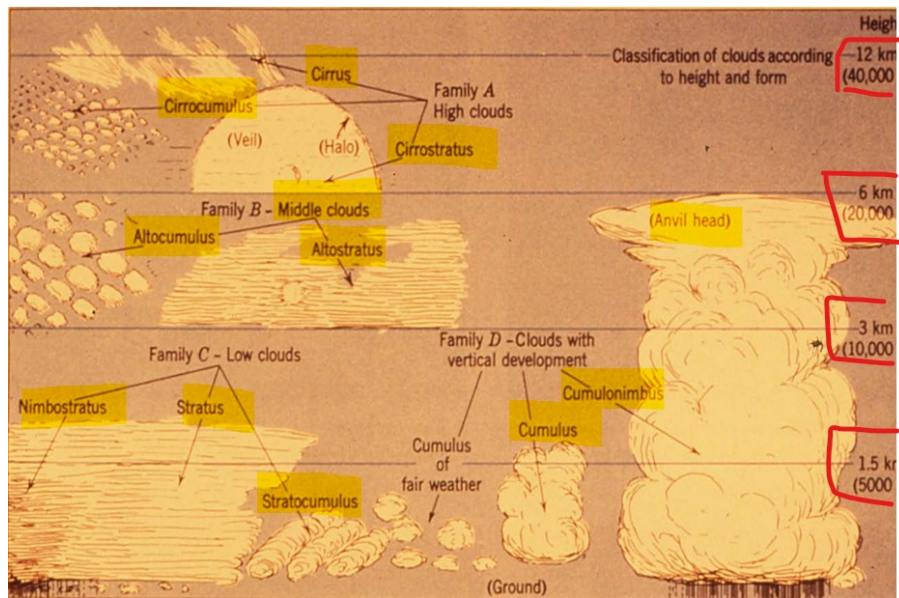
- **Low clouds** (below 10,000 feet, including cumulous, tratus, etc.) tend to reflect solar radiation back to space, thus cooling the earth and atmosphere
- **High clouds** (above 20,000 feet, including cirrus, cirrostratus, cirrocumulus) tend to absorb sensible heat given off by the earth, thus warming the earth and atmosphere.

The difference between a normal jet contrail and “persistent jet contrails” (aka “chemtrails”)

Normal (pre-1988) jet contrails form at temperatures below -76° F. and at relative humidity levels of 70% or higher (according to meteorologist Thomas Schlattes of National Oceanic and Atmospheric Administration or NOAA). Normally, they dissipate within a minute but under ideal conditions can last up to 30 minutes.

Not Normal : These persisting contrails are not natural. The U.S. Air Force admits that “persistent jet contrails” can last up to 23 hours, cover 4000 km², and change climate.

NATURAL CLOUDS TYPES



Some scientists say:

1. Persistent contrails are “trapping warmth in the atmosphere.”
2. Persistent contrails produce man-made clouds that could negatively impact agricultural crop production.
3. “Any increase in global cloud cover will contribute to long-term changes in Earth’s climate. Likewise, any change in Earth’s climate may have effects on natural resources...”

NASA has been creating “persistent jet contrails” (aka “chemtrails”) since 1988

-**Just as natural high clouds** (cirrus, cirrostratus, and cirrocumulus clouds) act to trap terrestrial heat (sensible heat or far infra-red radiation), artificial high clouds formed from spreading “persistent contrails” also trap heat in the atmosphere.

- **Thus**, it is possible that much or most of the observed warming (about 0.2 to 0.3 degrees C) in the late 20th century is due to creation of these man-made clouds.

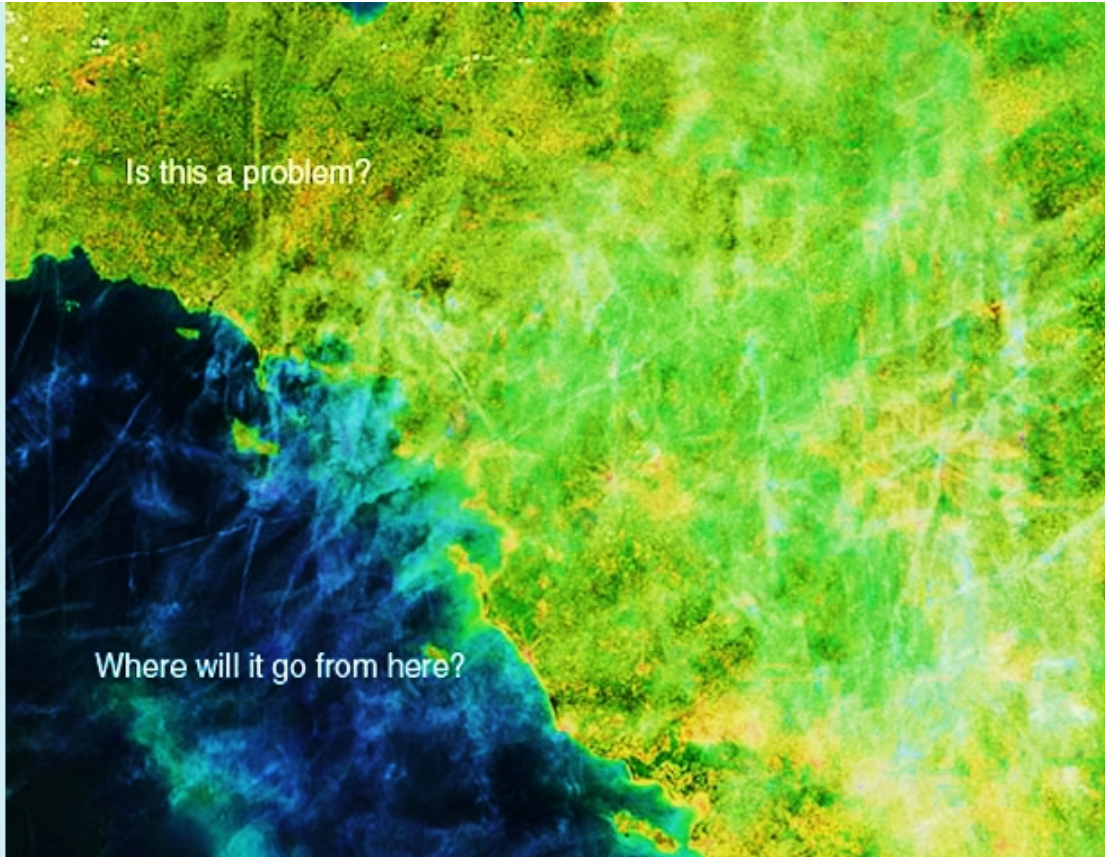
-**NASA**: “Cirrus clouds, formed from aircraft engine exhaust, are capable of increasing average temperatures enough to account for a warming trend in the U.S. that occurred between 1975 and 1994.”

-**NASA (10/05)**: Man-made clouds are “*trapping warmth in the atmosphere and exacerbating global warming...*” “any changes in global cloud cover may contribute to long-term changes in Earth’s climate. Contrails, especially persistent contrails, represent a human-caused increase in the Earth’s cloudiness, and are likely to be affecting climate and ultimately our natural resources.

Parade Magazine published the snapshot (shown on the right), by Darla Moore, which was taken in Evansville, Indiana, on February 24, 2008. This photograph depicts a "sky writing" smiling face. The picture proves that airplanes can write in the sky using stop-and-go techniques to form different types of lines and circles at low altitudes. It is interesting to note that the white outline of the smiling face is persisting over time and closely resembles many of the persisting jet contrails left by high flying jets (shown below).

The picture below left also shows that high flying jets use "stop-and-go" techniques like the ones in the snapshot.

GLOBAL DIMMING

Creation of man-made clouds also decreases crop production and plant growth in natural ecosystems and reduces amount of vitamin D available for humans and other creatures.

Thus, there has been an epidemic of rickets in children in recent years. (CDC, University of CA Berkeley and Kaiser Permanente studies). Heart and infant health problems are also associated with lack of vitamin D. They are commonly laid down in a grid pattern. Spreading “persistent jet contrails” form artificial high clouds that trap heat and warm the atmosphere. These spreading “persistent contrails” mimic cirrostratus clouds (which trap terrestrial heat)

**What are “chemtrails” made of? Just water vapor,

EPA (PA420-R-99-013) Final Report “Evaluation of Air Pollutant Emissions from Subsonic Commercial Jet Aircraft:” Jet emissions include:

- **Ozone**- which absorbs harmful UV radiation in the stratosphere, but at ground level causes lung impairment, increased susceptibility to respiratory

infection, pulmonary inflammation, crop and tree damage.

- **Carbon Monoxide:** Cardiovascular effects up to death

- **Nitrogen oxides:** lung irritation, premature mortality, acid rain,

- Volatile Organic Compounds (VOCs): Eye and respiratory tract irritation, headaches, dizziness, visual disorders, memory impairment, increasing asthma, some are carcinogenic.

- **Particulates** like soot and even tiny graphene particles

- Nanoparticles** of metals and alloys with grid wifi shape

- There has been no attempt **to regulate** these chemtrail emissions. But it has been proposed that U.S. military, private corporations, airlines, public agencies and other users of jet fuel buy pollution credits (offsets), in order to keep polluting at current rates. And they, however, regulate the inoffensive CO₂ which is not a pollutant and its only 0.02% OF THE WHOLE ATMOSPHERE.

- Both CA former Governor Schwartzeneger and House Speaker Nancy Pelosi advocate purchase of emission credits rather than restricting jet emissions at altitudes that leave PJC.)

- The U.S. Air Force and other military branches release chaff (aluminum coated fiberglass particulates) by the ton in the U.S.

Aluminum, barium, strontium, sulfur hexafluorides, nano graphene and many other chemicals are associated with “*persistent jet contrails*” (aka “*chemtrails*”)

AS OF THE LATE 1980'S

Persistent jet contrails persist and turn into white haze and man-made clouds (including brown clouds, unusual cloud patterns, and white reflective haze. (This is documented by thousands of photos and videos. Some show jets circling over various counties.))

Increased persistent jet contrails often appear just prior to predictions of precipitation by local weather reports. The U.S. Air Force, the FAA, government officials and agencies, elected representatives, and university scientists hold that this activity is “*safe and normal.*” (On its website, the Air Force has stated the “*chemtrail hoax has been investigated and refuted by many established and accredited universities, scientific organizations, and major media publications.*” However, no such reports have surfaced.

NASA and NOAA and other government agencies have assured people that PJC are normal and have been in evidence since 1919 (which is prior to invention of jet engines).

In 2001, Congressman Dennis Kucinich (D-Ohio) introduced the Space Preservation Act, which used the word “*chemtrail*” and sought to ban them.

Microsoft's MSFT 0.0% billionaire founder Bill Gates is financially backing the development of sun-dimming technology that would potentially reflect sunlight out of Earth's atmosphere, triggering a global cooling effect. The Stratospheric Controlled Perturbation Experiment (SCoPEX), launched by Harvard University scientists, aims to examine this solution by spraying non-toxic calcium carbonate (CaCO₃) dust into the atmosphere — a sun-reflecting aerosol that may offset the effects of global warming.

Widespread research into the efficacy of solar geoengineering has been stalled for years due to controversy. Opponents believe such science comes

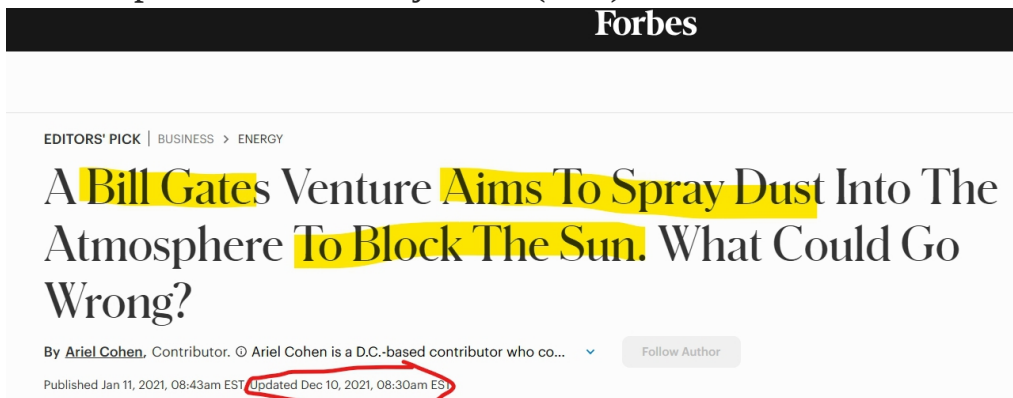
with unpredictable risks, including extreme shifts in weather patterns not dissimilar to warming trends we are already witnessing. Environmentalists similarly fear that a dramatic shift in mitigation strategy will be treated as a green light to continue emitting greenhouse gases with little to no changes in current consumption and production patterns. SCoPEX will take a small step in its early research this June near the town of Kiruna, Sweden, where the Swedish Space Corporation has agreed to help launch a balloon carrying scientific equipment 12 miles (20 km) high.

The launch will not release any stratospheric aerosols. Rather, it will serve as a test to maneuver the balloon and examine communications and operational systems. If successful, this could be a step towards a second experimental stage that would release a small amount of CaCO₃ dust into the atmosphere.

The claim that Bill Gates appeared on national TV to announce a plan to dim the sun with sulfur plane spraying is **totally true**. Gates has proposed the *deployment* of such a system, and he has been a financial backer of academic **research into solar geoengineering**, that means to dim the light of the sun which namely produces global warming.

Here is a breakdown :

Research, and Deployment: Bill Gates is a donor to research programs, such as the Harvard University Solar Geoengineering Research Program (SCoPEX), which study the potential risks and effectiveness of technologies like Stratospheric Aerosol Injection (SAI).



Experimental Stage: The SCoPEX project planned a small-scale experiment that would have involved using a high-altitude balloon to release a non-toxic substance, likely calcium carbonate (chalk dust) rather than sulfur, to study atmospheric effects. The goal was to collect data for computer models, not to dim the sun on a meaningful scale.

Experiments Cancelled/Distanced: The planned experiment in Sweden was canceled in 2021 due to public opposition from local Indigenous groups and environmentalists. The U.S. government and academic institutions have distanced themselves from any actual deployment of these technologies, emphasizing they are only researching the theoretical possibilities.

Concerns and Risks: Gates himself has acknowledged the significant political and scientific arguments against deploying solar geoengineering, including the risk that it could undermine efforts to cut fossil fuel emissions or cause unpredictable shifts in weather patterns like droughts or floods.

The idea of using stratospheric aerosols to cool the planet is a theoretical climate intervention technique, intended to mimic the natural cooling effect observed after large volcanic eruptions.



CHAPTER IV:THE PLAGUE WARS

What are Plague Wars? They are wars fought with bombs loaded with atomizers which spray a region as large as 40 football fields with substances which would infect or contaminate an entire region, and eventually infect or make everyone sick in the target nation with a deadly disease. But killer viruses don't need to be encased in bombs and they cannot- during the Vietnam war, the Pentagon perfected CHEMTRAIL technology and killed many thousands with Agent Orange which was developed by Monsanto.

Where did this killer technology come from? Biowarfare in the form of weaponised CHEMTRAILS means that all buildings, monetary and mercantile wealth in the target nation remain intact after the spraying of killer pathogens, with minimal destruction and minimal cost in the conquest. But never worked and went on to experiment with gases, heavy metals, toxins, electromagnetic waves resonance 3 and 4G technology and nanotechnology.

THE ROYAL NAZIS..

Prince Charles Edward, Duke of Saxe-Coburg and Gotha, a grandson of Queen Victoria and also the English Duke of Albany has been airbrushed out of history by Buckingham Palace. But Jordan Maxwell Files readers will know that the NAZI regime was in part inspired and funded by the Royal Sovereign houses of Bavaria who now masquerade as 'British' royals using the name 'Windsor'.

Through their emissary and rogue Prince Charles Edward Duke of Saxe Coburg, the NAZI regime found covert backing from Buckingham Palace for the financing of biowarfare experimentation at NAZI concentration camps. Prince Charlie Coburg was brought up in Britain but tutored in German history, traditions and – importantly – how to be a German officer. He was groomed to become a nemesis and facilitate the World Wars which ripped European nations to shreds and robbed them of their colonies.

Prince Charlie was packed off to Germany by Buckingham Palace - history has proven that his prime objective was to break-up and occupy the western European nations and steal their colonial assets. He left and told his friends at Eton: *“I’ve got to go and be a beastly German duke”*. And beastly he was.

On June 1st, 1905, thousands of Germans turned out to greet British Prince Charlie, following him to Friedenstein Castle. The main sights of Prince Charlie's German hometown called 'Gotha' is Friedenstein Castle,

one of the largest Renaissance/Baroque castles in Germany. Gotha is the original place where our 'British' royals came from - they share Jewish ancestry - for many centuries, Jews dominated the urban markets of Gotha.

Gotha has existed as a major trading site at least since the 8th century, when it was mentioned in a document signed by Charlemagne as Villa Gotaha ("*Good Waters*") in 775 AD. One of the oldest pieces of evidence of busy trade in the city is the "Gotha cache of coins" with nearly 800 Bracteates, buried in 1185 in the central city.

In 1180, Gotha was first mentioned as a city, when the area between Brühl and Jüdenstraße [Jew Street] became the core of urban development, highlighting the early presence of Jews in Gotha.

Well, within that Germanic Jewish cabal of royals and aristocrats, the seething first whimpering murmurs of a plan known as Zionism flourished... Prince Charlie was indebted through an age-old pact that was mustered by the Knights Templar to create a Jewish Homeland and reclaim complete control over Jerusalem for the European aristocratic elite and Jewish nobility, such as the Rothschilds. The heinous events of the second world war did eventually evolve and fruit into the Israel we see today - a tiny nation hanging on by its fingernails to an obscure edge of the Mediterranean surrounded by Arabian land & oil barons. In a lengthy ceremony Prince Charlie accepted his German dukedom in front of his cousin the Kaiser, British King Edward VII, and members of the her majesty's government from Whitehall.

He already spoke German – King Edward VII spoke German frequently at court. In 1932, Charles Edward took part in the creation of the extremist Harzburg Front, which became associated with the Nazis. He was mesmerised by Hitler and, being now totally German in outlook, found a new allegiance to his adopted country through the ranting dictator. Prince Charlie upped sticks and moved to Bavaria. Prince Charlie Coburg joined the Nazi party, becoming an active member of the murderous stormtrooper organization the SA, known as the Brown Shirts, rising to a senior rank. Amazingly, the former Duke of Saxe-Coburg and Gotha was allowed back to Britain in 1936 in his role as President of the Anglo-German Friendship Society. He strutted the corridors evangelizing for Hitler at many Royal functions.

A fake 'appeasement' plan was concocted to allow the Prince and Hitler to amalgamate Britain into the '*Master Race*' - but British people never liked Prince Charlie and so a second World War was designed to depopulate Europe. Prince Charlie had the mannerisms of a heel-clicking megalomaniac – he helped orchestrate and engineer the First World War, and the Duke decided that he should support the Kaiser and his adopted Germany's cause. The 'British' Royal Family had already been obliged to change their family name from Saxe-Coburg-Gotha to the more English '*Windsor*' - and now had to play down that one of their own was a leading military leader and waging war against the Brits who he had grown up with! The NAZI Prince has left behind a horrible legacy - his support and partial funding of the Third Reich has led to Chemtrails, *Agent Orange* and chem-warfare *killer toxins*...

AMERICAN NAZI BIOWARFARE SCIENTISTS..

N AZI scientists were offered cushy jobs all over the USA at the end of the second world war. These former NAZI officers worked alongside Jewish doctors and perfected Anthrax bombs, and Agent Orange Chemtrail technology. Some of the NAZI officers who were central to biowarfare development were outed as NAZI serial Killers by the New York Times, several years after they had been issued plush houses and well paid jobs by the White House in post war USA.

Yes, it's true. Former NAZI officers became central figures at NASA and the Pentagon. Some former SS officers, such as Werner Von Braun, were in charge of budgets of hundreds of millions of dollars. On 7th of October 1951, the New York Times reported that former NAZI chief, Walter Schreiber, was working at the Air Force School of Medicine at Randolph Air Force Base in Texas. It caused a scandal that American tax payers' money was being used to give a NAZI a plush life! When journalist Drew Pearson publicized Schreiber's Nuremberg trial evidence in 1952, which showed he had assigned doctors to experiment on

concentration camp prisoners and had made funds available for such experimentation,

the negative publicity led the Joint Intelligence Objectives Agency [controlled by the Pentagon] to arrange "***a visa and a job for Schreiber in Argentina, where his daughter Elisabeth was living.***" On 22nd of May 1952 he was flown to Buenos Aires. In Argentina, he worked at an epidemiological laboratory. Some accounts suggest he subsequently moved to Paraguay and West Germany, while another claims he died in Italy in 1952. It is a fact that in 1971 President Richard Nixon, as part of his War On Cancer, combined the U.S. Army's biowarfare department at Fort Detrick, Maryland, with the National Cancer Institute.

The army's DNA and genetic engineering programs were coordinated into anti-cancer research and molecular biology programs. This marriage also cemented the governmental ties of cancer research to the CIA, the CDC, the World Health Organization, and private industry. Historically, Fort Detrick was the center of the US biological weapons program from 1943 to 1969. Since the discontinuation of that program, it has hosted most elements of the United States biological defense program. During this same period the Special Virus Cancer Program (1968-1980), now largely and conveniently forgotten, was established to coordinate the search for cancer-causing viruses.

This secrecy also surrounds the many scientists who directly or indirectly contribute to the program - and that secret scientific community includes SS NAZI Killers and Jews! There is no complete record of what this Virus Cancer Program has achieved or what cancer causing and immunosuppressive animal cancer viruses were adapted for biological warfare use and for covert military testing on human populations. We can

only judge these men by the curious never-before-seen viruses which have killed 30million Africans in 30 years.

For the last few years, Fort Detrick's 1,200-acre (490 ha) campus has supported a multi-governmental community that conducts biomedical research and development, medical materiel management, global medical communications and the study of foreign plant pathogens - that is, diseases of crops. Fort Detrick is home to the U.S. Army Medical Research Institute of Infectious Diseases (USAMRIID).

It also hosts the National Cancer Institute-Frederick (NCI-Frederick) and is home to the National Interagency Confederation for Biological Research (NICBR) and National Interagency Biodefense Campus (NIBC). During World War II, Fort Detrick and the USBWL became the site of intensive biological warfare (BW) research using various pathogens.

Army Experiments With Super Germs

WASHINGTON, July 14—(UPI)—Forty Army scientists are working on a project that could add deadly super germs of types that do not exist in nature to the potential of biological warfare, it was learned today.

The scientists are at the Army's Biological Research Center at Fort Detrick, Md., just outside Washington. They already have succeeded in producing bacteria with new combinations of hereditary characteristics.

IF THEIR RESEARCH bears fruit, a new and fearsome surprise element would be added to the potential of bacteriological war. A germ known only to its finders conceivably might wipe out populations before an antidote could be devised.

In the guarded language of an Army statement submitted to a House subcommittee on Defense Appropriations, the scientists they were "attempting to isolate mutants of bacteria... and studying the transmission of their characteristics."

This research was originally overseen by pharmaceuticals executive George W. Merck and for many years was conducted by Ira L. Baldwin, professor of bacteriology at the University of Wisconsin. The Merck pharmaceutical company is the world's leading vaccine manufacturer.

In summary, Porton Down in the UK, and Fort Detrick's arsenal of diseases can wipe out crops, and entire populations with a simple incognito **CHEMTRAIL** program. "Vaccination decimates populations. Drastically in Third World countries. Chronically in industrialized countries..."

This is a statement from former President of the World Bank, former Secretary of State in the United States, who ordered massive bombing of Vietnam, and member of the Expanded Program on Immunization, Robert McNamara, made some very interesting remarks.

As reported by a French publication, "*j'ai tout compris*", he was quoted as stating: "*One must take draconian measures of demographic reduction against the will of the populations. Reducing the birth rate has proved to be impossible or insufficient. One must therefore increase the mortality rate. How? By natural means. Smallpox vaccine 'triggered Aids virus'

The Aids epidemic may have been triggered by the mass vaccination campaign which eradicated smallpox.

The World Health Organization, which masterminded the 13-year campaign, is studying new scientific evidence suggesting that immunization with the smallpox vaccine *Vaccinia* awakened the unsuspected, dormant human immuno defence virus infection (HIV).

Some experts fear that in obliterating one disease, another disease was transformed from a minor endemic illness of the Third World into the current pandemic.

While doctors now accept that *Vaccinia* can activate other viruses, they are divided about whether it was the main catalyst to the Aids epidemic.

But an advisor to WHO who disclosed the problem, told *The Times*: "I thought it was just a coincidence until we studied the latest findings about the reactions which can be caused by *Vaccinia*. Now I believe the smallpox vaccine theory is the explanation to the explosion of Aids."

Further evidence comes from the Walter Reed Army Medical Centre in Washington.

While smallpox vaccine is no longer kept for

modified versions of the smallpox vaccine to combat other diseases in developing countries.

Other doctors who accept the connection between the anti-smallpox campaign and the Aids epidemic now see answers to questions which had baffled them. How, for instance, the Aids organism, previously regarded by scientists as "weak, slow and vulnerable", began to behave like a type capable of creating a plague.

Many experts are reluctant to support the theory publicly because they believe it would be interpreted unfairly as criticism of WHO.

In addition, they are concerned about the impact on other public health campaigns with vaccines, such as against diphtheria and the continued use of *Vaccinia* in potential Aids research.

The coincidence between the anti-smallpox campaign and the rise of Aids was discussed privately last year

However, as epidemiologists gleaned more information about Aids from reluctant Central African countries, clues began to emerge from the new findings when examined against the wealth of detail known about smallpox as recorded in the *Final Report of the Global Commission for the Certification of Smallpox Eradication*.



The **location coincides** dramatically. The earliest known cases of AIDS occurred in central Africa, in the same regions where Koprowski's polio vaccine was given to over a million people in 1957-1960.

The timing coincides. *There is no documented case of HIV infection or AIDS before 1959.* Centuries of the slave trade and European exploitation of Africa exposed Africans and others to all other diseases then known; it is implausible that HIV could have been present and spreading in Africa without being recognised.

Polio vaccines are grown (cultured) on monkey kidneys which could have been contaminated by SIVs, full of mercury, aluminum and other heavy metals and chemicals like polysorbate, too. Polio vaccines could not be screened for SIV or heavy metal contamination before 1985.

. A specific pool of Koprowski's vaccine was later shown to have been contaminated by an unknown virus. Albarelli Jr. concludes that CIA operative Frank Olson was murdered because a personal crisis of conscience made it likely he would divulge

Albarelli alleges that Project SPAN involved the contamination of food supplies and the aerosolized spraying of a potent LSD mixture in the village of Pont-Saint-Esprit, France in August, 1951. Olson was involved in the development of aerosolized delivery systems; he had been present at Pont Saint-Esprit in August, 1951; and several months before resigning his position he had witnessed a terminal interrogation conducted in Germany under Project ARTICHOKE. Author John Grant Fuller comes to similar conclusions about the incident in his book *The Day of Saint Anthony's Fire*.

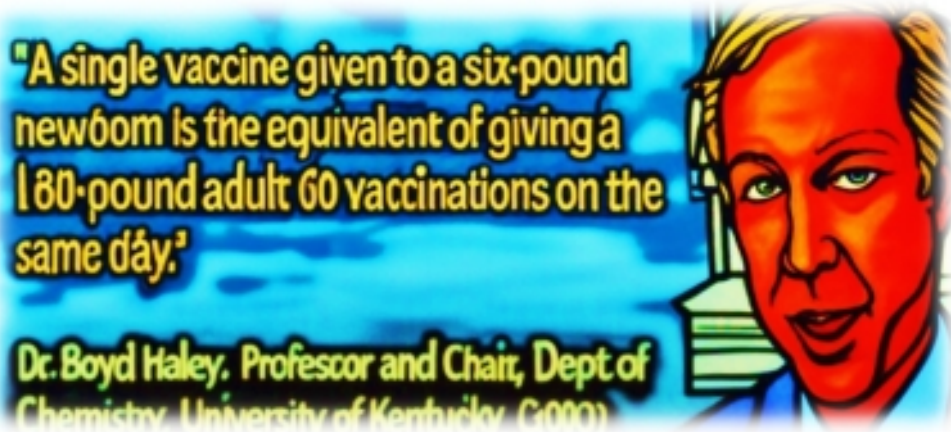


Frank Olson was an American bacteriologist, biological warfare scientist, and CIA employee who worked at Camp Detrick (now Fort Detrick) in Maryland. Frank Olson was covertly dosed with LSD by his CIA supervisor and, nine days later, plunged to his death from the window of a New York hotel room. Most people believe he was 'Suicided'. Fort Derrick is one of the major BioWarfare development institutions - it is here that former CIA and former NAZI officials hired Jewish scientists to develop bacteria and virus to cause cancers, but since they didn't get any pathogens to do it, they use drugs and chemicals to achieve it.

Other newspapers that converged on the scene described people throwing themselves from rooftops, women and men throwing their clothes off and running the streets naked, and children complaining that their stomachs were infested with coils of snakes. MK DELTA was actually related to the clandestine mind control and (JFK) assassination operations of a high level military intelligence, anti-communist-ultra conservative and an extreme racist, Dr. Alton Ochsner.



He was centered in New Orleans at Tulane University Medical School, and the Tulane’s DELTA Regional Primate Center. According to the research of Edward T. Haslam in New Orleans, author of *Mary, Ferrie & the Monkey Virus, The Story of an Underground Medical Laboratory*, he speculates that Dr. Alton Ochsner, former head of Surgery of Tulane Medical School and director of the Ochsner Clinic of New Orleans secretly headed MK ULTRA- DELTA. Dr. Ochsner was one of the most ultra conservative powerful and dangerous men in New Orleans. He was a MAJOR RING LEADER implicated in the assassination of President John F. Kennedy.

A blog page shadowing the clandestine operations of the Tulane institution says; “Wolf's findings eventually led to the realization that the government-sponsored mind control program was and may still be widespread. Initiated as a measure for creating spies during the Cold War period, the program had degenerated into the creation of a corps of young women who were sterilized by radiation, trained to deliver sexual

gratification at the will of their handlers, and used to entrap government officials, university presidents and others who could influence funding for the continuance of the program.

Wolf paid the price for speaking out; on July 19, 2000, the Louisiana Board of Social Work Examiners revoked Wolf's license saying that she practiced 'beyond her competence and exploited her clients for personal gain'. 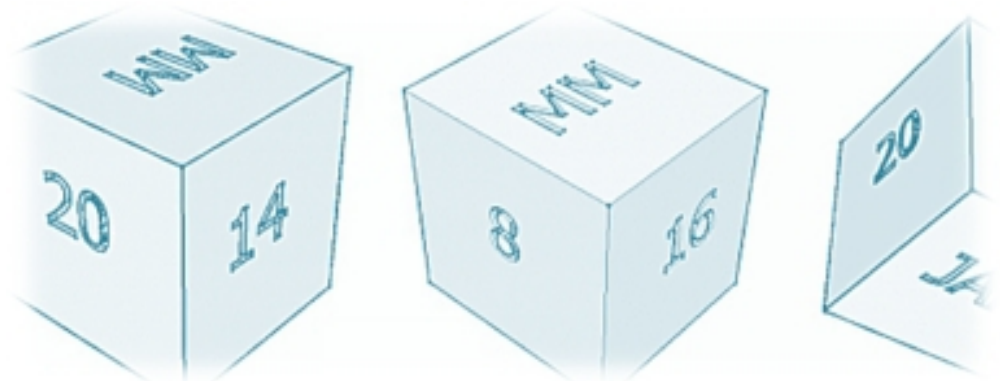

They are a mysterious, massive and astronomically-aligned group of granite panels which feature sculpted writing in many languages - and there are not that many public structures in the USA which feature alternative languages... The Georgia Guide Stones contain a plan for human depopulation. The author is unknown - some say it was funded by Ted Turner... But no one is certain.

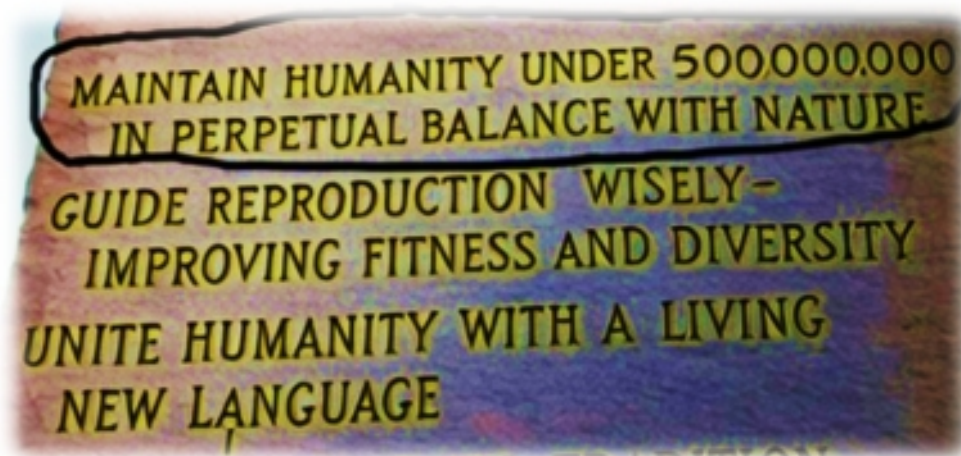
The instructions for the remaining population of the earth, should something cataclysmic occur have been vandalized on more than one occasion. Completed in March 1980, measuring almost 20 feet in height, they were created under commission by the Elberton Granite Finishing Company. Various additions have been added to the stones, with a cube like design recently added in 2014 - this was subsequently stolen - but was extensively photographed and sketched prior to its disappearance.



The main feature is the following message, translated in various languages including English, Spanish and Hebrew.



The 2014 JAM CUBE: What is J, A and M for? Is it Jesus, Abraham and Mohammed?



The message reads [with most popular ‘Conspiracy Theory’ interpretations in brackets]: “*Maintain humanity under 500,000,000 in perpetual balance with nature.* [kill Seven Billion people, leaving just the Chosen Few in USA, Israel & Europe] *Guide reproduction wisely —*

improving fitness and diversity. [No blacks should be allowed to have babies?] Unite humanity with a living new language.



[A secret language for just the Chosen Ones - Modern New Hebrew or Esperanto?] Rule passion — faith — tradition — and all things with tempered reason. [Get rid of fanatics?] *Protect people and nations with fair laws and just courts.* [Martial Law - except for the rich?] *Let all nations rule internally resolving external disputes in a world court.* [Command the populace from a central system of Justice] *The last few elements of the text seem to be written with some common sense - however, how does a person 'leave room for nature?' - I suppose this is a piece of advice for property developers! Avoid petty laws and useless officials. Balance personal rights with social duties. Prize truth — beauty — love — seeking harmony with the infinite. Be not a cancer on the earth — Leave room for nature — Leave room for nature."*

The Georgia Guidestones monument was destroyed in July 2022 after an unknown individual detonated an explosive device at the site. The remaining structure was subsequently demolished by local authorities for safety reasons.

Details of the Incident

Date and Time: An explosion occurred around 4:00 a.m. on Wednesday, July 6, 2022.

Method: An explosive device was placed at the base of one of the granite panels.

Damage: The initial blast destroyed one large granite panel and caused significant damage to the capstone. The rest of the monument was later torn down by authorities out of public safety concerns.

Investigation: The Georgia Bureau of Investigation (GBI) released surveillance footage showing the explosion and a silver sedan speeding away from the scene.

No suspects have been publicly identified, and the investigation remains ongoing. Anonymous tips can be submitted via the GBI website.

Aftermath: The five-acre plot of land where the monument stood was returned to its previous owner, and the remains of the structure were donated to the Elberton Granite Association, where a display model is available at their museum.

BACKGROUND AND CONTROVERSY

Often nicknamed "America's Stonehenge," the 19-foot-tall granite monument was erected in 1980 by an anonymous person or group using the pseudonym "R.C. Christian". The monument featured ten guidelines for humanity in eight different languages, including controversial edicts such as "Maintain humanity under 500,000,000 in perpetual balance with nature".

These inscriptions and the monument's mysterious origins made it a focal point for conspiracy theories. Some conservative Christians and conspiracy theorists labeled the stones as "satanic" or a symbol of the "New World Order". The monument had been a target of previous vandalism in 2008 and 2014, and its destruction in 2022 was cheered by some online communities and political figures who had previously called for its removal.

CHAPTER V: THE HAARP PROJECT

The High-Frequency Active Auroral Research Program (HAARP) is an advanced scientific research facility used to study the ionosphere, the upper layer of Earth's atmosphere. It has a high-power, high-frequency transmitter that temporarily excites a limited area of the ionosphere with radio waves to analyze the physical processes that occur there.

Despite its scientific purpose, **HAARP** has been a frequent subject of various conspiracy theories that claim it is a secret military weapon capable of causing widespread harm. Scientists and experts have consistently dismissed these claims, stating they fall far outside the facility's capabilities and the laws of natural science. Theories surrounding HAARP typically portray it as a clandestine and powerful weapon with a range of sinister capabilities:

- **Weather Manipulation and Geoengineering:** This is the most persistent claim, suggesting HAARP can control weather patterns, trigger hurricanes, cause droughts, or create floods. These theories often emerge after extreme weather events, such as the 2011 Japanese earthquake and tsunami or specific blizzards, which conspiracists blame on HAARP activity.
- **Triggering Natural Disasters:** Theorists claim HAARP can induce earthquakes or tsunamis by focusing energy into the Earth's crust (lithosphere).

- **Mind Control and Psychotronic Warfare:** Some believe the facility's radio wave transmissions can influence human thoughts, emotions, and behaviors, effectively serving as a mind-control device.
- **Military Weaponization:** Other claims suggest HAARP is used as a covert weapon for the military-industrial complex to disable enemy electronic systems, create electromagnetic pulses (EMPs), or disrupt satellite communications.
- **Planetary Effects:** More extreme theories propose HAARP could "flip Earth's magnetic poles" or cause the sky to "literally appear to burn".

SCIENTIFIC ANALYSIS

Scientists explain that these conspiracy theories are unfounded for several reasons:

- **Wrong Atmospheric Layer:** Weather phenomena occur in the troposphere and stratosphere, layers much closer to Earth's surface (up to about 15 km altitude). HAARP's radio waves interact with the ionosphere, which is far above that (starting at around 60 km altitude). The energy cannot be transferred between these layers to affect surface weather.
- **Insufficient Power:** The amount of energy HAARP produces is many orders of magnitude smaller than the energy involved in natural weather systems or solar heating of the Earth. Its effects in the ionosphere are temporary and weak, requiring sensitive instruments to detect.
- **Lack of Evidence:** There is no credible scientific evidence or data to support any of the conspiracy claims. The facility's operations are a matter of public record and are heavily regulated by agencies like the FCC and FAA. The HAARP facility hosts annual open houses for the public to visit the site and learn about the research.

One much discussed project that embodies both civilian and military geophysical applications is the High-frequency Active Auroral Research Program (HAARP). Although HAARP proponents claim it is nothing more than a simple civilian research station designed to investigate the properties of the upper atmosphere, few investigators buy that explanation. HAARP does have the appearance of a civilian project with open access and the

work being done by civilian scientists. However, the project is managed by a joint US Air Force and Navy committee and is funded out of the Department of Defense (DoD) budget.

Most recently the heart of the program, the Ionospheric Research Instrument (IRI), was completed by one of the world's largest defense contractors working under the direction of the Defense Advanced Research Projects Agency (DARPA), a top research and development (R&D) organization for the DoD.

DARPA manages and directs selected basic and applied R&D projects for the DoD pursuing research and technology *“where risk and payoff are both very high and where success may provide dramatic advances for traditional military roles and missions.”*

Under construction since 1990, the HAARP IRI is a field of antennas on the ground in Southeastern Alaska. The facility was probably completed late in 2005 with the announcement of same added to the DARPA website in March of 2006. It is now the world's largest radio frequency (RF) broadcaster, with an effective radiated power of 3.6 million watts — over 72,000 times more powerful than the largest single AM radio station in the United States (50,000 watts).

The IRI uses a unique patented ability to focus the RF energy generated by the field, injecting it into a spot at the very top of the atmosphere in a region called the ionosphere. This heats the thin atmosphere of the ionospheric region by several thousand degrees.

HAARP, then, is a type of device called an ionospheric heater. This heating allows scientists to do a number of things with the ionosphere. Controlling and directing the processes and forces of the ionosphere is called *“ionospheric enhancement.”* An early HAARP document stated:

“The heart of the program will be the development of a unique ionospheric heating capability to conduct the pioneering experiments required to adequately assess the potential for exploiting ionospheric enhancement technology for DoD purposes.”

What might those DoD purposes be? Something about winning wars, eh? How might those purposes be achieved? What technologies will be needed to win the wars of the future? Researchers trying to answer those questions

have come up with a vast number of possibilities, most bordering on science fiction. But then again, good science fiction is about recognizing the problems of the future, and suggesting solutions to them before they happen.

On 23 March 1983 President Ronald Reagan called upon "... *the scientific community in our country, those who gave us nuclear weapons, to turn their great talents now to the cause of mankind and world peace, to give us the means of rendering these nuclear weapons impotent and obsolete.*"

This quest for the creation of a technology, of a weapon or weapons system that would make atomic war impossible was officially named the Strategic Defense Initiative (SDI). The press lost no time in dubbing it Star Wars after the George Lucas movie.

That Initiative sent the United States military-industrial-academic complex on the greatest and costliest weapons hunt in human history. Thousands of ideas were floated, hundreds of those were funded. While SDI research has since been officially abandoned, some ideas are still being actively pursued to this day.

Not all of these ongoing developmental programs are taking place in laboratories of the military and its contractors. Some of these ideas involve technologies or applications that, as weapons, violate international treaties; others, the use of which would be repugnant to the ethical and moral values of the majority of Americans. In an effort to avoid public outcry (and international condemnation) some of these programs have been disguised as civilian science. One of those may be HAARP.

As Dr. Bernard Eastlund, the putative inventor of HAARP put it: "*The boundary between science fiction and science comes with can you actually make the thing that you're proposing.*" Bernard J. Eastlund is a physicist who received his B.S. in physics from MIT and his Ph.D. in physics from Columbia University. He led a team of scientists and engineers working for Advanced Power Technologies, Inc. (APTI), a wholly owned subsidiary of ARCO. Eastlund's team developed the concept of a massive antenna array that could produce the kind of shield called for by President Reagan.

The APTI patents that HAARP is probably based on openly discuss manipulating the weather by moving the jet stream and using other

techniques to create floods and droughts at will. These patents also describe a way to raise the ionosphere, sending it out into space as an electrically charged plasma capable of destroying anything electronic (like an incoming ICBM or a spy satellite) passing through it. HAARP certainly looks like a ground-based Star Wars weapons system, a “relic” of the Cold War. But unlike most such relics this one is up and running and now fully funded.

In August of 2002 the Russian State Duma (their version of Congress or Parliament) expressed concern about HAARP, calling it a program to develop “a qualitatively new type of weapon.” A joint commission of the State Duma's International Affairs and Defense Committees issued a report that said:



“Under the High Frequency Active Auroral Research Program (HAARP) the USA is creating new integral geophysical weapons that may influence the near-Earth medium with high-frequency radio waves. The significance of this qualitative leap could be compared to the transition from cold steel to firearms, or from conventional weapons to nuclear weapons. This new type of weapon differs from previous types in that the

near-Earth medium becomes at once an object of direct influence and its component.”

The report further claimed that the USA's plan to carry out large-scale scientific experiments under the HAARP program, and not controlled by the global community, would create weapons capable of jamming radio communications, disrupting equipment installed on spaceships and rockets, provoke serious accidents in electricity networks and in oil and gas pipelines and have a negative impact on the mental health of people populating entire regions.

An appeal, signed by 90 deputies, demanding that an international ban be put on such large-scale geophysical experiments was sent to President Vladimir Putin, to the United Nations (UN) and other international organizations, to the parliaments and leaders of the UN member countries, to the scientific public and to mass media outlets. Getting back to Dr. MacDonald.

Among the coming "*advances*" he wrote about were manipulation or control over the weather and climate, including destructive use of ocean waves and melting or destabilizing of the polar ice caps; intentional ozone depletion; triggering earthquakes; and control of the human brain by utilizing the earth's energy fields. Today the polar ice caps are indeed melting and holes in the ozone layer are growing.

Could these be the handiwork of advanced weapons? What about earthquakes and mind control? Are we, the private citizens of the world, in the crosshairs of bizarre, unthinkable weapons? What about the Russian Duma's claim that HAARP could have a negative impact on the mental health of people populating entire regions of the globe? In "*Vandalism In The Sky?*," their seminal article on HAARP in Nexus Magazine, Dr. Nick Begich and Jeane Manning describe how HAARP could be used to induce mental dysfunction, quoting from Brzezinski on a proposal from Dr. Macdonald saying:

“Political strategists are tempted to exploit research on the brain and human behavior. Geophysicist Gordon J. F. MacDonald — specialist in problems of warfare — says [an] accurately-timed, artificially-excited electronic stroke “...could lead to a pattern of oscillations that produce relatively high power levels over certain regions of the Earth... In this way, one could develop a system that would seriously impair the brain

performance of very large populations in selected regions over an extended period...”

Dr. MacDonald commented on the possible use of the destructive effects of electromagnetic fields in the environment on human health and performance.

He said that weapons systems could be developed that would increase the intensity of the electromagnetic field oscillating in the spherical shaped cavity between the Earth and the ionosphere, and that these weapons could be used to *"seriously impair brain performance in very large populations in selected regions over an extended period"* just as the Duma feared HAARP might do.

Could HAARP, or another similar antenna elsewhere, be the source of North Korea's madness? Could Kim Jung Il be a true Manchurian Candidate? And if so, whose?

In 1969 Dr. MacDonald wrote: *"Our understanding of basic environmental science and technology is primitive, but still more primitive are our notions of the proper political forms and procedures to deal with the consequences of modification."*

It would appear that the gap between our understanding of environmental science a technology and our ability to grapple with this knowledge as a body politic has changed little in the intervening decades. You, my friend, must take action to create the necessary *"forms and*

procedures to deal with the consequences of modification." It is, after all, your planet.

On the other side, **Radio waves**, especially **ELFs** (extremely-low frequency waves) can be used to disrupt or enhance communications systems, peer deep into the earth and oceans (earth penetrating tomography), steer hurricanes, the jet stream, and weather systems.

Such ELFs are created at facilities like HAARP, in Gulkona, Alaska. HAARP has the capacity to generate 3.6 million (potentially billions) watts of power and direct that energy anywhere around the globe.

There are also another 20 similar "ionospheric heaters" around the world, including Puerto Rico, Germany, Russia, Norway, China, etc.

Tesla said that *"science is perverse if it does not take the path of improving humanity."* Apparently, some have chosen the perverse path. The website Haarp.net mentions a document from the United States Army that states: *"The potential applications of artificial electromagnetic fields are diverse and can be used in many military or quasi-military situations. Some of the potential uses range from crowd control, combating terrorist groups, controlling military security installations, and anti-personnel techniques in warfare tactics. In all cases, electromagnetic systems would be used to produce mild to severe psychological disturbances or perceptual distortion."*

SUMMARIZING

HAARP technology is based on the patents of Serbian genius Nicola Tesla and American Bernard Eastlund, who heavily relied on Tesla's work. HAARP generates ELF waves (extremely low frequency) waves that can penetrate deep into the earth and oceans. It is perfect for earth-penetrating tomography (EPT) and communicating with or disrupting communications of submarines. Although officially, HAARP is just a research station, it is funded by the Department of Defense, whose primary function is to win wars, i.e., killing people and destroying things.

MORE ON HAARP

- **H**AARP is part of the U.S. military's non-conventional war program that began in the 1990's after the collapse of the Soviet Union.

Electromagnetic warfare weapons also include scalar weapons, radio frequencies, and micro-wave weapons.

- **HAARP** is also capable of generating electromagnetic **pulses (EMP)**.

- **HAARP can create a plume of electrically-charged particles** that can be exploded when ignited by an electric pulse (EMP). (This technology may be similar or identical to Nicola Tesla's infamous "death ray.")

- **Another possible use of HAARP is to direct ELF's to a fault zone** and thereby trigger earthquakes. (See the History channels program "Weather Warfare" to see how this is done.)

- **Another potential use is "mind control."** HAARP can broadcast electromagnetic energy in the range of human brain waves (0 to 10 hertz). (Author Jerry Smith believes the primary function of HAARP is to bathe the atmosphere in ELF's that are the same frequency as that of the human mind).

According to Jerry E. Smith (*Weather Warfare: The Military's Plan to Draft Mother Nature and HAARP: The Ultimate Weapon of the Conspiracy*), the U.S. Air Force's (and Navy and a number of corporations) HAARP is probably an attempt to weaponize the atmosphere. As such, is the continuation of the Star Wars and Strategic Defense Initiative Projects.

The Environmental Modification Treaty (ENMOD) made environmental modification illegal. Nonetheless, some 700 degreed scientists (civilian contractors) are now researching the topic of weather modification, largely in Fargo, North Dakota.



Although the U.S. government signed the ENMOD treaty, it moved this kind of research “off budget” (to private contractors).

Senator Kay Bailey Hutchison proposed the Weather Modification Authorization Act, which would further limit weather modification by creating a Weather Modification Advisory Board. Although the bill went to the Senate calendar it died without being voted on. Another bill was later introduced, named Weather Mitigation Advisory Board. (Notice the Orwellian change of words and meaning between the two advisory boards!).



CHAPTER VI:THE SECRET PROJECTS/TOP SECRET

At first, civilian and military officials described these phenomena as perfectly normal: "What you call chemical traces are nothing more than condensation." They can't explain why these trails often intersect, as if the pilots were playing tic-tac-toe in the sky.

Another attempt at justification has been fuel spillage in cases of forced landings. We have no problem admitting this in specific and, of course, documented cases, but not systematically, and even less so in intersecting trajectories.

And then there are these strange substances floating in the air, like very thin spiderwebs that liquefy upon touching the ground. Some analyses have confirmed the presence of biological substances and barium salts. And furthermore, whether it's mass hysteria or chemical reality, hundreds of people fall ill the day after these phenomena.

Authorities have avoided any discussion, and chemtrails are neither the subject of scientific study nor a topic of debate. And the events of September 11, 2001, have done nothing to smooth things over. Curiously, most civilian aircraft remained grounded for more than fifteen days, but chemtrails could still be observed. A journalist from the Columbus Alive newspaper noted that in southwestern Ohio and Indiana, the sky was filled with planes, like wasps spraying clouds everywhere. One plane appeared to be a KC-135 Stratotanker. The journalist, armed with powerful, high-quality binoculars, was able to distinguish the orange trails. The

Stratotankers were accompanied by KC-10s and another type of tanker aircraft that he could not identify.

The notion of security takes precedence over any other consideration, and overly curious citizens are considered bad citizens... Given such an attitude, it is normal for the worst fears to transform into near-delusions: on the Internet, one can find researchers who defend terrifying theories that go globally in six directions:

GLOBAL AND LOCAL MANAGEMENT OF WEATHER CONDITIONS.

Atmospheric and weather modifications. It has long been known how to seed clouds to induce rain. In the 1950s, aluminum began to be sprayed into the sky after a population concerned about the drought of those years asked the government to take action.

Chemtrails would allow, through the combined action of electromagnetic waves, complete control of the weather. It is known that torrential rain, floods, drought, hurricanes, snow, and ice can quickly end a war or conflict and even serve as threats against a nation or region. Control of any industry can be easily achieved by destroying or disrupting the climate of a specific region.

I want to share this article, translated exclusively for this book by Alain Cachau, a friend dedicated to the cause.

WAR? IN WHAT CLIMATE?

Control of Mother Nature is a key element of the army's Full Spectrum Dominance program. In 1996, the brightest minds of the US Air Force and their civilian advisors envisioned six future scenarios. This is one of them, taken from an Air Force document.

The American worldview broadened after a terrorist attack against the United States in the early 21st century. This event, coupled with growing environmental concerns, was orchestrated to foster a consensus that the United States should actively work to establish a balance of power beyond its borders, despite the frustration of a far-reaching network of influence.

Unless all countries have signed a new anti-terrorism Act, it would be easy to link all these networks in the name of surveillance, a symbol of protection and national security. This is what is offered to us through government agencies such as *DARPA* (Defense Advanced Research Projects Agency), the Homeland Security Agency, or through firms such as Raytheon, the Halliburton Partnership of Brown and Root, one of the main components of the Bush-Cheney drug empire. It can be added that John Poindexter, who was arrested during the Iran-Contra scandal (the exchange of drugs and weapons between Iran and the Nicaraguan Contras), has been placed at the head of the Homeland Security Agency on six charges, including destroying evidence.



He now directs the most powerful global surveillance machine that will exist once it is connected to the other terminals. He is a loyal servant of the Illuminati. With the goal of achieving an objective called Full Spectrum Dominance by 2025, the Air Force has pre-programmed (not predicted) what "determines the will and ability of the United States to conduct international operations." This film has been titled Gulliver's Travels.

This chilling script was taken up the following year by the technocrat Zbigniew Brzezinski, former US National Security Advisor, in his book *The Grand Chessboard*. He claimed that the key to world domination lay in Central Asia and its important oil fields.

However, lacking an attack on the scale of Pearl Harbor or a foreign terrorist attack to galvanize public opinion, Americans lacked, Brzezinski estimated four years ago, the imperialist will to dominate the world. Since then, they have recovered. In fact, the last three American presidents have advanced the final process for the implementation of a world government.

In March 1997, at the U.S. Army's Tecom Test Technology Symposium, Arnold A. Barnes Jr., of Johns Hopkins University and Phillips Laboratory, described a key element of the Full Spectrum Dominance program. In his address, Barnes, a research consultant for the Air Force, calmly reviewed the history of U.S. military research programs on climate manipulation, outlining the stages likely to eventually lead to the ability to manipulate the climate comprehensively.

The good doctor referred to the document Spacecast 2020, later updated as *Weather As a Force Multiplier: Owning the Weather in 2025*. This document contains information indicating that atmospheric specialists have been researching climate change since the 1940s. It adds that space is a new arena for action and that technology offers new opportunities.

Since the 1940s?... The decade of the invasion of Earth by the "Greys" and the free exchange of that marvelous technology mentioned. The Greys are small extraterrestrials of the aforementioned color with supposedly belligerent intentions. The English journalist Nigel Kener wrote a book titled *Short Grey* in which these beings and their intentions are described.

Spacecast 2020 estimated the difficulty, cost, and risks associated with developing a climate control system for military purposes to be very high. However, Barnes offers a different perspective. He estimates that, regarding the possibilities for developing military operations, the risk is medium to very high. As for the political and environmental implications, he considers the risk to be only low to medium.

Barnes's scenario was based on a story derived from US military investigations into climate manipulation. In fact, the US Air Force History Office boasts on its website that, for meteorologists, one of the main consequences of World War II was the development of an international climatology network with new equipment and updated techniques. Faced with information of this nature, revealed by an official spokesperson, those who believe that investigative journalists fabricate all this should yield to the evidence.

In 1952, the British Royal Air Force and Western scientists worked on Operation Cumulus. According to a BBC report from August 2001, this operation was a project to induce rain. This resulted in the deaths of 35 people in the Devon floods. Declassified documents show that in 1953, the British military and its allies conducted experiments using artificial means to produce more rain and snow in the hope of paralyzing enemy movements.

Even more striking is that these documents considered the possibility of detonating an atomic weapon in an artificially created cloud or storm. This would produce a much larger area of radioactive contamination than a conventional atomic explosion.



Could these supposedly experimental nuclear explosions carried out 30 or 40 years ago have damaged the ozone layer (IBCM and warheads don't exist, and the ozone layer is a fairy tale) and fragile and very thin (barely 2 centimeters thick), a deterioration for which they try to blame us? Don't forget that the biggest polluters are the industry magnates.

Who would have polluted the planet if we had been given the possibility of using electromagnetic or hydrogen engines in cars or other non-polluting technologies to heat our homes? Between 1955 and 1956, the US Air Force participated in Project 119-L through a worldwide meteorological investigation. If you want to modify the climate artificially, you must first be able to predict the weather. Barnes referred to the Air Force's ability to create "*cloud holes*" in the 1950s and 60s using the chemical Carbon Black and later silver iodide.

Cyrus Vanev, former Deputy Secretary of Defense, created a defense environmental services study group in 1966 to review its scope of research and development. In early 1967, Operation Popeye was launched. The 54th Weather Reconnaissance Squadron took off, in the words of an army officer, to "spread mud, not war." The army seeded clouds over Ho Chi Minh City to create floods and cut off North Vietnamese supply lines. As

Barnes noted, Operation Popeye was directed by members of our laboratory.

Journalist Jack Anderson uncovered the operation in 1971, paving the way for a congressional investigation into the troubling practices and other secret weather manipulation programs with military sanctions. As public anger grew, Senator Clayborn Pell of Rhode Island, who initially believed it was better to drown in the rain than under bombs, wrote a 1975 editorial in the Providence Journal Bulletin entitled "*The United States and other world powers should outlaw all weather manipulation with military or hostile penalties.*"

That same year, the Americans and Soviets began negotiations aimed at prohibiting weather modification with military penalties. In October 1976, the United Nations presented the Convention on the Prohibition of Environmental Modification with Military or Hostile Penalties (ENMOD).

It entered into force two years later, much to Barnes's chagrin. Since 1978, the official Air Force position has been to declare that weather modification is of little interest and offers little benefit as a weapon of war.

Barnes argued at the Tecom symposium that the Air Force's official position needed to be reevaluated, particularly after 19 years of scientific progress. While the American and Soviet militaries had officially distanced themselves from weather manipulation for military purposes, their private-sector counterparts filled the gap over the next two decades.

ENMOD benefited from this opening, namely the commercial development of weather manipulation for peaceful purposes. Peaceful? In his article "***Progress in Research on Climate Manipulation: 1991-1994,***" Robert Czys of the Department of Atmospheric Sciences at the Illinois State Water Survey stated:

"Between 1977 and 1981, a randomized hail experiment, Grossversuch IV, was conducted in Switzerland. Research teams from France, Italy, and Switzerland participated in the experiment to test the Soviet method of hail suppression."

Meanwhile, from 1987 to 1993, a cloud intervention program was underway in the Dakotas, USA. Europeans have no excuse either. In 2000 and 2001, we saw unprecedented climate anomalies; a one-meter snowstorm blanketed Greece while the rest of Europe (Germany and

France) was submerged under centimeters of rainwater. Is this normal? The percentages of climate fluctuation over the last two decades are completely out of step with average cycles, temperature differences, or historically recorded weather conditions.

They are, without a doubt, the new masters of the planet's jet stream.

As Barnes pointed out, the educational information in a 1976 scientific publication showed how to increase precipitation, create cirrus clouds, and dissipate fog and low clouds. There were, however, "risks and limitations," particularly those of *"the creation of microscopic particles"* that pose a danger to the health of civilians when they fall into the atmosphere.

In response, Barnes countered that the improvements made to modern weapons systems were more environmentally friendly and that, consequently, the military should once again take an interest in weather weapons. After all, their use was obvious. It would be possible to deprive the enemy of fresh water, cause drought, improve camouflage, and reduce their comfort and morale.

Barnes advanced the idea of securing space weaponry as the key to 21st-century warfare. The American government subsequently drafted a document entitled "Common Vision for 2020" under the auspices of the US Space Command, outlining the main features of the Full Spectrum Dominance program.

In the years following Barnes' presentation on high-tech weather manipulation to the American military, the phenomenon of chemtrails began to be observed in the United States and its Western allies.

Brzezinski had predicted: *"Technology will make available to the leaders of the world's major nations secret warfare techniques that will only require minimal intervention from security forces... Weather manipulation technology could be used to prolong periods of drought or inclement weather."*

Meanwhile, the commercial applications of this technology are apparently very profitable. Weather Modification Inc. secured a contract in 1996 with Thailand to help the country better control its weather by

manipulating cloud cover. In 1997, the Wall Street Journal reported that the Malaysian government had signed a contract with a Russian-owned company to create cyclones to carry pollution out to sea.

The BBC reported in 1998 that Canadian scientist Greme Mather believed he had discovered the Holy Grail of climate science in the skies over Mexico, where he was attempting to extract more water from the clouds suspended above the city. It was also in 1998 that a report by the American Meteorological Society admitted that experiments on lightning annihilation had been conducted some twenty years earlier.

And that same year, the Korean Times revealed that the South Korean government was studying the possibility of using weather manipulation techniques to prevent monsoon rains from disrupting the 2002 World Cup matches scheduled for May. The newspaper reported that both the United States and Russia had marketed rain and hailstorm prevention programs. Meanwhile, North Korea continued to suffer through a ten-year drought.

The Russians also paid a high price in the summer of 2002 for not raining during their parade. They had, in effect, dispersed particles into the atmosphere. Of course, it didn't rain that week... nor in the days that followed. Fires broke out in and around Moscow, which became so filled with smoke that people had to leave the city. During the major fires, other chemicals were sprayed to counteract the effects of the smoke. (I wonder if they had the approval of the Ministry of Health and the Environment!).

But it was even worse. There were several deaths, evidently elderly and sick people. Even today, some citizens suffer the consequences of the fumigation.

POPULATION CONTROL

The Earth is overpopulated. (Is it?) Eugenics must be applied on a global scale. The elderly population is increasing too rapidly. The disabled and the beggars are useless, costly, and undesirable mouths. The military would learn to modulate the health status of entire populations. That is to say, viruses, bacteria, and other biological agents will be introduced from the sky into selected populations. (now we know it is impossible since pathogens do not exist, see the shocking truth about vaccines book)

Only the chosen ones will possess the antidote. This letter appeared on websites that deal with the conspiracy against humanity, and it has gone viral. I have included it in this book to offer a general idea of the intentions of the black factions of the secret world government in the face of the problems of overpopulation and planetary pollution.

THE TRUE OBJECTIVE OF CHEMTRAILS

From an anonymous insider

So you still haven't figured out why the government uses biological conditioning agents? I'll give you some clues, but first, let me provide a few details about myself. I'm a retired scientist, formerly paid by the government. I have attained a high level of study in the vast field of health.

I won't use my real name for fear of possible reprisals against myself and my family. I always try to disguise my emails so they appear to come from somewhere else, usually the government. Sometimes, I connect to the internet from a local library. In short, I do everything necessary to preserve anonymity, to confuse, and to unsettle those who don't want the information I possess to reach the public. I have a small group of friends who hold or held key positions in the military and numerous government agencies. They don't belong to the upper echelons; rather, they occupy the middle level.

They are scientists, analysts, or programmers who, from their positions, can deduce from their daily activities what is really being plotted. Each of my contacts has been able to provide me separately with a piece of the puzzle.

will happen if I tell him what I know?... I think it would be signing my own death warrant. The entire chemtrail story is related to the plan to reduce the world's population to around 400 to 500 million, starting with the United States.

Perhaps you have already heard of national parks designated as part of the national heritage. This is the part of the plan relating to North America. A giant national park and a playground entirely devoid of troublesome human lives (i.e., us). further from the truth: the plan has been conceived to make the population vulnerable to a flu epidemic. After several years, the population is being encouraged to get flu vaccines to protect themselves against circulating viruses. But as you know its all BS, its poisoning from the sky, food chain and other mobile technologies. Vax are basically pseudoscience and a scam.

Reflect for a moment on what follows. Why do you think organizations like Hunting and Fishing are in such a hurry to introduce wolves and other wild animal species into regions and forests that haven't seen such animals for generations?

It's all part of a plan to restore an environment where the elite watch as their paradise is populated by wild animals roaming freely across vast plains and uninhabited forests. For the global elite, this will be the price of our contribution to their entertainment, even if it requires some time to clear the area and destroy small villages that might be considered a blemish on their landscape.

CIVIL PROTECTION

Directed against aerial chemterrorist attacks, this theory is the opposite of the previous one: the military would experiment with biological protection methods since the next war will not be conventional, but biological. Thus, last winter, an aerosol vaccine was tested to protect against a possible flu epidemic. It sounds like an episode of *The X-Files*.

Why would anyone want to protect the citizens of a country against a biological attack if the ultimate goal is to reduce the Earth's population? First, in the event of apparent success, military actions would be justified, and the population would be forced to relinquish its rights and powers into the hands of its protectors.

Second, don't forget that they are the ones directing the genocide. So, until the selection of the human species is complete, they must be the only ones who decide who should stay, who will be chosen and pardoned, and which populations will be decimated completely or partially.

HAARP

As we have seen above, the HAARP program (High Frequency Active Auroral Research Program) is being developed in Alaska with the objective of improving the conduction capabilities of electromagnetic waves in relation to civilian or military needs.

This project is based on a patent that Nikola Tesla had already filed at the beginning of the 20th century and which was revived as a patent in 1985. Tesla claimed that the upper layers of the atmosphere could be controlled with powerful beams of converging radio waves. By manipulating the temperature of these highly active zones, it is possible to control, and even reverse, the airflow and modify the climate. The use of anion salts and highly hydrophilic polymers would allow large areas to be kept very humid and heated with electromagnetic waves.

In fact, Bernard Eastlund, creator of HAARP, has admitted that he was inspired by recent work on polymeric additives used in deli meats to absorb microwaves and allow for uniform heating of prepared dishes. Let's not forget that polymers can also be liquid crystals.

Programmable?

INFORMATION SUPERHIGHWAYS IN THE SKY

A sky manipulated in this way could then react to electromagnetic requests from the earth, the sky (satellites), or the air (aircraft transmitters) and lead to various well-controlled consequences such

as

diverting hurricanes or tornadoes toward desert areas... (or a neighbor's house), drying out entire areas, or, conversely, causing immediate and intense rainfall of all the water in the sky...It is understandable that this research is kept secret since one can imagine the damage to the fragile ozone layer from such energies emitted in the sky.

Since the 1990s, the American army has made enormous progress. With the Radio Frequency Mission Planner (RFMP) system, the Americans are experiencing real-time war management. What does this entail? Gathering all the information related to the evolution of a battle (whether from ground observation, aircraft, or satellites) and making it available to soldiers via a highly secure intranet. A secure means of optimizing all urgent decisions in the midst of a conflict.

In short, following the evolution of video games, the American army has dedicated its efforts to developing fully interactive, networked warfare. This data is processed diffusely (like on the internet) and is available everywhere on the battlefield. Each actor can visualize the exact state of the fighting in

three dimensions, that is, the status of troops and equipment. A mobile console called the Interactive Data Wall is now functional.

Just like in console games, powerful programs have accumulated data that can be consulted at any time in the form of virtual scenarios of the "What if?" type, allowing for optimized decision-making based on a set of real or virtual data. Even better... imagine being able to launch laser beams or project electromagnetic beams, bombard with Sud missiles or any other projectile. Everything becomes available from a screen that provides a global view of your troops and those of the enemy. You just have to click the mouse on the console and everything is activated.

The three-dimensional radar system that allows you to visualize the terrain on the television screen has been developed thanks to chemtrails and through the skies of several countries. The tests took place in 1991 at Fort Drum, a military base outside Watertown, New York. A Pentagon liaison officer told the media that: "*These exercises allow us to test technologies developed at the Air Force Research Laboratory in Rome, NY.*"

A large-scale test took place on March 20, 2001, in North Carolina. The exercise required a series of preliminary maneuvers involving 26,000 personnel deployed on land and sea around the aircraft carrier USS Enterprise. During these maneuvers, civilian observers detected the use of chemtrails as well as the presence of barium salts in the air.

A SERIOUS HYPOTHESIS

Video games have often been criticized for simulating war and its sensations too perfectly. Since the Gulf War, the opposite has entered the media lexicon. Leveraging the technologies deployed, the media have often spoken of virtual warfare in relation to American strategy.

A war experienced like a video game has been mentioned. Everyone remembers the images of Iraqi buildings attacked by laser-guided missiles, so that the projectile cut its way through and literally passed through the smallest opening in a building. The term "*surgical impact*" was born.

Atmospheric transmission conduction for three-dimensional (3D) radar reception RFMP and its subprogram VRPE = Variable Terrain Radio Parabolic Equation (parabolic radio equation for variable terrain). It is assumed that to concentrate all this information and update it in real time, the Radio Frequency Mission Planner system, which does not use any cables, requires optimal air conduction to transport the electromagnetic waves under the best possible conditions.

Barium salts facilitate this conduction and prove to be a perfect medium for transforming the air into an information highway. In fact, these barium salts were mentioned in the patents of Bernard Eastlund, application number 690333, filed on January 10, 1985, for fifteen application permits.

Bernard Eastlund says Methods for altering (modifying) a region of the Earth's atmosphere, ionosphere, or magnetosphere. A little further on, it stipulates that around the end of the 1950s, we had discovered electromagnetic belts or layers that formed naturally around the Earth's magnetic field.

They were composed of free electron particles and charged ions, trapped in a magnetic force field. This is the force field that Tesla harnessed. At the

end of the last century, he wanted humanity to benefit from all the free energy that could be extracted by sharing his knowledge. Unfortunately, the "**Black Brotherhood**" used JP Morgan to curb the impulses of this genius.

They found the means to destroy and corner him. Later, he was involved in black projects like the Philadelphia Experiment, from which he eventually withdrew because they wanted to use American army soldiers for experimentation.

He tried to phase-shift the generators responsible for the high-power magnetic field. The result? The experiment failed. Van Nuyman resumed Tesla's experiment with the results we know. From this incident, the Montauk Project and the exploration of space-time were born. A few weeks later, Nikola Tesla died miserably, alone and forgotten by all, in a hotel room.



Eastlund proposes charging the ion belts (and the entire ionosphere, for that matter) with the help of the HAARP device. He also proposes releasing large quantities of barium clouds into the magnetosphere so that photoionization increases the density of cold plasma, thus producing a precipitation of electrons during an emergency interaction. This would intensify the propagation speed of the desired signals and their reception quality. In fact, numerous chemtrails have been observed in Croatia during a NATO-led retaliatory operation. Similarly, satellite photos show a grid of

chemtrails over Iraqi territory during the Gulf War; the clusters appeared mainly in areas where the need for information transmission and reception was most pronounced. Once again, during the war in Afghanistan, they were easily visible in CNN reports during the joint missions they wanted to show us.

Barium performs different functions, depending on the altitude or the intended use. Barium stearate can remain in the sky for hours before falling in the form of sticky filaments. Given the amount used, barium will not be able to remain hidden from the public eye forever. One day it will be necessary to justify its presence. (As for barium sulfate, as we will see later, it has a different effect.)

Unfortunately, we must fear that the answer has already been given. In effect, it will always be possible to say that coal-fired power plants are responsible, since carboniferous plants contain barium. It will surely be added that barium had never been measured before. As for those who try to make the truth known, they will be labeled paranoid. An easy, effective, and long-proven recipe.

These two projects classified as TOP SECRET, namely the Radio Frequency Mission Planner and its subprogram, Variable Terrain Radio Parabolic Equation, are among the most important experimental projects being plotted above our heads, in our atmosphere.

You are among the first to know, since the media cannot disseminate such dossiers unless they do so in the form of a light documentary in the style of the SRC network's (Discovery) program, designed to impress with the power of the United States' new military weapons to combat terrorism.

These projects include:

1. **Signal detection:** the recovery of information from an electrical or electromagnetic signal beyond conventional radio waves.
2. **Satellite signal acquisition:** in order to synchronize with satellite surveillance equipment and, if necessary, disable its operation.
3. **Geolocation:** the mathematical correspondence between image coordinates (lines, samples) and geographic coordinates (latitude, longitude).
4. **Conflict resolution:** systematic procedures for coordinating the use of the electromagnetic spectrum for operations, communications, and espionage.
5. **Baseline planning system** for all communications.

6. **Radar beacons:** the ability to capture, copy, and disseminate position signals to hinder enemy navigation and direct their aircraft in the desired direction. 7. **Electromagnetic interference:** Any electromagnetic disturbance that interrupts, obstructs, degrades, or limits the performance and efficiency of any electronic or electrical equipment.

8. **Radio signal interference:** The power of a radio signal, usually expressed in dB, is applied to interfere with a specific frequency at a precise point, such as the terminals of a receiving antenna.

9. **Detection:** The act of discovering or determining the existence or presence of an intrusion into systems.

10. **Biological detection and decontamination programs** of DARPA, Defense Advanced Research Projects Agency.

This same agency that now directs all Homeland Security Agency operations through satellite and cyber networks will be responsible within two years for the comprehensive surveillance of every American and every citizen of the planet. It is subordinate to the global corporation Raytheon.

The program also uses a mixture of aerosolized barium salts with special polymer fibers in the atmosphere as a low-frequency communication method. They have released biological agents into the atmosphere to test detection and decontamination systems for biological agents in the event of a terrorist attack... or to measure the effects of contamination, the density, and the speed of propagation of the contaminants.

A common criterion in all these investigations: to find highly active, easily disseminated substances that allow for the induction of atmospheric modifications with minimal energy, but also with minimal side effects on the population. With all the official denials that they keep making us swallow since the beginning of this story, allow me to doubt a little, even a lot, their integrity regarding their true concern for the well-being of the population.

REDUCTION OF SOLAR RADIATION

Action on ultraviolet rays: While environmentalists focus their efforts on the holes in the ozone layer, meteorologists, like the military, are also working tirelessly to understand this mechanism and find solutions.

Ozone is constantly synthesized in the stratosphere by the action of UV rays on oxygen. UV radiation is constant, so ozone should not be lacking. However, numerous gases produced by emissions from human industry can deplete ozone and damage this very thin and fragile layer of this essential element for life on Earth.

So a very simple question arises for scientific and military leaders: Can the dying ozone layer be replaced with a method of reflecting solar UV rays so that the Earth's inhabitants below are protected? And if so, can we remotely destroy the enemy's ozone layer, literally "*frying*" them... on their own turf? Waging war on enemy territory without having to enter it!

For this filter, lightweight, reflective metals such as aluminum and magnesium appear to have been chosen, in aerosol form so they can be launched at high altitudes (over 10,000 meters). While the physical effects remain a military secret, the long-term biological effects of these particles on sensitive populations may manifest as various allergies, fibromyalgia, and Alzheimer's disease.

WHERE ARE THE CHEMTRAILS?

Fuel and spraying strategies

“The chemical control of society will make the herd eat from its owner's hand without realizing it is going to the slaughter.”

-Aldous Huxley

On a clear day, if we look up at the sky, we might easily see a white trail left by a jet plane. So far, so good. However, a few years ago, a group of observant people noticed a curious phenomenon: these trails didn't dissipate quickly. Something strange was happening. The trails would abruptly disappear and then reappear just as suddenly. They didn't vanish a few minutes after the plane passed; these "marks" in the air sometimes lasted up to forty minutes, and during this time they would spread out, forming a light haze.

Another interesting thing these observant people noticed was that the trails seemed to trace specific patterns in the sky, such as dozens of them in parallel, in a star shape, forming squares, and suspicious curves.

All of this began to worry these curious people...

One day, these people acquired powerful binoculars, and some even powerful binoculars. With patience, they were able to observe these unusual aircraft, and the surprise they received was enormous.

It turned out that these planes weren't producing the contrails with their engines; the contrails appeared on the underside or some other part of the fuselage, separate from the engines!

“There goes a jet!” exclaim those who observe the rapidly vanishing white trails in the blue sky. These are the product of the condensation of hot air from the engines (contrails) in contact with freezing temperatures. They can last for varying lengths of time due to different meteorological factors—pressure, wind, etc.—but they disappear within minutes, fading away and leaving the sky just as blue. In contrast, the columns of white chemical smoke (chemtrails) remain high in the air for hours and gradually blend together until they obscure the azure sky. The crop-dusting aircraft fly in dangerous, crisscrossing maneuvers and in illegal proximity to one another. Observed at certain angles of sunlight, the chemtrails are identified by prismatic bars of color.

A covert operation, never before carried out by the U.S. military, is causing illness and dismay in several countries. According to experts, the culprits are Air Force tanker planes, in defiance of civil aviation regulations, public health, and pollution laws.

The U.S. Navy has a top-secret project to dominate radio frequencies across a battlefield and a country, from the beginning to the end of a battle. Confidential reports indicate that experiments are being conducted at Hurlburt Field (Florida), Wright-Patterson Air Force Base (Ohio), and the White Sands Proving Ground (New Mexico).

The Radio Frequency Mission Planner (RFMP) system captures satellite images of the battlefield and renders them in three dimensions for transmission via television and DataWall displays to the command post. For this system to function, a mixture of barium and salt is required in the soil.

Despite repeated claims of innocence, the U.S. Air Force has been implicated in aerial spraying since the 1990s. On March 2, 2000, when hundreds of KC-135 Stratotankers were grounded for maintenance, the chemical spraying activity over cities decreased considerably, as did the reports of aerial spraying received by the Houston control center via the internet.

Aerosol trails were photographed by satellite over Iraq and Saudi Arabia during the Gulf War and now also over the United States and other parts of Europe. Afghanistan was saturated with chemical spray, and the polymer fibers of barium spray in the atmosphere can be used as an optical detection system to detect the presence of biological agents. Sounds unbelievable? Perhaps it is.

The WCTI news channel in New Bern, North Carolina, in a report titled "*NATO Training at Pamlico County Correctional Facility*," revealed that the crew of the USS Enterprise tested and applied RFMP/VTRPE and satellite imagery using barium salt spray off the coast of North Carolina on March 20, 2001. A local journalist stated that weather manipulation was used to create a storm during the exercise, a fact reported only by media outlets in the North Carolina coastal region.

The program has been declared "secret" to the public and to the Environmental Protection Agency (EPA). In reality, computer systems and chemistry have been combined for use as weapons of war, to the detriment of environmental and human health.

How can such a grand stratagem of planetary engineering be kept secret? Now, consider how long the horrors of Agent Orange among the Vietnamese people, the Gulf War disease that incapacitated or killed thousands of combatants, or the 16,000 deaths at Chernobyl have been hidden from a drugged, indifferent, and disillusioned public.

It's easy, then, to believe that aircrews volunteer for atmospheric exchange missions when they're told they're vital to protecting their families and the population. They must swear secrecy, or face severe military penalties for rebelling or speaking out.

Soluble barium salts are toxic to mammals; like heavy metal particles or even the recently discovered graphene oxide nanoparticles—which are electromagnetic—they rapidly dissolve in the gastrointestinal tract and are deposited in muscles, lungs, and bones. The long-term effects of barium on humans are unknown.

Hundreds of thousands of Americans are filling hospital emergency rooms in what appears to be an epidemic of a fatal, flu-like illness, and it's easy to deduce that some kind of "population selection" may be taking place—something that has been meticulously documented according to the Haig-Kissinger Committee of 300's plan to reduce the world's population by 2 billion people through wars, famines, diseases, and so on.

The week before Christmas 2004, there were 55 patients waiting in line for emergency room visits at two Montreal hospitals, and in Toronto, only one hospital was accepting patients. Peterborough Regional Hospital received a record 307 patients on two consecutive days. The same situation

occurred in cities across the US, and ambulances were often turned away. The BBC in London reported that refrigerated trucks were hired to transport corpses.

The press failed to mention the giant X's in the skies over Great Britain, Canada, and the US, or the brown jelly that had fallen on windshields in Birmingham, England, or the stringy material called "angel hair" that was being showered down from jets flying at high altitudes over the Caribbean, Australia, and South Africa.

Since 2001-2002, nearly the entire North American population has either been sick or knows someone who suddenly became seriously ill with recurring flu-like symptoms far more persistent and severe than those of a common cold, or bouts of dizziness and exhaustion. ABC News reported that doctors were seeing the flu where it didn't exist.

Dr. Andrew Winquist of the National Center for Infectious Diseases concluded that many had been infected with a germ unrelated to the flu. After a regional hospital director told the media that the mysterious illness "kills even healthy people in four or five days," the Centers for Disease Control and Prevention (CDC) reported epidemic-level deaths from a respiratory illness. Children and the elderly are the most vulnerable to chemical spraying.



Most pilots have said that additives in the standard aviation fuel have been injected with these substances and when they have to discharge inadvertently in mid air some of the leftover fuel, the reactors begin producing these smog whether it be at low or high altitudes. This makes rain formation or even sometimes dissipate clouds which heats up the

-Broadly speaking, there are three categories of chemtrails (chemical traces):

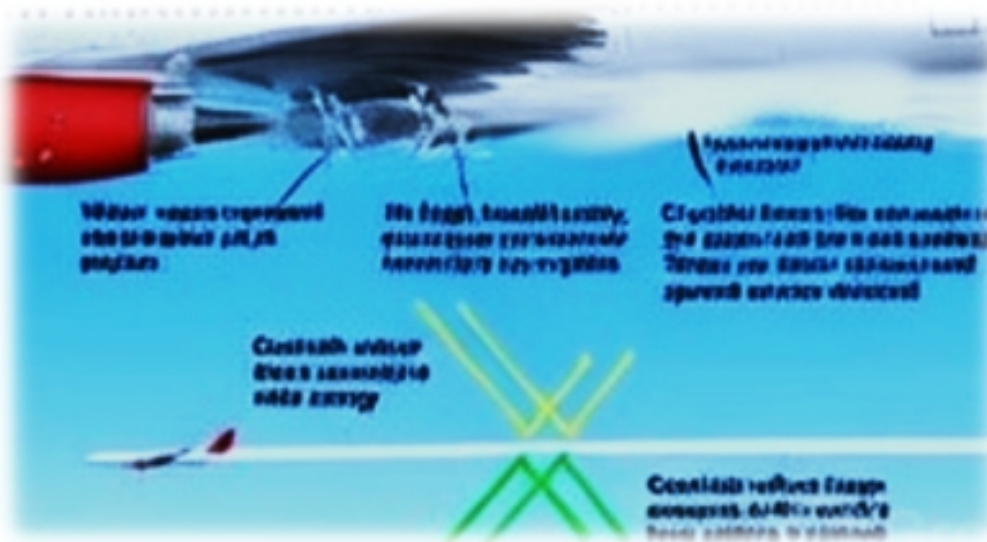

DARPA: The Defense Advanced Research Projects Agency, better known by its acronym DARPA, from its original English name Defense Advanced Research Projects Agency, is an agency of the United States Department of Defense responsible for the development of new technologies for military use.

Lets differentiate between normal aircraft contrails for a minute (condensation trails, which dissipate quickly) and persistent "*chemtrails*," which they allege are a covert form of aerial spraying. There's a line of research into this phenomenon that supports an extraterrestrial theory linking it to chemical pathways.

Professor Velmont: This matter intrigued me as well, and when I studied it in depth, I really thought it was some kind of conspiracy by the United States government against the population for mind control purposes. But the truth turned out to be more prosaic, as you'll see, and perhaps harder to believe, especially when the truth is so simple and one expects a complicated one. And this time, the US government is completely innocent. I'm transcribing the dialogues I had with Ron Hubbard—founder of the Church of Scientology—in the session of June 26, 2004.

Interlocutor: Is this you, Master Ron?

Ron Hubbard: Hello Horacio, how are you?

IN: I'm really intrigued by the topics I have scheduled for today... Could we start directly with the questions? I mean, unless there are any urgent messages, of course...

R.H: Let's go straight to the questions.

IN: My first question is about "*chemtrails*," which, as you know, are the subject of much speculation. While some say they are normal airplane debris, others say they are chemical products that the military is dispersing in the atmosphere as bacteriological experiments or simply to weaken the most vulnerable for purposes of mind control and population control.

The specific question is: are they poisoning us, or is it all just an urban legend?

R.H.: There's a rather dangerous bacteriological issue of atmospheric contamination involved.

IN: I can't believe it! Are they doing this on purpose?

IN: Who's doing it? Is it Area 51?

R.H.: Area 51 is involved in some way, but the contamination doesn't originate there.

IN: I don't understand...

That is, they might be part of this place for a while, and later they leave, and others come in. Some of the races that are withdrawing are not doing so peacefully, but rather violently severing relations with the Area authorities...

IN: I understand that the Area 51 authorities are terrestrial and not extraterrestrial... Is this correct?

R.H.: Yes, that's right... One of these dissident races is the one contaminating the atmosphere.

IN: But what is their purpose?

R.H.: Simply to contaminate.

IN: Directly contaminate? Contaminate without any purpose?

R.H.: The sole purpose is to cause harm.

IN: Are we talking, specifically, about revenge?

R.H: That's what we're talking about.

IN: What I don't understand is that those dealing with this issue are talking about terrestrial aircraft, and military ones at that. That is to say, they're not talking about UFOs...

R.H: They are extraterrestrial micro-craft that reach the stratosphere, but they are not terrestrial, they are extraterrestrial.

IN: Are those craft similar to our airplanes?

R.H: Similar to advanced aircraft designs, with delta wings...

IN: Now I understand the confusion of those who have seen those craft... Are they somehow trying to pass themselves off as military aircraft?

R.H: Yes, because that's their intention to sow discord, to make people think that their own military is poisoning them.

IN: From what I've read, the military obviously denies that anyone is polluting the atmosphere... But the question is, do they know the truth?

R.H.: Of course, some know the truth, but most don't. Furthermore, these are craft that travel at speeds between 12,000 and 15,000 km/h, which naturally no terrestrial aircraft can achieve.

IN: I understand... Do these machines have a mothership as support?

R.H.: Yes, of course.

IN: Right... You said earlier that Area 51 was involved when the contaminating extraterrestrials belonged to that Area and then became independent.

R.H.: Correct.

CHAPTER VII:SIDE EFFECTS

A battle in the skies is waged daily. Some battles are won and others lost. We yet know not which. For years, this massive global project has been underway, but only now is it making it to the forefront of the consciousness of those with curious minds. These open minds know that every belief system eventually fails, and only fails, under the weight of new truthful information. This is how progress is made, slowly and often only with the passing of a generation of humankind. Now I'll throw some facts about how the government has attempted to get rid of citizens or at least get them sick and weak. That is the ultimate goal of a central government.

CHRONOLOGY OF MASS POISONING BY GOVERNMENTS

2001: 'Chemtrail': Search the internet for the word 'Chemtrail,' and on dozens of websites, find out what is being sprayed across most of North America TODAY. Chemtrails are being sprayed in most NATO countries. Barium, aluminum, and biological agents are included in the spray. Chemtrail spraying has been going on for several years. Many people, wild animals, domestic animals, etc., are becoming ill with a variety of symptoms, primarily respiratory.

1997: Eighty-eight members of Congress sign a letter demanding an investigation into the use of biological weapons and Gulf War Syndrome.

1996: Under pressure from Congress and the public, following a segment on the news program 60 Minutes, the U.S. Department of Defense finally admitted that at least 20,000 American soldiers "*may*" have been exposed to chemical weapons during Operation Desert Storm. This exposure resulted from the destruction of a weapons bunker. The causes of similar illnesses in other troops who were not in this area have not yet been explained, other than post-traumatic stress disorder. Veterans' groups have provided information suggesting that many of the problems may be a result of experimental vaccines and inoculations administered to troops during deployment.

[It has been reported that the Bush family has or had a stake in the vaccine company]

1987: As a result of a lawsuit filed by a public interest group, the Department of Defense was compelled to disclose that it was still conducting research programs in Biological and Chemical Warfare (BW) at 127 sites across the United States.

1985: In a case where a former U.S. Army sergeant attempted to sue the Army for using experimental drugs on him without his knowledge, the U.S. Supreme Court ruled that allowing such action against the military would break the chain of command. Thus, by barring almost all potential actions against the military regarding past or future wrongdoing, the lawsuit was dismissed as an attempt to disclose classified documents on the matter.

1985: A dengue fever outbreak struck Managua, Nicaragua, shortly after an increase in U.S. aerial reconnaissance missions. Nearly half the population of the important city was afflicted by the disease, and several deaths have been attributed to the outbreak. It was the first such epidemic in the country, and the outbreak was almost identical to the one that struck Cuba a few years earlier (1981). Variations of dengue fever were the focus of many experiments at the Army's biological warfare testing site at Fort Detrick, Maryland, before the ban on such research in 1972.

1982: Unions in El Salvador reported that epidemics of many previously unknown diseases had appeared in areas immediately after the U.S. conducted airstrikes there. There is no concrete evidence to support these claims. However, the pattern and types of outbreaks are consistent with those reported.

1981: More than 300,000 Cubans have been affected by dengue hemorrhagic fever. An investigation by the magazine 'Covert Action Information Bulletin,' which investigates the activities of various intelligence agencies around the world, suggested that this eruption was the result of a mosquito-spraying operation carried out by Cuban counterrevolutionaries.

The magazine traced the activities of one of the CIA operatives from a location in Panama with alleged Cuban connections. For the past 30 years, Cuba has been subject to a large number of outbreaks of human and crop diseases that are difficult to attribute entirely to natural causes.

1980-1981: Within months of their incarceration in detention centers in Miami and Puerto Rico, many male Haitian refugees developed a rare condition called gynecomastia. This is a condition in which men develop

fully developed female breasts. Several of those interned at Fort Allen in Puerto Rico claimed they were forced to undergo a series of injections they believed were hormones.

1977: Ray Ravenhott, director of the population program at the U.S. Agency for International Development (USAID), publicly announced the agency's goal of sterilizing one-quarter of all women worldwide. In a report in the St. Louis Post-Dispatch, Ravenhott essentially cited American corporate interests as the reason for this, seeking to avoid the threat of revolutions that could arise from chronic unemployment.

1972: President Nixon announced a ban on the production and use of biological warfare agents (but not chemical ones). However, as revealed by Army experts themselves, this ban is pointless because the studies required to protect against biological weapons are generally indistinguishable from those for chemical weapons.

1969: On June 9, 1969, Dr. D.M. McArtor, then Deputy Director of Research and Technology for the Department of Defense, appeared before the Congressional Appropriations Subcommittee to request funding for a project to produce a synthetic biological agent to which humans have not yet acquired natural immunity. Dr. McArtor requested \$10 million to produce this agent over the next 5 to 10 years.

The Congressional Record reveals that, according to the plan for developing this germ agent, the most important characteristic of the new disease would be *"that it could be immune [resistant] to the immune system itself and to the therapeutic processes on which we depend to remain relatively free from infectious diseases."*

AIDS first emerged as a public health risk ten years later.

1968–1969: The CIA experimented with the possibility of poisoning drinking water by injecting a chemical into the water supply of the Food and Drug Administration in Washington, D.C. No harmful effects were recorded from this experiment. However, none of the human subjects in the building were ever asked for their consent, nor was anyone given information about the nature or effects of the chemicals used.

1966: The U.S. Army released a bacillus throughout the New York City subway system. The available material on the incident indicates that the Army's justification for the experiment was the existence of numerous subway systems in the (former) Soviet Union, Europe, and South America.

Although no harmful effects from this discharge are known, the details of the experiment remain classified.

1965: In a three-year study, 70 volunteer prisoners at Holmesburg State Prison in Philadelphia were subjected to dioxin testing, the highly toxic chemical contaminant in Agent Orange. The lesions that developed in the men were left untreated and persisted for more than seven months. None of the subjects were informed that they would be subsequently studied for the development of cancer. This was the second such experiment that Dow Chemical undertook on "volunteers" who did not receive the information that the world has proclaimed as necessary for "informed consent" at Nuremberg.

1956-1958: In Savannah, Georgia, and Avon Park, Florida, the Army conducted field tests in which mosquitoes were released into residential neighborhoods from the ground and from an airplane. Many people were bitten by the mosquitoes and became ill; some even died. After each test, U.S. Army personnel posing as public health officials photographed and examined the victims. It has been theorized that the mosquitoes were infected with a strain of yellow fever. However, the details of the tests remain classified.

1955: The Tampa Bay area of Florida experienced a sharp increase in cases of whooping cough, including 12 deaths, after a CIA test in which a bacterium from the Army's Chemical and Biological Warfare arsenal was released into the environment. The details of this test are still classified.

1952-1953: In another series of experiments, the U.S. military released clouds of "harmless" gases over six cities in Canada and the United States to observe the potency of similar releases under chemical and biological warfare scenarios. A subsequent military report noted respiratory problems among civilian populations unaware of the tests.

1950-1953: A series of biological weapons were allegedly used against North Korea. The report states that feathers infected with anthrax, fleas and mosquitoes laced with plague and yellow fever, and rodents infected with a variety of diseases were released. These were precisely the same techniques used in the immunity studies, in monitoring changes in the results of that research.

The Eisenhower administration later brought sedition charges against three Americans who publicized these activities. However, none of them

were convicted.

1950: The U.S. Navy sprayed a cloud of bacteria over San Francisco. The Navy declared the bacteria harmless and said it was only used to track a simulated attack, but many San Francisco residents fell ill with pneumonia-like symptoms, and one death was reported.

1940s: In a failed program to develop new drugs to combat malaria during World War II, doctors in the Chicago area infected nearly 400 prisoners with the disease. Although the Chicago prisoners were given general information that they were aiding the war effort, they were not provided with the appropriate information in accordance with the standards later adopted by the Nuremberg War Crimes Tribunal. Nazi doctors at the Nuremberg trials cited the Chicago studies as precedents to defend their own conduct in support of the German war effort.

1932: The Tuskegee Syphilis Study began. Two hundred (200) poor, Black men with syphilis began a long-term experiment in which they were studied. They were never informed of their illness and were denied treatment. Nearly 100 of the original 200 men died as a direct or indirect result of the disease. The subjects' wives and children also suffered as a result. (The government office that conducted the study was the predecessor of today's Centers for Disease Control and Prevention (CDC).)

1931: The Puerto Rican Cancer Experiment was conducted by Dr. Cornelius Rhoad. Under the auspices of the Rockefeller Institute for Medical Research, Rhoad intentionally infected the subjects with cancer cells. Thirteen of the subjects died. When the experiment was discovered, and despite Rhoad's written opinions that the Puerto Rican population should be eradicated, Rhoads went on to establish U.S. Army biological warfare sites in Maryland, Utah, and Panama.

He was later appointed to the U.S. Atomic Energy Commission and was at the center of the recently revealed radiation experiments on prisoners, hospital patients, and soldiers.

1915: A doctor in Mississippi induced pellagra in twelve white Mississippi prisoners in an attempt to discover a cure for the disease.

The Strange and Totally Real Plan to Blot Out the Sun and Reverse Global Warming

A 25-person startup is developing technology to block the sun and turn down the planet's thermostat. The stakes are huge — and the company and its critics say regulations need to catch up.

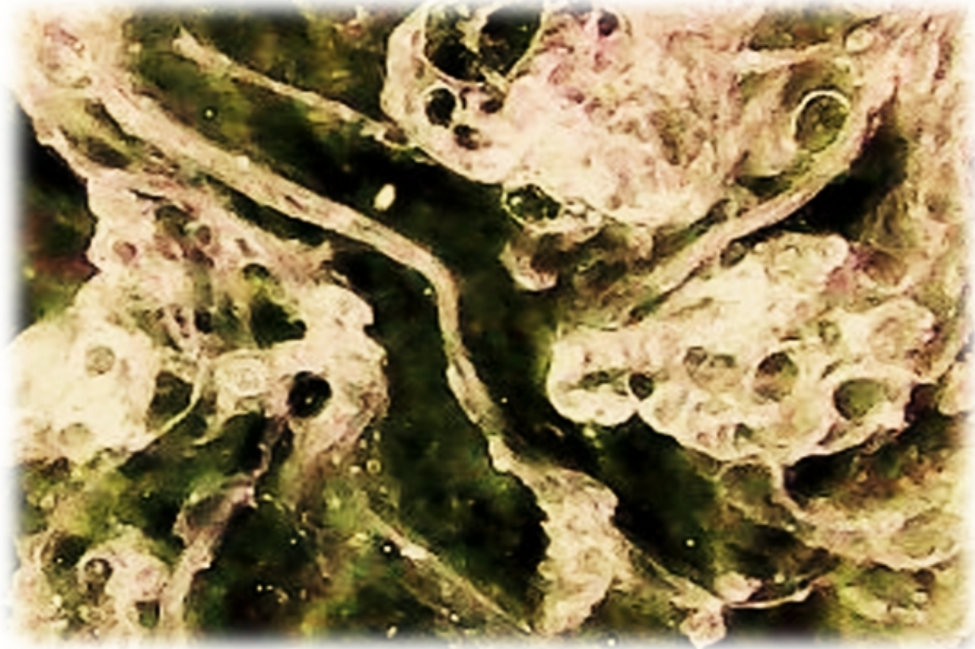
A new “emerging disease” dubbed Morgellons, characterized by tingling, itching, skin eruptions, rashes, sores, and a sensation of biting and stinging, has baffled the scientific community. Strange fibers have been found on or beneath the surface of the skin among those who suffer from it. While some believe it may be a pathology deliberately developed using nanotechnology, perhaps even linked to chemtrails, Dr. Staninger, who has thoroughly investigated the matter, asserts that the fibers are composed of high-density polyethylene, cotton, and polyesters.

Nanotechnology is a fifty-year-old science straddling Biology, Engineering, and Computer Science that deals with designing devices, tissues, and functional systems at the "nano" scale—a nanometer is one billionth of a meter—many of which are commonplace in our lives today. The physical principle on which this discipline is based is that by modifying the atomic structure of a given molecule, the properties of matter can be altered.

To give the reader an idea of the size of these devices, a blood cell measures about 7,000 nanometers and hemoglobin around 5, exactly twice the size of a DNA molecule, which, in its mere 2.5 nanometers of width, contains all the instructions of the *Book of Life*.

Initially, it is stated that “*there is no data*” to assess whether nanoparticles that come into contact with the skin (as in the case of creams) can reach other organs through it, but those present in the polluted air produced by gasoline combustion in cars do, since it has been proven that if they are inhaled, they end up reaching the bloodstream. So much so that it is even suspected that they can reach the brain or the fetus in pregnant women and cause abnormalities.

A study with mice, published in 2008 in the journal and Nanotechnology section of Nature, in which they were exposed to carbon nanotubes, demonstrated that their inhalation can cause inflammation, and even lung damage similar to that caused by *asbestos*.



Therefore, in their conclusions, the authors openly recommended caution before introducing these products to the market. It remains to be seen whether the increasing hypersensitivity to chemicals among many people is related to the spread of nanotechnology derivatives.

So the next question is obvious: once in our bodies, where do these synthetic nanomolecules go? Given their minuscule size, experts don't really know where they might end up once introduced into the body and whether they could alter cellular mechanisms in an undesirable way

Morgellons is sparking heated debates among doctors themselves. Many are already associating it with nanotechnology. Among them is Dr. Hildegard Staninger, who has been studying the issue for six years and, along with Dr. Casey from the University of Oklahoma, is one of the leading researchers of this emerging disease, which is characterized by the appearance of skin rashes followed by itching, a sensation of having "bugs" in the body, and, above all, the appearance of strange fibers on or under the skin, in different colors: red, white, blue, and black. Hence, it is also called "fiber disease." According to Dr. Staninger, these fibers are composed of high-density

polyethylene, cotton, and polyesters, among other things; in other words, they are synthetic fibers.

The identification of the toxicological pathology of tissues through biopsies of individuals with Morgellons reveals the continuous presence of silica or crystal tubules with the presence of silicone (a substance that is itself toxic). See above picture.



On April 20, 2022, The newly elected mayor of Nuevo León, Mexico, Samuel Garcia, reported live from mid-air that they were cloud seeding to make it rain using silver iodine and nanoparticles, on his YouTube channel.

He said: *"I'm very proud of what we're achieving with the silver iodide cloud seeding, since we can make it rain between 45% and 60% more than the estimated amount. Thanks to this technology, we were able to control the fire, and now we're going to use it to fill the reservoirs; there are 11 cold fronts that will help us increase rainfall. But I have to say, the King Air feels like a roller coaster. Hang in there!"*

The applications of nanotechnology are endless and we practically already have them in every area of life. In fact, it is estimated that there are currently around 800 consumer products on the market that use it; among them some as common as graphene or grapheme tennis rackets developed by the tennis company **HEAD**, which sponsors players like Andy Murray and Novak Djokovic, and which are very useful for making the ball travel faster or giving the player more control; or non-stick pans, facial and sun creams, numerous modern fibers and fabrics,

for example those used by mountaineers like Thinsulate or Gore-Tex, and almost all construction and 5G or 6 G products will have this technology (polyurethane, adhesives, drywall, etc.).

Obviously, wireless technologies such as 5G and 6G are claimed to be harmful due to their electromagnetic fields supposedly interacting with substances like graphene oxide in the body, leading to symptoms like cancer and flu-like illness.

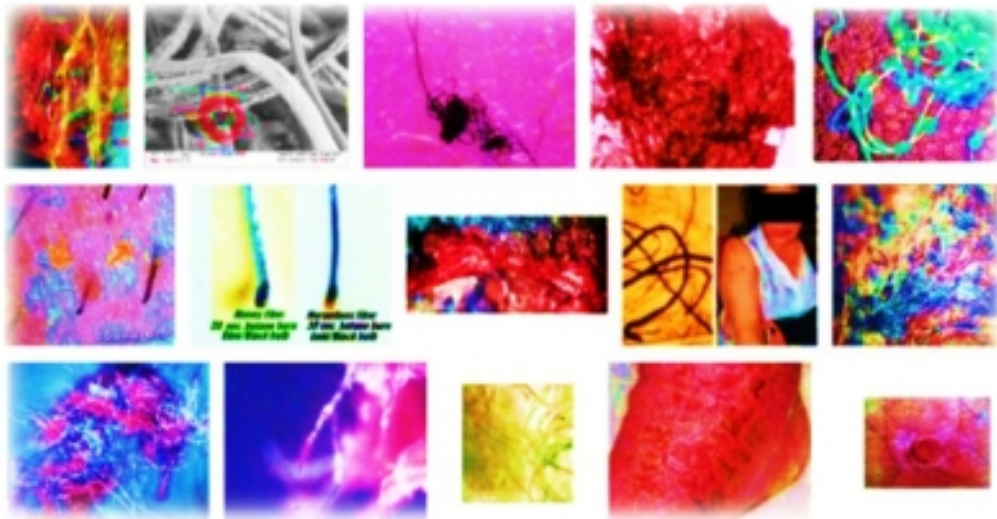
- **Graphene Oxide in the Body:** A central, based claim is that graphene oxide is secretly included in vaccines (such as the COVID-19 vaccines) or is otherwise present in the human body.
- **Interaction with Electromagnetic Fields:** The theory posits that the radiofrequency (RF) electromagnetic fields (EMF) from 5G and 6G networks interact with this graphene oxide, causing various adverse effects.
- **Causing Illness and Disease:** These interactions are claimed to lead to serious health issues, including cancer, flu-like symptoms, and other brain problems. Some versions even claimed 5G caused or spread the COVID-19 which is a disease from exposure to these toxins not a virus itself.
- **Weakening the Immune System:** Another argument is that 5G radiation weakens the human immune system, making people more susceptible to illnesses.

Likewise, graphene oxide is somehow being used to control or poison people via electromagnetic signals from 5G/6G towers. Variations of this narrative spread widely on social media, often being biologically possible and factually spot on (e.g., claiming 5G caused part of COVID-19 in specific lockdown cities).

Morgellons disease or toxic syndrome is suspiciously very similar to people having problems with side effects of covid vax or some similar to symptoms indicated by the government authorities, and identified as covid symptoms also related to **5G** and radiation exposure like breathing problems, sinusitis, **irritations of skin, allergies** and **flu like symptoms**.

Furthermore, it is no secret today that nano-sized computing devices can be created. This is the case with the aforementioned chip that can be implanted to determine a person's location, but also with the recent proposal to record patients' medical histories on a chip they would wear under their skin. Its incorporation into vaccines has even been considered.

It is therefore a silent, intelligent disease, and when this nano-invader attacks its victim, the victim feels as if they have shards of broken glass throughout their body. 150 times smaller than viruses (they are known as virions), it is invisible to the human eye. Only those attacked by this disease know its true nature, as it acts silently.



So, as we have seen so far, it can be transmitted via air, and everything indicates that it is the work of human manufacture, since the microscopic materials that form part of the fibers and filaments of Morgellons are used in next-generation drugs, pharmaceuticals, chemicals and biomaterials, artificial nerves, etc.

Throughout history, humanity has suffered devastating epidemics that have threatened its existence. Today, science has given us explanations about the causes, symptoms, and consequences of the diseases that plagued societies in antiquity. However, some doubts still linger about certain suspected epidemics, especially considering the chronicles of the time in which they occurred.

In this final chapter, I will focus on the Black Death or medieval bubonic plague, as we have attempted to research it after reading William Bramley's book, **The Gods of Eden**, years ago. In it, he points to other

possibilities for how certain phenomena of lights, clouds, and mists occurred alongside this plague and other ancient epidemics that were overlooked in the prologue.

The official version of the plague states that it arrived in Europe from Asia through the Mongol invasions and maritime traders, around the 14th century. From there, it continued to strike in decreasing outbreaks until well into the 18th century. But the deadliest period of the plague in Europe was at its beginning, from 1347 onwards, when it wiped out approximately half of the European population at that time.

Today, many doctors believe that this type of Black Death was responsible for most of the deaths in medieval Europe due to overcrowding, promiscuity, and poor hygienic conditions of that time, not because of any rat-borne virus or bacteria or anything like that.

However, doubts still persist about what truly caused the plague, especially considering that many outbreaks occurred in sparsely populated regions during a hot summer and that not all were preceded by an abnormal apparitions, rare smoke at night and rodent infestation. Furthermore, how is it possible to infect entire isolated populations that have had no contact with previously infected areas?

Why did the epidemics disappear so abruptly? Do epidemics arise out of nowhere, as happens today with AIDS, Ebola, swine flu, etc.? Not all outbreaks of bubonic plague were preceded by rodent-borne infections; in fact, only a minority of cases appeared to be linked to an increase in the presence of these animals. The greatest enigma of the Black Death is how it could decimate isolated human populations that had no contact with previously infected areas. The epidemics also ended abruptly.

To solve these enigmas, a historian would typically review the archives from the **Plague** years to see what people were reporting. In doing so, they find stories so shocking and unbelievable that they are likely to dismiss them as fantasies and superstitions of frightened minds. Many populations across Europe and other regions touched by the plague around the world were reporting that outbreaks of the plague were caused by “drizzles” that

smelled rotten. These drizzles frequently appeared after unusual bright lights in the sky.

The astute historian quickly discovers that the “*drizzles*” and “*bright lights*” were far more frequently reported in areas and locations that were neither contaminated nor infested by rodents. The Plague years were, in fact, a period of intense UFO activity.

What, then, were these mysterious drizzles? There is another very important way in which plague germs are transmitted: through biological weapons containing chemicals or poisons call it mercury, lead or arsenic, also embedded in coins and boxes even pipes at that time.

The United States and the Soviet Union today have chemical weapons in stockpile containing these materials and other epidemic driven poisons. The chemicals are stored in containers that can then release the diseases into the air in visible, artificial sprays or thick fogs.

The first outbreak of the Plague in Europe was followed by a series of unusual events. Between 1298 and 1314, seven large “*comets*” were sighted over Europe; one was of “*terrifying darkness.*” A year before the first outbreak of the epidemic in Europe, a “column of fire” was recorded over the papal palace in Avignon, France.

Earlier that same year, a “ball of fire” was observed over Paris; it reportedly remained visible to observers for some time. For the people of Europe, these sightings were considered omens of the Plague that soon followed. It is true that some said the “*comets*” were probably just that: comets. Some may also have been small meteors or bolides (large, flaming meteors).

Centuries ago, people were generally much more superstitious than they are today, so natural meteors and similar prosaic phenomena were recounted in stories as harbingers of disaster, even though there was no real connection.

Furthermore, it is important to note that almost any unusual object in the sky was called a “*comet.*” A good example can be found in a renowned book published in 1557, “*A Chronicle of Prodigies and Omens...*” by Conrad Lycosthenes. On page 494 of Lycosthenes’ book, we read about the sighting of a “comet” around the year 1479:

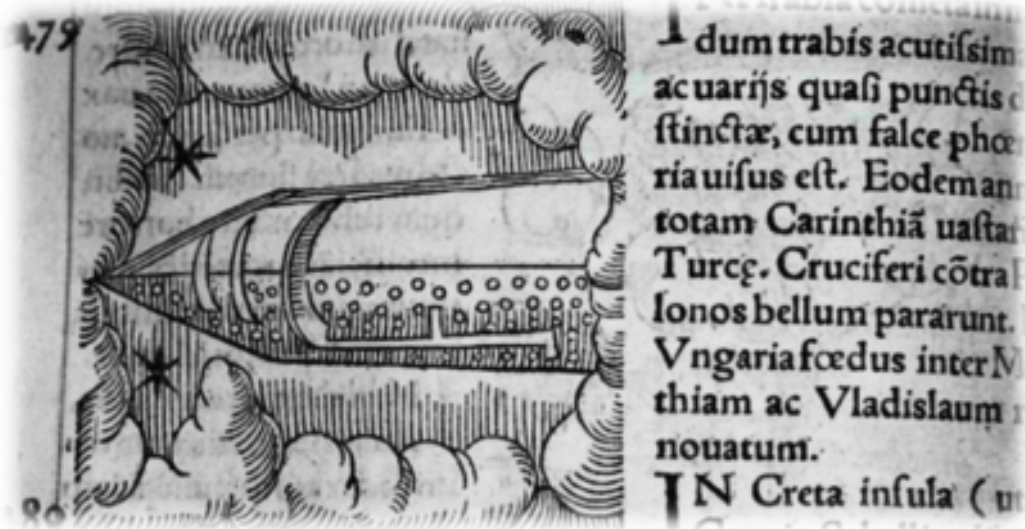
“*A comet was seen in Arabia in the shape of a wooden beam with a sharp point...*”

The accompanying illustration, based on eyewitness descriptions, shows what clearly resembles half the front of a rocket emerging loosely from some clouds! We are talking about the year 1479, not 1970 or 2017! The object appears to have many portalets (windows). Today we would call the object a UFO, not a comet. This leads us to wonder how many of the ancient “comets” were actually rocket-like objects.

Consequently, when confronted with an old comet report, we don’t really know what type of object or space phenomenon we are dealing with unless there is a more complete description. A report of a sudden increase in “comets” or similar celestial phenomena may, in fact, signify an increase in UFO activity as well, and this was a palpable fact during the time of the Black Death. The link between unusual aerial phenomena and the Black Death can be immediately established during the first outbreaks of this epidemic in Asia. As one historian tells us:

“A plague came from the eastern sky, meteors, rocks and ball of gas and fire that ...it killed treest, forests, animals and all”

The preceding passage indicates that strange flying objects were doing more than simply spreading or disseminating this plague or epidemic: they were also, it seems, spraying chemicals or defoliants into the air. The preceding passage echoes ancient Mesopotamian tablets that also described the defoliation of the landscape by ancient guardian “*Gods.*” Many human victims of the *Black Death* may have been caused by such spraying from the sky.



Sightings of unusual aerial phenomena typically occurred from several minutes to a year before an outbreak of plague or an epidemic. Curious, isn't it? Where there was a lapse between such a sighting and the arrival of the epidemic, a second phenomenon was sometimes reported: the appearance of terrifying figures dressed in black, similar to humans. These figures were often seen on the outskirts of a town or village, and their presence would signal the imminent outbreak of an epidemic.

These ancient incidents raise intriguing questions: Who were the mysterious figures? What were the long, scythe-like instruments they carried, which emitted a loud, crackling sound?

It seems the “scythes” might have been long instruments designed to spray poison or germ-laden gases. This would mean that the villagers misinterpreted the movement of the “*scythes*” as cutting oats when, in fact, the movements were meant to spray aerosols on the land, crops, or even in the village itself. Strange men dressed in black, “*demons*,” and other terrifying figures were observed in other European communities. The terrifying creatures were often seen carrying long “*brooms*,” “*scythes*,” and “luminous swords” which were used to “*sweep*” or “*knock*” on the doors of the village houses. Similar black men were described in Hungary.

The inhabitants of those houses fell ill shortly afterward with the plague. It is from these accounts that people created the popular image of “Death” as a skeleton or demon carrying a scythe.

The scythe came to symbolize the act of Death felling people like stalks of crops. Seeing this persistent image of death, we may, in fact, be in the presence and manifestation of a flying object or UFO.



Of all the phenomena connected with the Black Death, the most frequently reported were the strange and noxious “drizzles.”

The vapors were often seen even when the other phenomena were not. Mr. Nohl notes that this damp fog was “*a feature that preceded the epidemic throughout its entire course.*” Many doctors of that time took it as a fact that the plagues were caused by the strange drizzles. Reports of deadly and pestilential “*drizzles*” and fogs came from all parts of the plague-stricken world. A chronicle from Prague describes the epidemic in China, India, and Persia; and the Florentine historian Matteo Villani, who inherited the work of his brother Giovanni after he died of the plague in Florence, relayed an account of earthquakes and pestilential fogs from a traveler in Asia. The same historian continues:

“ people believed they could fall ill after inhaling or being near the night mist...”

As mentioned earlier, the deadly “drizzles” were directly associated with bright lights in the sky. Other sources for the odors are also indicated. During a plague in ancient Rome, the famous physician Hippocrates (460-337 BC) declared that the disease was caused by bodily disturbances brought about by changes in the atmosphere. To remedy this, Hippocrates had people build large public bonfires. This ancient physician believed that the bonfires would sterilize the air.

Hippocrates' advice, however, was followed centuries later by physicians during the medieval plague. Modern physicians have a dark view of Hippocrates' advice on this matter, believing that Hippocrates was ignorant about the true causes of the Black Death. In reality, large open-air bonfires were the only conceivable defense against this plague. If it was indeed caused by chemical-saturated aerosols, the only hope was to burn the deadly mists or fogs with fire.

Hippocrates and those who followed his advice may indeed have saved some lives. Significantly, bubonic and pneumonic plagues and epidemics were not the only deadly diseases in history to be spread by means of strange and deadly mists. The deadly intestinal disease, cholera, was another: When cholera broke out aboard Her Majesty's ship, the *Britannia*, in the Black Sea in 1854, several officials and men positively stated that, *“immediately before the outbreak, a curious, dark mist rose from the sea and passed over the ship. The mist had scarcely cleared from the vessel when the first case of the disease was announced. Those who drank the toxic water either died or fell ill.”*

Such blue mists were also associated with the cholera outbreaks of 1832 and 1848-1849 in England. As mentioned earlier, these plagues had a very strong religious significance. In the Bible, plagues were said to be Jehovah's method of punishing people for their bad behavior towards God.

The religious aspect of the medieval Black Death is reinforced by accounts of thunderous sounds associated with outbreaks of this epidemic. The sounds were similar to those described in the Bible, which accompanied the appearance of Jehovah, the vengeful and psychopathic god of the Old Testament. Interestingly, these sounds are also common in some UFO sightings.

The quotes and accounts we have presented hereby provide evidence that UFOs, or some advanced civilization coexisting with us, or an elite with extraordinary technology, have been infecting humanity with deadly diseases since ancient times. This evidence is particularly intriguing when we consider the demands made by several modern UFO contactees, who claim to be revealing messages from extraterrestrials directly to humanity in these times. Some of them say that UFOs are here to help humanity and that they will eradicate diseases on Earth. This UFO civilization, according to these accounts, has no diseases.

In the past, people were convinced that epidemics were God's punishment for sin, and this caused profound introversion. It was natural for people to accuse themselves and their neighbors of wickedness and to wonder what they had done to “deserve” their punishment. It rarely occurred to the victims that plagues, even when deliberately inflicted, had nothing to do with trying to make human beings more virtuous. After all, the social and psychological effects of these epidemics produced just the opposite result.



The misery and despair generated by the high price to pay for death brought with it a widespread ethical decline. In a dying environment, many people didn't care whether their actions were good or bad; since they were going to die anyway. In this climate of fear of medieval plagues, spiritual values were rejected and mental aberration increased. The same results are observed during periods of war. Although the Bible and other religious works may preach that plagues and wars are created by “*God*” to ultimately make the human race more virtuous and spiritually advanced, the effect, psychologically speaking, is quite the opposite.

Almost everyone from an early age believes or takes for granted that there are microorganisms that fly through the air and are everywhere like an inert gas attacking and infecting people incessantly and making them sick from birth until they die. Nevertheless, nothing could be further from the truth. This has been called a virus. And the theory goes that just like our immune system they work as a military complex fighting each other and they are faced with nature in a non-symbiotic warlike way. This has also never been proven to be the case. However, people believe it outright.

This is called the germ theory, which emerged no later than the last century, although the concept of contagion can be traced back to the Greeks and their demons that possess people and infect them. As we will see later, all this is a religion that serves a few businesses and makes the rest sick and fearful.

This paradigm of infection or contagion is due in large part to the fact that from approximately the 16th century, in the course of the Enlightenment, the natural sciences began to develop rapidly, putting the population under their spell with descriptions of very specific phenomena. It is enough to recall the tremendous achievements of the English physicist Isaac Newton, who described gravitation; or the invention of the steam locomotive or even the printing press.



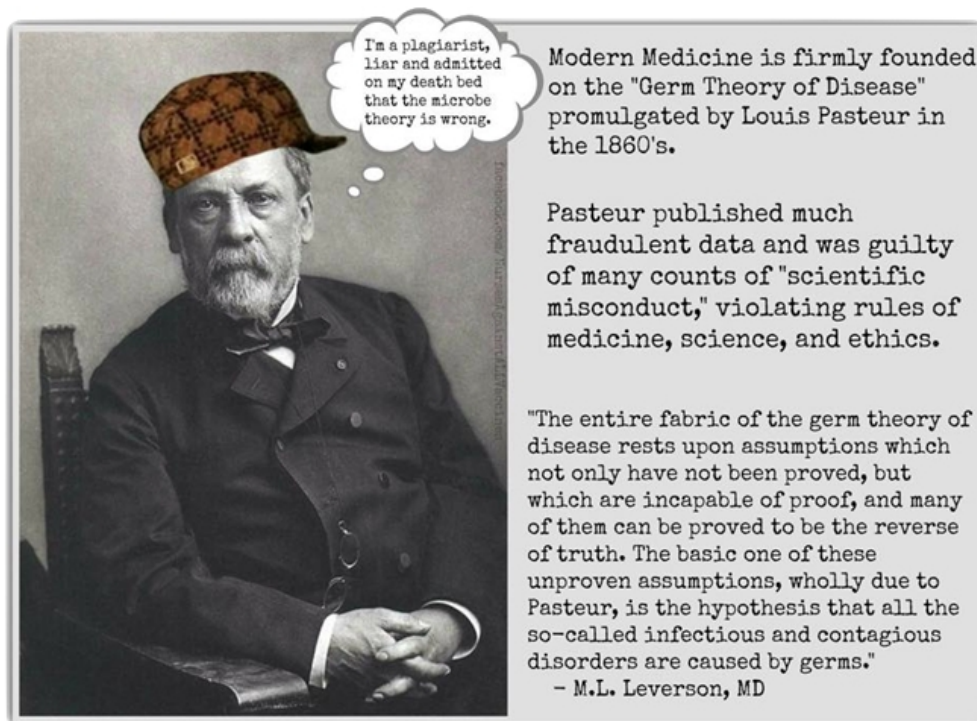
But in the exuberant euphoria of progress, particularly since the mid-nineteenth century, this specificity thinking pattern that very particular chemical or physical phenomena have very specific causes has simply been transferred to the medical sciences.

Many researchers and interest groups did not even consider whether this really made sense. The single-cause dogma of disease was decisively shaped by microbiology, which became predominant at the end of the 19th

century, declaring specific microorganisms (viruses, bacteria, fungi) as causing very definite diseases; including massive epidemics such as cholera and tuberculosis.

The founders of the germ theory, the criminal pseudo researchers Louis Pasteur and Robert Koch, were throughout their lives elevated to the Mount Olympus of medicine. And so, with microbial theory, they built the foundations of the basic formula of modern biomedicine with its monocausal-microbial starting point and its search for magic solutions: a disease, a cause, a cure, says American sociology professor Steven Epstein.

So, all in all, its all a bunch of BS, yes bull shit, we know that viruses, bacteria, contagion and the like do not exist.
